RACE 1: RURAL CITY MURRAY BRIDGE - LETS THRIVE MOORUNDI CLASSIC - 900 Metres

CASBOURG (D. Caboche) - dipped shortly after the start. Laid out under pressure in the straight.

AVANZO (K. Crowther) - near the 400m was disappointed when attempting a tight run to the inside of CASBOURG and altered course to its outside to obtain clear ground.

REALITY MISS (H. Grace) - jumped away awkwardly. Inclined to lay in under pressure in the straight.

RACE 2: BRIDGE CARPET COURT ANDREW MILLS 1000 GUINEAS - 1000 Metres

HARLEY'N'ROSE (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

GEEIJO (J. Toeroek) - slow to begin. Raced keenly in the early and middle stages of the event.



RACE 2: BRIDGE CARPET COURT ANDREW MILLS 1000 GUINEAS - 1000 Metres (cont'd)

DODD (K. Crowther) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

GIVE SOME LIP (B. Price) - raced keenly in the early and middle stages of the event.

HOLPIN (D.Caboche) - rider was reminded of his obligations under AR131(b) to ride his mounts out to the finish of the race.

RACE 3: SPRING RACING CARNIVAL AT MORPHETTVILLE - (OCT. 14TH - NOV 11TH)
HANDICAP - 1000 Metres

SECOND TO NUN (T. Pannell) - slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m when he was able to ease to the outside of other runners.

LADY HOUDINI (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

AZTEC DANCER (J. Opperman) - jumped away awkwardly and was slow into stride. Held up for a short distance near the 400m when awkwardly placed on the heels of SUGGESTIVE MISS, which laid out, and was obliged to alter course to that mare's inside to obtain clear ground.

FOXY FEMME (D. Tourneur) - jumped away awkwardly and was slow into stride.

SUGGESTIVE MISS (A. Livesey) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

FIELDS OF ATHENRY (H. Edgley) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

EVERLY (B. Price) - rider reported that the filly raced flat in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: NORTHPOINT MURRAYLANDS HANDICAP - 1800 Metres

ALLUSION (J. Holder) - rider reported that the gelding raced flat in today's event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Ms C. Rose, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

EXOPIPI (D. Tourneur) - had to be momentarily steadied and alter course at the entrance to the straight when MOSTLY SUNNY shifted out.

SEAFARING (NZ) (M. Collett) - raced keenly in the early and middle stages of the event. At the entrance to the straight shifted out slightly onto BENZ BARON. Rider was advised to make a greater effort to keep her mounts straight in future. Laid out under pressure in the straight.

MOSTLY SUNNY (F. Atkinson) - a post-race veterinary examination revealed the mare to have bled from both nostrils. Trainer, Mr D. Caboche, was advised that as this was the mare's first bilateral bleed MOSTLY SUNNY would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

AMERICAN TROUBLE (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

BENZ BARON (E. Finnegan) - Stewards permitted E. Finnegan to ride the gelding 0.5kg over its allocated weight of 54.0kg. At the entrance to the straight commenced to shift out and then shortly after was taken out wider into the running line of MULOFDUBAI by SEAFARING (NZ). Had difficulty obtaining clear ground from approaching the 400m until inside the 300m when awkwardly placed on the heels of SEAFARING (NZ), which continued to lay out.





RACE 4: NORTHPOINT MURRAYLANDS HANDICAP - 1800 Metres (cont'd)

APPLIED (T. Voorham) – slow to begin. Held up from the entrance to the straight until approaching the 200m.

JAYWICK (J. Potter) – when questioned regarding the improved performance of the gelding trainer, Mr B. Potter, explained that he did not consider today's performance to be significantly better than its previous run. He stated at its last start the gelding was slow to begin and lost considerable ground at the start, then had become held up in the early stages of the straight before finishing strongly to only finish 4.6 lengths from the winner. He added that the horse had continued to work well since that run and he felt that it was a strong change in today's event and had moderately supported JAYWICK.

MULOFDUBAI (S. Logan) – at the entrance to the straight had to be steadied when BENZ BARON was taken out into its running line.

RACE 5: THOMAS FARMS HANDICAP - 2000 Metres

SILENT COMMAND (A. Livesey) – a post-race veterinary examination revealed the gelding to be lame in the near fore (2/5). Trainer, Ms A. Brook, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

THE MAP (L. Neindorf) – had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m. Rider reported that the mare raced flat in today's event.

OATH OF OMERTA (T. Pannell) – rider reported that the gelding raced keenly in the early and middle stages of the event and then commenced to hang out in the straight and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

HOOPS (NZ) (K. Crowther) – inconvenienced near the 150m when VINO DECASA NOSTRA (NZ) shifted in.

SIX FOOT SONG (S. Logan) – slow to begin. Hung out over the concluding 1000m and proved extremely difficult to ride. Rider reported that the gelding hung out throughout the event. A post-race veterinary examination revealed a slower than expected recovery. Trainer, Mr J. Macmillan, was advised that the gelding would now be required to race tractably in an Official Barrier Trial prior to a future race start.

VINO DECASA NOSTRA (NZ) (H. Grace) – slow to begin. Laid in under pressure in the straight and near the 150m shifted in and inconvenienced HOOPS (NZ).

RACE 6: SPRY CIVIL CONSTRUCTION HANDICAP - 1000 Metres

HONGBAO (H. Edgley) – slow to begin. Held up from the entrance to the straight until the finish of the event and was untested.

THE GOV (S. Cahill) – Stewards permitted jockey S. Cahill to replace apprentice K. Hannan as there was no other apprentice available. A post-race veterinary examination revealed no visible abnormalities.

ALPHA FLIGHT (J. Toeroek) – inclined to shift about in the early and middle stages of the event, and near the 700m rolled in onto DARING MOVE.

DARING MOVE (A. Livesey) – near the 700m rider had to take hold momentarily when awkwardly placed on the heels of ALPHA FLIGHT, which rolled in slightly. Held up from the entrance to the straight until inside the 200m when able to ease to the outside of other runners.

BROADWAY LANE (F. Atkinson) – near the 700m shifted out slightly into the running line of OLD TIME ROCK. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 100m when it shifted to the outside of LONRODEX and in doing so hampered THEY CALL ME ALVIN. Rider was severely reprimanded and advised in future to ensure she was sufficiently clear prior to shifting ground.

OLD TIME ROCK (B. Price) – near the 700m had to be steadied when BROADWAY LANE shifted out into its running line. Held up from the entrance to the straight until inside the 200m.



RACE 6: SPRY CIVIL CONSTRUCTION HANDICAP - 1000 Metres (cont'd)

ZUFASTA (L. Neindorf) - laid in under pressure in the straight. Rider reported that the gelding did not let down as he had expected in the straight.

RACE 7: BGC INDUSTRIAL CLEANING SUPPLIES HANDICAP - 1000 Metres

THE GUAVA (S. Cahill) - raced wide without cove throughout the event.

TEST THE LAW (R. Hurdle) - held up from the entrance to the straight until near the 200m. A post-race veterinary examination revealed no visible abnormalities.

BRAVEMAN'SGAME (NZ) (T. Pannell) - hung in, in the straight and proved difficult to ride. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

ICE SYMPHONY (J. Toeroek) - raced keenly in the early and middle stages of the event. Rider reported that the gelding failed to let down when placed under pressure and was disappointing to the finish.

MIDNIGHT MASS (NZ) (J. Opperman) - held up from the entrance to the straight until near the 300m.

PLATINUM WOLF (L. Neindorf) - held up from the entrance to the straight until near the 300m.

SAVILLE (A. Livesey) - jumped away extremely awkwardly and was slow into stride.

COOL MAGNUM (S. Tomlinson) - a post-race veterinary examination revealed no visible abnormalities.

CHIPSON (D. Tourneur) - held up from the entrance to the straight until near the 200m.

LI'L HANK (S. Payne) - raced wide without cover throughout the event.

PIVOTAL FORCE (J. Potter) - laid in under pressure in the straight.

RACE 8: BURKE URBAN REG NOLAN FLYING HANDICAP - 1200 Metres

The start of this event was delayed approximately three minutes.


SASKATOON (J. Toeroek) - near the 250m was hampered and lost its position when taken in onto BELLINGER, which had commenced to shift out, by SHOVE OVER, which shifted in.

BELLINGER (T. Pannell) - near the 250m shifted out slightly contacting SASKATOON, which had been taken in. Laid out over the concluding 150m of the event.

NEODIUM (E. Finnegan) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SHOVE OVER (A. Kelly) - near the 250m shifted in onto SASKATOON, which was taken in onto BELLINGER, which had commenced to shift out. Rider was reprimanded.

RICH GINA (D. Tourneur) - raced keenly in the early and middle stages of the event. Laid out over the concluding 100m. When questioned in relation to the instructions he was provided in today's event rider explained that he was instructed to have the mare settle where comfortable; however, they anticipated that RICH GINA would settle behind the leader or a further pair back. He added that after jumping away the mare grabbed the bit, raced keenly and took up the lead of its own accord. Co-trainer, Mr P. Blanch, confirmed that the instructions were not to lead the event.



BUBBLE OVER (A. Livesey) - raced keenly in the early and middle stages of the event. In the vicinity of the 200m shifted out abruptly and then laid out under pressure for the remainder of the event.



RACE 9: CARLTON DRAUGHT MURRAY BRIDGE GOLD CUP - 1600 Metres

LORD VLADIVOSTOK (NZ) (T. Pannell) - near the 1000m rider had to ease his mount and relinquish his position when REGALO DI GAETANO shifted in.

REGALO DI GAETANO (C. Murray) - near the 1000m shifted in to the running line of LORD VLADIVOSTOK (NZ), forcing that rider to ease his mount and relinquish his position. Rider was advised that although the consequences were not significant the standard of riding was below what is expected.

CLEVER MAN (H. Grace) - laid in under pressure in the straight.

LYRICAL LAD (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 1.0kg over its allocated weight of 54.0kg.

WILD CHAP (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

CHICAGO STORM (J. Holder) - Stewards permitted J. Holder to ride the gelding 0.5kg over its allocated weight of 54.0kg. Inclined to lay out under pressure in the straight.

SEBONNA (S. Metcalfe) - slow to begin. Held up from the 500m until the 200m.

PUDDING (NZ) (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 1.0kg over its allocated weight of 54.0kg. Held up from the 500m until the 300m.

EN FRANCAIS (L. Neindorf) - Stewards permitted L. Neindorf to ride the mare 0.5kg over its allocated weight of 54.0kg.

JACK THE LAD (J. Potter) - raced keenly in the early and middle stages of the event.

RACE 10: BEYOND INK HANDICAP - 1400 Metres

BRAVE STAR (NZ) (H. Edgley) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

TEXAN WINDSTORM (A. Livesey) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr J. Macmillan, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

AIGUILLETTE (J. Holder) - held up from the entrance to the straight until near the 200m. Lost its near fore plate during the event.

ANNIHILATE (T. Voorham) - jumped away awkwardly. Laid in under pressure in the straight.

KATIM'S CLUB (C. Murray) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

PEACEMAKER (F. Atkinson) - raced keenly in the early and middle stages of the event.

WHISKEY 'N' WOMEN (P. Gatt) - raced keenly in the early and middle stages of the event.

WINE BARRON (NZ) (T. Pannell) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. Rider reported that the gelding raced fiercely in the early and middle stages, which proved detrimental to its finishing effort. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RABTAT (B. Price) - rider reported that the gelding was disappointing. A post-race veterinary examination revealed no visible abnormalities.
