RACE 1: ADELAIDE GALVANISING INDUSTRIES MAIDEN PLATE - 1200 Metres

CHEF MILITAIRE (S. Tomlinson) - rider was unable to claim his full allowance in this event and was fined \$200 under AR143(13). Jumped away awkwardly and was slow to begin.

UNDERCOVER AGENT (D. Tourneur) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

EPISODIC (NZ) (B. Price) - near the 500m shifted out and took VALIEVA wider on the track.

PULAMBI (T. Childs) - lost its near hind plate during the event. Jumped away awkwardly. Near the 100m had to be steadied and alter course to the outside of SET ON YOU, which laid in.

VALIEVA (L. Lafferty) - inconvenienced near the 500m when taken wider on the track by EPISODIC (NZ). Laid out under pressure in the straight.

IVE GOT YOUR BACK (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

SET ON YOU (J. Holder) - laid in under pressure in the straight and proved difficult to ride.



RACE 2: THOMAS FARMS HANDICAP - 1200 Metres

DUBENENKO (S. Tomlinson) - lost its off fore plate during the event. Rider reported that his saddled shifted back on jumping away placing him at a slight disadvantage throughout the event.

HUGGLE TIME (J. Holder) - jumped away awkwardly, shifted out and contacted FUN FOREVER. Rider reported that the gelding travelled well in the early and middle stages; however, when asked for an effort was disappointing. A post-race veterinary examination revealed no visible abnormalities.

FUN FOREVER (T. Pannell) - inconvenienced on jumping away when contacted by HUGGLE TIME. Near the 1100m had to be steadied and lost its position when tightened between HUGGLE TIME, which shifted out slightly and BONA FIDE STAR, which was taken in slightly by ANOTHERHOUSE (NZ). Near the 300m was disappointed for a run to the inside of HUGGLE TIME, which rolled in and was obliged to alter course to obtain clear ground. Rider reported that the gelding raced greenly and hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ZESTY SPICE (B. Price) - slow to begin and shortly after was inconvenienced when THE STALKER shifted out.

THE STALKER (D. Tourneur) - lost its near hind plate during the event. Shifted out shortly after the start onto ZESTY SPICE.

RACE 3: FLEURIEU MILK COMPANY HANDICAP - 1050 Metres

KEEP READING (S. Tomlinson) - jumped away awkwardly.

OCEAN REWARD (T. Pannell) - inclined to lay in under pressure in the straight.

QUEMAN (J. Potter) - rider was reminded of his obligations under AR132(6)(b) in relation to the use of his whip in an action that raises his arm above shoulder height.

MAGNETIC (B. Price) - rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure did not respond to his riding and felt uncomfortable in its action. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Co-trainers, Mr L. and Mr T. Corstens were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 4: QUAYCLEAN HANDICAP - 1600 Metres

ARUGAMAMA (J. Holder) - raced keenly in the middle stages of the event.

CROWN HARMONIUM (S. Clarke) - raced wide without cover throughout the event.

MONSEAGLE (L. Lafferty) - jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

RACE 5: THE FOTOBASE GROUP HANDICAP - 1200 Metres

The start of this event was delayed three minutes to avoid a clash with an interstate event.

ORNAMENTAL LADY (C. Murray) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by C. Murray and noted that he used it on ten occasions over the final 100m of the event.

BASE OF FIRE (J. Opperman) - jumped away awkwardly, shifted in and inconvenienced VALLEY RATTLER. A post-race veterinary examination revealed no visible abnormalities.

LUCKY BLUE (J. Potter) - raced keenly in the early and middle stages of the event.

MR WHITACRE (S. Logan) - raced keenly in the early and middle stages of the event.

VALLEY RATTLER (S. Metcalfe) - inconvenienced on jumping away.



RACE 6: HILL SMITH STAKES - 1800 Metres

The start of this event was delayed three minutes to avoid a clash with an interstate event.

RUMINATE (B. Price) - rider reported that the gelding travelled well in the early and middle stages; however, when placed under pressure commenced to lay in and he had become concerned with its action over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr M. Cumani was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

THORNY PATH (C. Murray) - Change of tactics - attempt to settle further forward in the event if possible. Settled back of midfield. Near the 500m was held up for a number of strides when awkwardly placed on the inside of THINK TANK. Rider reported that after jumping away slowly he was unable to push forward to comply with the instructions due to the formation of the field. He added that THORNY PATCH laid in when placed under pressure in the straight.

THINK TANK (J. Opperman) - slow to begin.

MERCURY FLYER (L. Neindorf) - raced fiercely in the early and middle stages of the event. Near the 1200m shifted out to a three wide position to allow the gelding to stride forward. Rider reported that after improving into a three wide position near the 1000m, the gelding was inclined to lay in on top of other runners. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: GUINNESS HANDICAP - 1200 Metres

KATIM'S CLUB (T. Pannell) - raced wide without cover throughout the event. Laid out under pressure in the straight. Approaching the finish shifted out onto BELLALIQUE. Rider was reprimanded under AR131(a) and advised to take greater care when shifting ground in future.

MISS KERMIE (S. Clarke) - jumped away awkwardly. Held up from the 400m until near the 150m.

MISS REMSKI (C. Murray) - raced keenly in the early and middle stages of the event.

OUR SHINING STAR (J. Toeroek) - rider reported that the mare had never travelled during the event and when asked for an effort failed to let down as he had anticipated and was disappointing to the finish. A post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Co-trainers, Mr R & Ms C. Jolly were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

PRICILLA'S CHOICE (T. Childs) - a post-race veterinary examination revealed no visible abnormalities.


BELLALIQUE (B. Price) - approaching the finish had to be steadied when MISS REMSKI shifted out.

EXALTED DAME (L. Lafferty) - held up from the 400m until approaching the 100m.

ALOTAFUN (D. Tourneur) - jumped away awkwardly and was slow to begin.

PICKY (L. Neindorf) - Change of tactics - attempt to settle further back in the event if possible. Settled outside the leader. Rider reported that it was his intention to restrain at the start to comply with the instructions he had been provided; however, the filly commenced to over race shortly after jumping away and he was unable to settle it. He added that he then permitted PICKY to stride forward to settle outside the leader rather than continue to fight it.

RACE 8: SKYCITY HANDICAP - 2500 Metres



LOOK SHARPISH (NZ) (T. Pannell) - rider reported that the mare raced flat and did not respond to his riding when asked for an effort inside the 600m. A post-race veterinary examination revealed no visible abnormalities.

FOOTLIGHTS (NZ) (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.



RACE 8: SKYCITY HANDICAP - 2500 Metres (cont'd)

BELMONT AVENUE (IRE) (D. Tourneur) - jumped away awkwardly.

RADEGAST (NZ) (F. Atkinson) - jumped away awkwardly.

SHADOW HAWK (NZ) (S. Clarke) - raced wide without cover throughout the event.

AMERICAN TROUBLE (T. Childs) - jumped away awkwardly.

RACE 9: JAMESON'S IRISH WHISKEY HANDICAP - 1500 Metres

EXCELMAN (NZ) (S. Clarke) - slow to begin. Laid in under pressure in the straight.

DARLAMAX (C. Murray) - inside the 200m became held up and disappointed when attempting a run between PEACEMAKER and ANGASTON and was unable to obtain clear ground until near the 50m.

AITCH D'AMICO (T. Pannell) - raced keenly in the early and middle stages of the event.

ALPINE FLYER (B. Price) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

SET TO PROPHET (R. Hurdle) - had his whip accidentally struck from his hand by T. Pannell in the vicinity of the 50m.

TAPINFORPAR (L. Neindorf) - laid in under pressure in the straight.

ANGASTON (L. Lafferty) - a post-race veterinary examination revealed the gelding to have cardiac arrhythmia (1st occurrence). First aid administered. Trainer Mr J. O'Connor was advised that he was required to comply with the Racing Australia Code of Practice in order for the gelding to be reinstated to race.

PEACEMAKER (F. Atkinson) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

RACE 10: GRAND SYNDICATES HANDICAP - 1100 Metres

HELLO LADIES (H. Edgley) - raced keenly in the early and middle stages whilst being restrained.

JAAZEB (L. Lafferty) - jumped away awkwardly and shifted in onto NOSTRYIA. Inclined to lay in under pressure in the straight.

OUTPOST (J. Opperman) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

NOSTRYIA (T. Pannell) - contacted on jumping away. Rider reported that his saddle shifted back on jumping away placing him at a disadvantage throughout the event and was unable to be tested in the straight. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr K. Sweeney was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

ZARACE (T. Childs) - laid out under pressure in the straight.

BRAZANO (J. Potter) - approaching the 100m raced in restricted room for a number of strides when awkwardly placed between TRYGVE and KONG, which both shifted ground slightly.

KING MOYA (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

FOSTER STREET (J. Holder) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

WAKANJEJA (K. Crowther) - jumped away awkwardly and was slow to begin.



RACE 10: GRAND SYNDICATES HANDICAP - 1100 Metres (cont'd)

SPORTS CHOICE (B. Price) - laid out rounding the home turn.

Correct weight was delayed to allow Co-trainers, Mr G. Richards and Mr D. Moyle of JAZZEB, placed fifth, an opportunity to view the vision in the straight.
