Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 21 October 2023

RACE 1: TRIPLE M HANDICAP - 2006 Metres

LORD GOLDBERG (J. Opperman) - inconvenienced on jumping away when contacted by AMERICAN TROUBLE. Laid in under pressure in the straight.

EXOPIPI (K. Crowther) – inconvenienced shortly after the start when LORD GOLDBERG was taken out into its running line. Had difficulty obtaining clear ground from the entrance to the straight until near the 300m when it shifted to the inside of SEAFARING (NZ). In doing so shifted in onto WARRANDYTE ROAD, which was hampered. Rider was reminded of her obligations when shifting ground.

SEAFARING (NZ) (M. Collett) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn.

CHARTIN (NZ) (D. Tourneur) - shifted out on jumping away onto AMERICAN TROUBLE. Raced keenly in the early and middle stages of the event when being restrained to allow SEAFARING (NZ) to cross.

LETTEMGO (S. Logan) - slow to begin.

AMERICAN TROUBLE (W. Price) - inconvenienced on jumping away when tightened onto LORD GOLDBERG by CHARTIN (NZ). A post-race veterinary examination revealed no visible abnormalities.

WARRANDYTE ROAD (J. Potter) - slow to begin. Near the 300m was hampered when EXOPIPI shifted in.

RACE 2: CROSER HANDICAP - 1100 Metres

SIX STARS (T. Pannell) - jumped away awkwardly and shortly after was hampered when tightened onto DEEPFLOAT DIVA by KRISTOBEL. Raced keenly in the early and middle stages of the event.

KRISTOBEL (J. Holder) - shifted in on jumping away onto SIX STARS. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: DRINK WISE HANDICAP - 1800 Metres

CLEVER MAN (H. Edgley) – rider explained that she had been instructed to obtain a position midfield with cover; however, after jumping away extremely well the gelding improved of its own accord and obtained the lead. She added that CLEVER MAN travelled well in the early and middle stages of the event; however, did not finish the event off as she had anticipated. Trainer, Mr T. White, confirmed that the instructions were to attempt to settle midfield with cover. A post-race veterinary examination revealed no visible abnormalities.

MONTEPULCIANO (K. Crowther) - slow to begin.

EXCELMAN (NZ) (D. Tourneur) - laid in under pressure in the straight.

EUREKA'S VICTORY (J. Potter) - rider was reminded of his obligations under AR131(b) to ride his mounts out to the finish of the event.

MARYMOUNT LASS (S. Logan) - laid in under pressure in the straight.

RACE 4: DOMINANT HANDICAP - 2006 Metres

ICHIBANSAN (J. Holder) – laid out under pressure in the straight. Rider reported that his mount raced flat in today's event. A post-race veterinary examination revealed no visible abnormalities.

VINO DECASA NOSTRA (NZ) (S. Logan) – jumped away awkwardly and was slow into stride. Rider reported that her mount raced flat in today's event.

SIX FOOT SONG (W. Price) - stood flat-footed and was slow to begin. Trainer, Mr J. Macmillan, was advised that a warning had been placed on the gelding.

JAYWICK (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: ACCESS HARDWARE HANDICAP - 1100 Metres

STRUCK BY (T. Pannell) - jumped away awkwardly, shifted out and bumped ANILLA.

RIVER TWAIN (B. Price) - rider reported that in his opinion the gelding may have choked down. a post-race veterinary examination revealed a slower than expected recovery.

KARACASU (J. Toeroek) - raced keenly in the middle stages whilst being restrained.

ANILLA (J. Holder) - hampered when contacted on jumping away. Held up from near the 400m until approaching the 200m when it was able to alter course to obtain clear ground.

BUBBLE OVER (W. Price) - a post-race veterinary examination revealed no visible abnormalities.

RICH GINA (D. Tourneur) - jumped away awkwardly and was slow into stride, and shortly after was inconvenienced when ANILLA rolled out into its running line.

OUTPOST (A. Livesey) - raced wide without cover throughout the event.

RACE 6: PFD FOOD SERVICES HANDICAP - 1600 Metres

YURI ROYALE (S. Tomlinson) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 100m.





DR DEE DEE (B. Price) - slow to begin.

YABADABADOO (NZ) (A. Livesey) - raced wide without cover throughout the event.

CROWN MINT (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SIR KINGSFORD (K. Crowther) - raced keenly in the early and middle stages of the event. Held up from near the 400m until approaching the 200m.

CALIBURN (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

BRAZEN EAGLE (J. Maund) - raced keenly in the early and middle stages of the event. Rider reported that in his opinion the mare may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms K. Letts-Maund, advised that the mare will now be spelled.

RACE 7: TWILIGHT RACES AT MORPHETTVILLE DECEMBER 15TH HANDICAP - 1200 Metres

CARBONE (A. Livesey) - had difficulty obtaining clear ground from the 400m until near the 200m.

ANJOPIN (H. Edgley) - shifted in on jumping away and contacted MR MARATHON MAN (GB). Raced keenly in the early and middle stages of the event.

DEEVINE (D. Tourneur) - laid in under pressure in the straight.

SABERMETRIC (J. Toeroek) - raced keenly in the early and middle stages of the event.

BULLS ON PARADE (T. Pannell) - contacted on jumping away. Near the 50m rider was forced to take hold of his mount to avoid the heels of DAWNBURST, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

MISS REMSKI (C. Murray) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

TOSEN WATER (J. Opperman) - raced wide without cover throughout the event. Laid in under pressure in the straight.

COMMANDER MEROO (W. Price) - shifted in on jumping away and contacted BULLS ON PARADE. A post-race veterinary examination revealed no visible abnormalities.

DAWNBURST (S. Payne) – near the 50m shifted in onto BULLS ON PARADE, forcing that rider to take hold of his mount to avoid the heels of DAWNBURST. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight Friday, 27 October 2023 to conclude midnight Wednesday, 1 November 2023, a period of three meetings.

MR MARATHON MAN (GB) (B. Price) - contacted on jumping away. Raced keenly in the early and middle stages of the event. Held up over the concluding 200m and was untested to the line.

RACE 8: THE JUNCTION HANDICAP - 1600 Metres

ANDREW'S MEMORY (J. Maund) - raced keenly in the early and middle stages of the event. Rider reported that it was not his intention to lead the event; however, due to the slow tempo the gelding pulled itself to the lead of its own accord.

RUE BUNGAN (H. Edgley) - slow to begin.

DAZZLING PROSPECT (D. Tourneur) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SUPERIOR SAM (NZ) (T. Pannell) - raced keenly in the early and middle stages of the event.

RACE 8: THE JUNCTION HANDICAP - 1600 Metres (cont'd)

VEE ROD (NZ) (W. Price) - slow to begin. Raced keenly in the early and middle stages of the event.

DUAL FUEL (NZ) (J. Holder) - became held up at the entrance to the straight until approaching the 100m.

CURRENCY KAMAR (S. Metcalfe) - raced keenly in the early and middle stages of the event.

INDY MAGIC (D. Caboche) - Stewards permitted D. Caboche to ride the gelding 0.5kg over its allocated weight of 54.0kg. Near the 1200m became awkwardly placed on the heels of FRUSCIANTE for a number of strides when the pace eased.

RACE 9: TAB HANDICAP - 1050 Metres

MISS MUCINNI (H. Edgley) - raced keenly in the early stages of the event, and approaching the 800m got its head up and commenced to race fiercely and shifted out making contact with SPORTS CHOICE on a number of occasions when crossed by MAGIC DELTA.

FOXY FEMME (D. Tourneur) – slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m. Near the 200m was inconvenienced when taken in by MAGIC DELTA, and shortly after shifted out abruptly. A post-race veterinary examination revealed the mare to have bled from both nostrils. Co-trainers, Mr P. & Mrs B. Blanch, were advised that as this was the mare's first bi-lateral bleed FOXY FEMME would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

LADY SIMONE (S. Tomlinson) – near the 800m shifted in onto SPORTS CHOICE, which was forced to race in restricted room when taken in onto MISS MUCINNI. Rider was severely reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

SPORTS CHOICE (B. Price) – near the 800m was forced to race in restricted room for a number of strides when awkwardly placed between MISS MUCINNI, which shifted out at the same time as LADY SIMONE commenced to shift in.

STARTIDE (K. Crowther) - jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed no visible abnormalities.

MAGIC DELTA (S. Metcalfe) - inclined to shift about under pressure in the straight. Approaching the 800m shifted in onto MISS MUCINNI when not fully clear, resulting in MISS MUCINNI having to be steadied and in doing so got its head up and raced keenly for a number of strides. Rider was severely reprimanded.

SAMESYN (J. Maund) - inside the 800m was forced to race in restricted room to the inside of MISS MUCINNI, which had been taken in.

AVIATRESS (J. Toeroek) - jumped away awkwardly.

Correct weight for this event was delayed to allow B. Price (SPORTS CHOICE), placed fourth, and that mare's trainer, Mr A. Homann, to view the official footage near the 800m.

RACE 10: GRAND SYNDICATES HANDICAP - 1050 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

LONRODEX (R. Hurdle) - rider reported that the gelding raced flat, and in his opinion may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

SGHIRRIPA (K. Crowther) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

RACE 10: GRAND SYNDICATES HANDICAP - 1050 Metres (cont'd)

CLASSY KENNY (S. Tomlinson) - jumped away awkwardly and was slow into stride. Near the 500m improved onto and became awkwardly placed on the heels of MOUSE ALMIGHTY for a number of strides.

WHO SHOT SUZY (W. Price) - laid out under pressure in the straight.

VIDUKA (T. Pannell) - laid in under pressure in the straight.

ZARACE (A. Livesey) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

OLD TIME ROCK (B. Price) - jumped away awkwardly. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.
