RACE 1: GREAT NORTHERN HOTEL BENCHMARK 72 HANDICAP - 1210 Metres

SEEKING GLORY (R. Hurdle) - jumped away awkwardly. Laid in over the concluding stages of the event.

TRYGVE (T. Voorham) - rider explained that the gelding never travelled in today's event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

STRAWBERRY SWING (R. Milnes) - Stewards questioned the rider in relation to the tactics adopted in today's event, in particular her decision not to move to the inside rail near the 800m when the opportunity presented itself. Rider explained that she had no firm instructions in today's event and she felt that the mare would be better suited by maintaining its position once she had obtained a position in the lead due to STRAWBERRY SWING having a tendency to lay in. She added that the mare travelled well and finished the event off strongly.

RACE 2: HOTEL BOSTON MAIDEN PLATE - 1210 Metres

AIRFORCE (S. Tomlinson) - shortly after jumping away had to be steadied to avoid the heels of BATTLE ROYALE, which was taken out by FRESH AIR FRED. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: HOTEL BOSTON MAIDEN PLATE - 1210 Metres (cont'd)

BATTLE ROYALE (J. Opperman) - shortly after jumping away was hampered when FRESH AIR FRED shifted out. Shifted out abruptly over the concluding stages into the running line of ROLLING DUCK, resulting in the rider having to stop riding and straighten his mount.

FRESH AIR FRED (B. Wong) - hung out throughout the event. A post-race veterinary examination revealed a minor laceration to the near fore heel.

DOORBEL (A. Livesey) - raced fiercely in the early and middle stages of the event. Rider explained that her instructions were to be positive in the early stages; however, with the addition of blinkers the mare commenced to race keenly and obtained the lead of its own accord.

EQUINE HEADLINE (NZ) (R. Milnes) - jumped away awkwardly and shifted out.

GALLANTRY GIRL (K. Crowther) - jumped away awkwardly, shifted in and bumped THAT'S SETTLED.

NOORTOOMANY (C. Tootell) - raced greenly in the straight and near the 200m shifted out abruptly onto MIS GUIDED CHOICE.

THAT'S SETTLED (T. Voorham) - on jumping away bumped with GALLANTRY GIRL, which shifted in. Shortly after jumping away was inconvenienced when BATTLE ROYALE was taken out by FRESH AIR FRED.

TONIGHTS THE NIGHT (D. Caboche) - jumped away awkwardly and shifted out. A post-race veterinary examination revealed no visible abnormalities.

ROLLING DUCK (H. Yuen) - had to be steadied and was taken wider approaching the winning post to avoid the heels of BATTLE ROYALE, which shifted out abruptly.

MIS GUIDED CHOICE (H. Edgley) - had to be steadied near the 200m to avoid the heels of NOORTOOMANY, which shifted out.

Correct weight was delayed to allow H. Yuen (ROLLING DUCK), placed third, to view the vision in the straight.

RACE 3: WUDINNA HOTEL MAIDEN HANDICAP - 1350 Metres

BIG MERCH (B. Wong) - laid in under pressure in the straight and inside the 200m shifted in onto IN THE BUFF. Rider was reprimanded and advised she would be required to make a greater effort to keep her mounts straight in future.

IN THE BUFF (C. Munro) - jumped away awkwardly. Approaching the 1000m rider had to take hold of her mount to avoid the heels of MY BOY JETT, which shifted in. Near the 200m rider had to take hold of her mount when disappointed for a run to the inside of BIG MERCH, and did not obtain clear running until near the 50m.

RURAL TRADER (H. Edgley) - slow into stride.

DANORO PRINCE (C. Murray) - raced greenly throughout the event and proved difficult to ride in the straight.

JAY 'N' DOUBLE YOU (S. Tomlinson) - a post-race veterinary examination revealed no visible abnormalities.

MY BOY JETT (H. Yuen) - approaching the 1000m shifted in onto IN THE BUFF. Rider was severely reprimanded and advised to ensure she is sufficiently clear prior to shifting ground in future.





RACE 4: CELLARBRATIONS COFFIN BAY BENCHMARK 62 HANDICAP - 1350 Metres

The start of this event was delayed approximately two minutes.

AHSO (R. Milnes) - laid in under pressure in the straight, and near the 100m shifted in onto SORRIDERE.

KAYSERI (NZ) (S. Metcalfe) - a post-race veterinary examination revealed no visible abnormalities.

VELARO (A. Jordsjo) - laid out under pressure in the straight.

REALTIN (J. Opperman) - near the 200m bumped with POUVOIR DE SOIE.

SORRIDERE (B. Wong) - jumped away awkwardly and shifted out onto POUVOIR DE SOIE. Near the 100m was forced to race in restricted room between AHSO, which laid in, and POUVOIR DE SOIE, which shifted out slightly.

POUVOIR DE SOIE (T. Voorham) - hampered on jumping away when SORRIDERE shifted out. Near the 200m bumped with REALTIN, resulting in POUVOIR DE SOIE being taken out slightly.

BAD MOON RISING (H. Yuen) - raced wide without cover throughout the event.

THE MASTER (C. Tootell) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Shortly after being loaded became fractious in the barriers and struck its head on the barrier structure. Acting on veterinary advice Stewards declared THE MASTER a late scratching at 2.31pm. Trainer, Mr B. J. Cozamanis was advised that a warning had been placed on the gelding in relation to its barrier manners. Mr Cozamanis was further advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 5: THE MARINA HOTEL BENCHMARK 64 HANDICAP - 1750 Metres

BOOKER TEE (H. Edgley) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg (3/5). Co-trainer, Mr J. Dunn, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

ENBARR (T. Voorham) - rider reported that after obtaining a position in the lead the gelding dropped the bit and did not respond to her riding despite her efforts.

MOUNT MADEIRA (NZ) (R. Milnes) - raced keenly in the early stages of the event.

MUFFLA (S. Fawke) - slow to begin.

HOUSE SPOUSE (NZ) (S. Tomlinson) - a post-race veterinary examination revealed the gelding to be lame in both hind legs (2/5). Trainer, Ms J. Stoetzer, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

SINO WITNESS (A. Jordsjo) - near the 1000m had to be steadied to avoid the heels of ENBARR when the pace of the race was eased.

RACE 6: TUMBY BAY HOTEL BENCHMARK 56 HANDICAP - 1210 Metres

MESSERSCHMITT (A. Livesey) - jumped away awkwardly.

JONQUEST (B. Wong) - jumped away awkwardly.

SWIFT TERCEL (C. Munro) - jumped away awkwardly.

JUSTICA'S BONUS (H. Edgley) - near the 1000m shifted in onto FREE WILMA. Rider was reprimanded and advised to ensure she was sufficiently clear when shifting ground in future.

NASDANA (J. Opperman) - jumped away awkwardly.



RACE 6: TUMBY BAY HOTEL BENCHMARK 56 HANDICAP - 1210 Metres (cont'd)

SHEMA (T. Voorham) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

FREE WILMA (K. Crowther) - raced keenly in the early and middle stages of the event. Near the 1000m, when racing keenly, was inconvenienced when taken in by JUSTICA'S BONUS, which shifted in.

RACE 7: BECOME A PORT LINCOLN MEMBER BENCHMARK 56 HANDICAP - 1210 Metres

MCCAIN (R. Milnes) - rider reported that the gelding never travelled in today's event and proved disappointing.

STORM VOYAGER (T. Voorham) - had difficulty obtaining clear running from the entrance to the straight until inside the 200m.

HAYZEE FANTAYZEE (H. Edgley) - on jumping away bumped with CALL ME HERBIE and was taken in onto BIGNOTA.

LAKEHURST (A. Jordsjo) - jumped away awkwardly.

CALL ME HERBIE (D. Caboche) - on jumping away shifted in and bumped HAYZEE FANTAYZEE.

BIGNOTA (A. Livesey) - contacted on jumping away by HAYZEE FANTAYZEE.

TIAMAT (C. Munro) - jumped away awkwardly and raced ungenerously for a short distance.

SON OF AKEED (B. Wong) - raced wide without cover throughout the event.

DAY FOR IT (NZ) (H. Yuen) - laid in, in the straight.

RACE 8: STREAKY BAY HOTEL BENCHMARK 68 HANDICAP - 1000 Metres

SEA WITNESS (A. Livesey) - shortly after jumping away was inconvenienced and lost its position when ROYAL TYKE shifted out.

ROYAL TYKE (B. Wong) - shortly after jumping away shifted out onto SEA WITNESS.

ARTFUL AMBITION (C. Murray) - laid out under pressure in the straight.

SIR GRUMPY (A. Jordsjo) - raced wide without cover throughout the event.

KOVA (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.
