Report on Race Meeting held at Strathalbyn Racecourse by the Strathalbyn Racing Club on Sunday, 28 January 2024

RACE 1: DISTINCTIVE BLINDS & CURTAINS FILLIES AND MARES MAIDEN PLATE - 1200 Metres

FOREVER WILD (R. Milnes) - stood flat-footed at the start and lost considerable ground (ten lengths). Trainer, Mr K. Healy, was advised that the mare would now be required to jump away with the field in an Official Barrier Trial or Approval to Race jump-out prior to a future event.

IVA DREAM (K. Hannan) – slow to begin. After the winning post fell and dislodged its rider. A post-race veterinary examination revealed minor lacerations. K. Hannan was examined by the First Care Medical personnel and transported to hospital for further assessment. An inquiry into this incident was adjourned to a date to be fixed. Trainer, Mr G. Young, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

MORLAIX (M. Collett) - rider reported that the filly did not travel well in the early stages of the event and was disappointing when placed under pressure.

POPSTAR PRINCESS (J. Holder) – approaching the winning post was eased when racing close to the heels of TAMERICA. Rider explained that when placed under pressure the filly raced greenly. A post-race veterinary examination revealed no visible abnormalities.

TAMERICA (J. Potter) - lost its near hind plate during the event.

Prior to the running of Race 2 a section of the track was inspected by Stewards and deemed suitable to continue racing on.

Following the running of this event the rider group advised Stewards that, due to the fall on pulling up in Race 1 and the subsequent medical treatment required by Kelsey Hannan, they did not wish to continue riding on the day. Acting on this advice Stewards postponed the meeting at 2.30pm.
