Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Streaky Bay Racecourse by the Streaky Bay Racing Club on Saturday, 23 March 2024

TRACK: Dirt / Good (More loosened surface than fast, some kickback may be evident)

RAIL: True.

<u>WEATHER</u>: Fine

RACE 1: CHRIS GEORGIOU BUILDING MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately three minutes.

BIG OL' RIG (J. Doyle) - laid out under pressure in the straight.

MIKKI BEAN (T. Hutchinson) - difficult to load. Trainer, Mr G. Lynch, was advised that a warning had been placed on the gelding.

SHIPWRECK (I. Lam) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by I. Lam and noted that she used it on four occasions over the final 100m of the event. Rider also pleaded guilty to a charge under AR132(7)(a)(i) for consecutive use of the whip and was reprimanded.

SURVEY LANE (S. Fawke) - rider explained that the gelding raced flat during the event, and when asked for an effort in the straight did not respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

THIS ONE DAD (M. Henderson) - slow to begin.

LINCOLN ROSE (A. Lai) - reared on jumping away and was slow to begin.

VALKUR (P. Brewster) - held up for clear running rounding the home turn until near the 300m. Laid out over the concluding stages of the event.

RACE 2: LETCHER AND MORONEY CHARTERED ACCOUNTANTS / YOUR FINANCIAL EDGE BENCHMARK 62 HANDICAP - 1000 Metres

The start of this event was delayed approximately two minutes.

BELMONT DAY (C. Munro) - laid out under pressure in the straight.

SCUDETTO (P. Brewster) - laid out under pressure in the straight.

TAJAVEDO (I. Lam) – laid in under pressure in the straight. Rider explained that the gelding travelled well in the event; however, when asked for an effort in the straight it did not respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: NORTHERN TRANSPORTABLES BENCHMARK 54 TROPHY - 1200 Metres

ROCK HARD (I. Lam) - near the 1000m shifted in and away from CHIARO, which shifted in, onto ROMPER STOMPER, which was obliged to be checked and lost its position. Rider was reprimanded under AR131(a) for careless riding and advised to exercise greater care when shifting ground in future.

CHIARO (A. Lai) - near the 1000m shifted in, taking ROCK HARD in onto ROMPER STOMPER, which was obliged to be checked and lost its position. Rider was reprimanded under AR131(a) for careless riding and advised to exercise greater care when shifting ground in future.

TRANSZAM (J. Doyle) - rider explained that the gelding travelled well during the event; however, did not finish the event off as anticipated and, in her opinion, the gelding would be better suited racing over further distance. A post-race veterinary examination revealed no visible abnormalities.

TALLU (Z. Lloyd) – underwent a pre-race veterinary examination on arrival on course and was found to be lame in the near foreleg (2/5) and was therefore deemed unsuitable to start. Acting on this advice Stewards declared TALLU a late scratching at 12.57pm. Co-trainer, Mr W. Hornhardt, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

ROMPER STOMPER (C. Munro) – near the 1000m was obliged to be checked when ROCK HARD shifted in and away from CHIARO, and as a result lost its position.

RACE 4: STREAKY BAY HOTEL 3H BENCHMARK 62 HANDICAP - 1350 Metres

The start of this event was delayed approximately eight minutes due to a section of the rail being required to be repaired near the 1200m due to damage being caused by the starting gates.

BADISS (T. Hutchinson) - jumped away awkwardly. Near the 100m was momentarily inconvenienced when MISCHIEVOUS TYCOON shifted in slightly.

KINGSON (I. Lam) - laid out under pressure in the straight.

PRESCIENT (C. Munro) - jumped away awkwardly. Rider dropped her off side rein over the concluding stages of the event.

REGAL ROCKET (S. Fawke) – rider explained that the gelding travelled fairly during the event; however, when placed under pressure in the straight did not respond to his riding. He added that in his opinion the gelding did not appreciate the track conditions. A post-race veterinary examination revealed no visible abnormalities.

MISCHIEVOUS TYCOON (A. Lai) - near the 100m shifted in slightly onto BADISS. Rider explained that when asked for an effort in the straight the mare did not respond to his riding.

RACE 5: STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 Metres

SHAKESPEARE (NZ) (P. Brewster) - slow into stride.

BELLMAN (NZ) (S. Fawke) - hung out rounding the turn near the 1500m.

THE ICE CUTTER (T. Hutchinson) – rider explained that the gelding hung out rounding the turn near the 1500m, travelled well during the event; however, was not suited by the pattern of the race. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: XXXX / STREAKY BAY COMMUNITY HOTEL RATING 0 - 54 HANDICAP - 1800 Metres

VANCOUVER VELVET (Z. Lloyd) - slow to begin.

JAMCRA (NZ) (S. Fawke) - rider explained that the gelding would benefit from the run, but could offer no other explanation for the gelding's performance.



RACE 6: XXXX / STREAKY BAY COMMUNITY HOTEL RATING 0 - 54 HANDICAP - 1800 Metres (cont'd)

LEVEE (M. Henderson) - rider explained that the gelding hung out rounding the turn near the 1500m and was off the bridle from the 800m, and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

FUNNY LEGS (J. Doyle) - laid out under pressure in the straight.

DEVINE ASSASSIN (T. Hutchinson) – near the 500m was obliged to be momentarily steadied when awkwardly placed on the heels of BARON OF BEDFORD (NZ). A post-race veterinary examination revealed no visible abnormalities.

AKUBRA BLACK (A. Lai) - rider reported that the gelding hung out rounding the turn near 1500m.
