RACE 1: E.E MUIR & SONS MAIDEN PLATE - 1400 Metres

CROWN AND ANCHOR (S. Payne) - jumped away awkwardly and shifted in onto A REEL DIVA. Near the 1100m rider had to take hold of his mount to avoid the heels of DON'T MATTA ME, which shifted in and at the same time, the gelding had commenced to over race. Inside the 100m rider lost use of his near side rein.

DON'T MATTA ME (D. Tourneur) - near the 1100m shifted in onto CROWN AND ANCHOR. Rider was severely reprimanded under AR131(a) and advised to ensure that he is sufficiently clear when shifting ground.

MY GAL VAL (C. Puls) - on jumping away bumped with AMERICAIN MISS.

A REEL DIVA (C. Munro) - inconvenienced on jumping away by CROWN AND ANCHOR, which shifted in.

A WANDERING STAR (NZ) (C. Murray) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

RACE 2: THE MIDFIELD GROUP MAIDEN PLATE - 2100 Metres

APACHE STATION (S. Payne) - jumped away awkwardly and as a result was slow to begin. Raced greenly throughout the event. Momentarily held up for clear running rounding the home turn.

FREE FALLIN' (D. Caboche) - laid in, in the straight

ROLLING THUNDER (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

ROXY QUEEN (H. Grace) - rider explained the mare travelled only fairly in the early stages and when placed under pressure near the 1000m did not respond to his riding. He added that he became concerned with ROXY QUEEN's action and for that reason he did not ride his mount out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

SHARMA PRINCESS (NZ) (T. Hutchinson) - jumped away awkwardly. Raced wide without cover throughout the event.

ISLE OF MIKKINOS (J. Eaton) - rider could offer no explanation for the filly's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: RICHARD RAY INSURANCE BROKERS CLASS ONE HANDICAP - 1300 Metres

EL PASO CITIE (C. Puls) - laid out in the straight.

BYWATERS ROAD (J. Opperman) - raced wide without cover throughout the event.

LYNES (NZ) (K. Walters) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: COOPERS BREWERY BENCHMARK 66 HANDICAP - 1100 Metres

ROHLON DRUNK (T. Hutchinson) - raced wide without cover throughout the event. Laid in, in the straight.

SPIN THE REWARDS (C. Murray) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race.

FOSTER STREET (D. Tourneur) - slow to begin.

RACE 5: OMNIZAR BENCHMARK 66 HANDICAP - 1400 Metres

RISING LEGEND (F. Atkinson) - laid out in the straight. Rider reported that the gelding hung out throughout the event.

NAVILLUS EXCEL (H. Grace) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

WHISKEY 'N' WOMEN (S. Payne) - near the 400m had to be steadied when racing in restricted room between PEWTER, which rolled in and JUST LIKE LISA, which rolled out.

JUST LIKE LISA (M. Collett) - raced keenly in the early stages of the event. Held up for clear running for a short distance near the 150m, shifted in and made contact with ANRUSHKA.

Correct weight for this event was delayed to allow S. Payne (WHISKEY 'N' WOMEN) placed second and Trainer, Mr J. Frew to view the vision near the 400m. After doing so, S. Payne lodged an objection against JUST LIKE LISA (M. Collett) being declared the winner, alleging interference near the 400m. After considering the evidence, viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

RACE 6: WATTLE RANGE COUNCIL RATING 0 - 56 HANDICAP - 1700 Metres

LOOKING SUAVE (NZ) (J. Kissick) – raced keenly in the early and middle stages of the event. Held up from near the 200m until near the 150m and was obliged to shift out to obtain clear running.



RACE 6: WATTLE RANGE COUNCIL RATING 0 - 56 HANDICAP - 1700 Metres (cont'd)

EARL OF BANTRY (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

OFCOURSE I WILL (J. Opperman) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ALLGO (S. Metcalfe) - raced keenly in the early and middle stages of the event. Approaching the 200m shifted out onto MOORAK MISS. Rider was reminded of her obligations under AR131(a).

MOORAK MISS (Z. Lloyd) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Near the 200m had to be steadied to avoid the heels of ALLGO, which shifted out. Held up for clear running from near the 200m until the 100m.

ARTIE'S AVIATOR (D. Tourneur) – underwent a pre-race veterinary examination at the barriers and was deemed suitable to race. Became held up for clear approaching the 100m. Rider explained that once the gelding was held up for clear running, he was not comfortable with ARTIE'S AVIATOR's action and for that reason he did not reason he did not ride his mount out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

WARMINSTER (A. Livesey) - jumped away awkwardly.

RACE 7: DIGIORGIO FAMILY WINES PENOLA CUP (HEAT 6 LIMESTONE COAST CUP SERIES) (BENCHMARK 78 HANDICAP) - 1700 Metres

PRINCE JOFRA (R. Milnes) – near the 200m was contacted by BOLT BY, which shifted in and was tightened onto WEST CLIFF. Approaching the winning post bumped with BOLT BY.

WILD WILLY (J. Opperman) - laid in, in the straight.

BOLT BY (S. Fawke) - near the 200m when laying in, shifted in and made contact with PRINCE JOFRA. Rider was severely reprimanded and advised, in future, to make a greater effort to keep his mounts straight. Approaching the winning post bumped with PRINCE JOFRA.

VICTORY BANDIT (S. Metcalfe) - held up from the 400m until the 150m.

WEST CLIFF (T. Voorham) - raced in restricted room for a short distance between PRINCE JOFRA and DALE'S ROCKET when PRINCE JOFRA was taken in BOLT BY, which shifted in.

Correct weight for this event was delayed to allow S. Fawke (BOLT BY) placed second and Trainer, Mr J. Frew to view the vision in the straight. After doing so, S. Fawke lodged an objection against PRINCE JOFRA (R. Milnes) being declared the winner, alleging interference in the straight. After considering the evidence, viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

RACE 8: EDWARD & GLENDA DOBIE MEMORIAL RATING 0 - 56 HANDICAP - 1300 Metres

SWANKYTOFF (J. Kissick) - hampered on jumping away when contacted by CORK HARBOUR and as a result lost its position.

TALES OF CONFLICT (J. Doyle) - slow to begin. Laid out rounding the home turn.

CORK HARBOUR (A. Livesey) - contacted on jumping away by KATE'S VALLEY and as a result was taken out and contacted SWANKYTOFF. Near the 1000m when racing keenly shifted out to avoid the heels of ANY LUCK (NZ).

MISS GATSBY (D. Tourneur) - near the 850m raced ungenerously for a short distance.

KATE'S VALLEY (A. Lai) - on jumping away, shifted out and contacted CORK HARBOUR.



RACE 8: EDWARD & GLENDA DOBIE MEMORIAL RATING 0 - 56 HANDICAP - 1300 Metres (cont'd)

BUNUMBURT (S. Metcalfe) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Near the 1000m when racing keenly dipped when the gelding appeared to clip the heels of CORK HARBOUR, which shifted out.

GENERAL

Stewards inquired into the conduct of Trainer, Mr J. Frew when leaving the Stewards room following the protest hearing in Race 7. Trainer Mr J. Frew pleaded guilty to a charge under AR228(b) for misconduct in that he used inappropriate language when leaving the Stewards room and was fined \$500.
