RACE 1: FLEURIEU MILK COMPANY 3YO MAIDEN PLATE - 1300 Metres

ARTILLERY (NZ) (J. Eaton) - inclined to shift about under pressure in the straight.



RACE 1: FLEURIEU MILK COMPANY 3YO MAIDEN PLATE - 1300 Metres (cont'd)

GREAT CITY (A. Lindsay) - a post-race veterinary examination revealed no visible abnormalities.

LONGER ROUTE (S. Payne) - raced keenly in the early and middle stages of the event.

MAXILDO (B. Price) - slow to begin. Raced keenly in the early and middle stages of the event. Raced greenly throughout the event. Rider reported that the gelding raced extremely greenly throughout the event, was intractable and proved difficult to ride. A post-race veterinary examination revealed minor abrasions to the right side of the mouth but no other abnormalities.

DOLCEMENTE (C. Murray) – laid out rounding the home turn and under pressure in the straight. Lost its near fore plate during the event.

RACE 2: SPORTSBET FAST FORM HANDICAP - 1550 Metres

ALPINE FLYER (R. Milnes) - raced wide without cover throughout the event.

TEST THE LAW (J. Opperman) – jumped away awkwardly. Near the 200m was inconvenienced when brushed and taken wider by JENKINS.

WORSFOLD (J. Holder) - rider explained that due to the formation of the field he had settled further forward than he had anticipated rather than be caught wide without cover.

TEXAN WINDSTORM (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

ROSE OF DUPORTH (M. Collett) - raced keenly in the early and middle stages of the event. Held up from near the 300m until inside the 200m.

RUN AND TELL (B. Price) - laid out under pressure in the straight.

RACE 3: THE FOTOBASE GROUP HANDICAP - 1400 Metres

MY KHALIFA (R. Milnes) - raced wide without cover throughout the event.

EASY CAMPESE (A. Livesey) - raced keenly in the early and middle stages of the event.

LAST GIRL LOVE (J. Holder) - laid in under pressure in the straight.

EAST INDIAMAN (M. Collett) - a post-race veterinary examination revealed no visible abnormalities. Following the running of the event trainer, Mr D. McLeod, had the gelding scoped at the Morphettville Equine Clinic, which revealed EAST INDIAMAN to have grade three mucous. He advised that the gelding would undergo treatment and be freshened up.

ANNIHILATE (T. Voorham) - laid in under pressure in the straight.

RUBINI (B. Price) - slow to begin.

RACE 4:PFD FOOD SERVICES HANDICAP - 1000 Metres

STORYTELLER (R. Milnes) - held up from the 400m until inside the 200m.

SIOUX WARRIOR (J. Holder) - laid out over the concluding 400m of the event.

LAKE AGAWAM (M. Collett) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

COOL THE JETS (C. Murray) - held up from the entrance to the straight until inside the 200m.

GILMORE (E. Finnegan) - laid in under pressure in the straight.

KINETIC JEWEL (K. Crowther) - raced wide without cover throughout the event.



RACE 5:SPORTSBET NOBODY DOES IT EASIER HANDICAP - 1950 Metres

THE NEPHEW (J. Holder) - laid in under pressure in the straight.

DOES IT (NZ) (J. Toeroek) - rider reported that in his opinion the gelding is better suited on a track with more give in it. A post-race veterinary examination revealed no visible abnormalities.

AMMO AMOR (S. Metcalfe) - laid in under pressure in the straight.

DISAGREEABLE MISS (K. Crowther) - slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

DIXIE WHISTLER (A. Livesey) - over-raced in the early and middle stages of the event.

RACE 6: TRIPLE M HANDICAP - 1250 Metres

FOURTH POWER (M. Collett) - jumped away awkwardly and was slow into stride. Laid out under pressure in the straight.

BIG OPTION (F. Atkinson) - laid out under pressure in the straight.

DECLARED (R. Milnes) - a post-race veterinary examination revealed no visible abnormalities.

EXALTED DAME (A. Livesey) - laid out under pressure in the straight.

KAYSERI (NZ) (S. Metcalfe) - hung out under pressure in the straight. Rider reported that the gelding never travelled throughout and hung out in the straight. A post-race veterinary examination revealed no visible abnormalities.

WILLYBEAFACTOR (D. Caboche) - raced keenly in the early stages whilst being restrained.

BONNIE GANGSTER (J. Potter) - inside the 200m altered course to obtain clear ground and had difficulty obtaining clear ground for a short distance.

ZERO INN (S. Payne) - laid out under pressure in the straight.

FOSTER STREET (B. Price) - slow into stride.

RACE 7: SPORTSBET HANDICAP - 1000 Metres

LONRODEX (C. Jones) - shifted out on jumping away onto WONDERWOMEN.

LUNAR HERO (C. Murray) - raced keenly in the early and middle stages of the event.

WONDERWOMEN (J. Holder) - inconvenienced on jumping away when contacted by LONRODEX. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

CLASSY KENNY (J. Eaton) - rider reported that the gelding made excess respiratory noises on pulling up and in her opinion may have choked down. A post-race veterinary examination revealed no visible abnormalities.

KLABEL (NZ) (B. Price) - raced wide without cover throughout.

STARLITE VALLEY (J. Potter) - slow to begin. Held up from the entrance to the straight until inside the 200m.

WINNING REVOLUTION (M. Collett) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Trainer, Mr J. O'Connor, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 8: THOMAS FARMS HANDICAP - 1300 Metres

The start of this event was delayed approximately three minutes due to a delay with an interstate race.

CLASSY BANNER (A. Livesey) - slow to begin. Over-raced in the early and middle stages of the event.

CHAMBERS BAY (K. Crowther) - held up from the 400m until approaching the 200m.

SAN LUCIDO (J. Holder) - jumped away awkwardly and shifted in.

VOLTAGE POINT (T. Voorham) - laid in under pressure in the straight.

STRANGELESS (J. Eaton) - jumped away awkwardly and shifted out. Near the 1100m was forced to race in restricted room for a number of strides when awkwardly placed between MY MALOO, which shifted out, and FAVOURITE CHILD, which shifted in slightly.

PRINCE REICHWEITE (C. Jones) - raced wide without cover throughout the event.

SUPER ALANA (NZ) (J. Potter) - slow to begin, and shortly after was inconvenienced SAN LUCIDO shifted in.

FAVOURITE CHILD (B. Price) - raced wide without cover throughout the event.

LUNASHA (J. Opperman) - rider pleaded guilty to a charge under AR211(1) in that he weighed in, in excess of 0.5kg over the weight at which he weighed out and was fined \$200.

RACE 9: SPORTSBET SAME RACE MULTI HANDICAP - 1550 Metres

MARACOURT (J. Eaton) - slow to begin. Held up from the 400m until inside the 200m, and then approaching the 100m was forced to take hold when tightened between NULLIFY, which shifted out, and HAMSLETTE, which shifted in.

ICHIBANSAN (K. Crowther) - rider explained that the gelding was disappointing and did not respond to her riding in the straight, but appeared to pull up in a normal manner. A post-race veterinary examination revealed no visible abnormalities.

BADISS (T. Voorham) - slow to begin. Laid in under pressure in the straight.

PEACEMAKER (F. Atkinson) - slow to begin.

HAMSLETTE (C. Murray) - inclined to shift about under pressure in the straight and approaching the 100m shifted in onto MARACOURT. Rider was severely reprimanded.

FREE VINO (J. Holder) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities

NULLIFY (J. Opperman) - laid out under pressure in the straight and approaching the 100m shifted out onto MARACOURT. Rider was severely reprimanded.

CROWN HARMONIUM (B. Price) - slow to begin. Held up from the 400m until the entrance to the straight.

THE CASSINI (C. Jones) - near the 1100m raced keenly for a number of strides whilst being restrained.

TOBIWASHI (A. Livesey) - raced keenly in the early and middle stages of the event.
