Saturday, 29 June 2024

RACE 1: QUAYCLEAN HANDICAP - 1000 Metres

ASTON RAPOVA (B. Price) - raced keenly in the early and middle stages of the event.

SQUAD (S. Clarke) - jumped away awkwardly. Rider pleaded guilty to a charge under AR131(b) in that she failed to ride her mount out fully to the end of the race and was fined \$400. In arriving at this penalty Stewards took into account that they could not be comfortably satisfied that the breach affected the placings in the event.

CHOSEN BLONDE (F. Atkinson) - jumped away awkwardly.

WINNING REVOLUTION (J. Doyle) - rider pleaded guilty to a charge under AR131(b) in that she failed to ride her mount out fully to the end of the race and was fined \$400. In arriving at this penalty Stewards took into account that they could not be comfortably satisfied that the breach affected the placings in the event.



RACE 1: QUAYCLEAN HANDICAP - 1000 Metres (cont'd)

FOXY FEMME (D. Tourneur) - hung out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed the mare to have bled from both nostrils. Co-trainers, Mr P. & Mrs B. Blanch, were advised that as this was the mare's second bi-lateral bleed it was now ineligible to start in a race in accordance with AR79(6).

Correct weight for this event was delayed to allow Mr J. O'Connor, the trainer of WINNING REVOLUTION, placed seventh, to view the official image.

RACE 2: HAHN HANDICAP - 1000 Metres

OVEREXTEND (J. Opperman) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

KONG (F. Atkinson) - Stewards questioned rider in relation to her riding of the gelding in the straight, in particular her decision inside the 200m to shift to the outside of SHADOWFAX, when in the opinion of Stewards there was a clear run available to her between that gelding and JIMMYS EDGE. She explained that KONG had not picked up as she had hoped when placed under pressure, and she had formed the view when walking to the event prior to today's racing that the ground towards the outside of the track was superior, and for this reason she elected to alter course to a position in the better going. She added that after shifting ground the gelding stretched out much better and finished the race off well. Stewards noted her explanation.

PUTANOTHERCOININ (B. Price) - raced keenly in the early and middle stages of the event. Rider reported that the gelding travelled well in the early and middle stages of the event; however, when asked for an effort at the entrance to the straight did not respond to his riding and was disappointing to the finish. He added that in his opinion the gelding may not have been suited by the track condition. A post-race veterinary examination revealed no visible abnormalities.

VALAROC (K. Crowther) - rider reported that the gelding did not handle the track condition. Lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

MAGIC FIELD (R. Milnes) - inclined to lay out under pressure in the straight.

BABAYKA (S. Clarke) - a post-race veterinary examination revealed a slow recovery. First aid administered.

RACE 3: CROSER HANDICAP - 1950 Metres

ICHIBANSAN (J. Opperman) - raced keenly in the early and middle stages of the event.

IMPOSING SUSPECT (NZ) (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

TAPA CAPALL (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

MARIOTA (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

HAYAI MESU (B. Price) - underwent a pre-race veterinary examination as it raced on Wednesday, 26 June 2024, and was deemed suitable to start.

RUN ON (NZ) (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

SCAMSTER (E. Finnegan) - reared on jumping away and was slow into stride.



RACE 4: SPORTSBET JOCKEY WATCH HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes in order to avoid a clash with an interstate event.



RACE 4: SPORTSBET JOCKEY WATCH HANDICAP - 1550 Metres (cont'd)

DEGRAVES (IRE) (S. Clarke) - underwent a pre-race veterinary examination as it had not raced in over twelve months and was found to be lame in the off foreleg (2/5) and therefore deemed unsuitable to start. Acting on this advice Stewards declared DEGRAVES (IRE) a late scratching at 12.52pm. Trainer, Mr G. Bedggood, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

NOT USUAL GLORIOUS (A. Livesey) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MONTIGN (M. Collett) - rider reported that the gelding never travelled in the event.

CAWDOR (GB) (T. Pannell) - change of tactics - attempt to be more forward - led.

WORSFOLD (K. Crowther) - change of tactics - be positive out of the gates and attempt to lead - settled behind the leader.

AITCH D'AMICO (B. Price) - rider reported that the gelding never travelled in the event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

TYITA (D. Tourneur) - rider reported that the gelding was inclined to lay out during the event.

RACE 5: FLEURIEU MILK COMPANY HANDICAP - 1000 Metres

VINTAGE STAR (J. Opperman) - inconvenienced on jumping away when taken in onto KALASEC by ANOTHERHOUSE (NZ). Raced wide without cover throughout the event. Laid in under pressure in the straight and near the 200m shifted in onto DESERT DANCING. A post-race veterinary examination revealed no visible abnormalities.

KALASEC (B. Price) - hampered on jumping away when tightened between VINTAGE STAR, which had been taken in, and STOKKE, which shifted out.

LINGANI (D. Tourneur) - slow to begin. Laid in under pressure in the straight and near the 150m shifted in and brushed ZANTHRON.

ZANTHRON (H. Yuen) - slow to begin. Held up from the 500m until inside the 300m. Near the 150m was momentarily inconvenienced when brushed by LINGANI.

ANOTHERHOUSE (NZ) (C. Murray) - shifted in on jumping away onto VINTAGE STAR. Laid out rounding the home turn and under pressure in the straight. Near the 200m shifted out slightly onto DESERT DANCING.

DESERT DANCING (J. Eaton) - had to be momentarily steadied near the 200m when tightened between ANOTHERHOUSE (NZ) and VINTAGE STAR, which both shifted ground. Rider reported that her mount did not handle the track conditions. A post-race veterinary examination revealed no visible abnormalities.

STOKKE (H. Grace) - shifted out on jumping away onto KALASEC. Hung out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow H. Yuen (ZANTHRON), placed second, and that gelding's co-trainer, Mrs N. Searle, to view the vision in the straight.

RACE 6: SPORTSBET OAKLANDS PLATE - 1400 Metres

COLMAR (S. Payne) - hung out rounding the home turn and under pressure in the straight. Rider reported that the gelding hung out throughout the event.

DANCING STORM (J. Opperman) - inconvenienced when contacted by OMANYALA near the 700m.





RACE 6: SPORTSBET OAKLANDS PLATE - 1400 Metres (cont'd)

OMANYALA (T. Pannell) - laid in under pressure in the straight. Near the 700m shifted out in an attempt to improve and in doing so contacted DANCING STORM on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

BIG BRUTE (F. Atkinson) - rider reported that the gelding did not handle the track conditions.

SERINITE ILLUSION (S. Logan) - rider reported that the colt raced greenly throughout the event.

CAVITY BAY (J. Holder) - rider reported that the filly did not handle the track conditions. A post-race veterinary examination revealed the filly to have the thumps.

LOVEY (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

TALISAY (A. Livesey) - slow into stride. Rider reported that it was her intention to settle further forward in the event, but she was unable to do so. She added that the filly did not handle the track conditions.

BUSHANN (H. Grace) - laid out rounding the home turn and under pressure in the straight.

TEARDROP ROTATION (D. Caboche) - slipped behind for no apparent reason near the 800m.

FEMMINILE (K. Crowther) - slow to begin.

HARD LEAF (R. Milnes) - slipped behind for no apparent reason near the 800m.

FUTURE COMMAND (T. Voorham) - a post-race veterinary examination revealed the colt to be lame in the near foreleg (2/5). Trainer, Mr C. Bieg, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial and race start.

Following the running of the event Stewards inspected a section of the track near the 800m and identified no issues.

RACE 7: HAPPY 18TH COOPER BARLOW HANDICAP - 1250 Metres

FLY ON BYE (S. Clarke) - raced wide without cover throughout the event.

NICCOLITE (H. Grace) - jumped away awkwardly. Laid out under pressure in the straight.

HEADPHONES (A. Livesey) - dipped for no apparent reason near the 500m.

WHEELS (NZ) (F. Atkinson) - slow to begin.

THE SEVEN SEAS (T. Pannell) - co-trainer, Mr N. O'Shea, made a submission to Stewards that the mare be withdrawn due to the track downgraded. Stewards acceded to the request and declared THE SEVEN SEAS a late scratching at 12.29pm.

KATIM'S CLUB (C. Murray) - rider reported that the mare choked down during the event. A post-race veterinary examination revealed the mare to have cardiac arrhythmia (1st occurrence). Trainer Ms. R. Day, was advised that she was required to comply with the Racing Australia Code of Practice in order for the mare to be reinstated to race.

RACE 8: GRAND SYNDICATES HANDICAP - 2250 Metres

HEART OF PUISSANCE (T. Pannell) - rider explained that his instructions were to be more positive due to the good barrier draw and the reapplication of blinkers. He stated that the gelding jumped away well and due to there being little speed in the race he elected to push forward and obtain the lead. He added that HEART OF PUISSANCE travelled well in the early stages; however, locked its jaw near the 900m, commenced to hung out and was disappointing. A post-race veterinary examination revealed no visible abnormalities.





RACE 8: GRAND SYNDICATES HANDICAP - 2250 Metres (cont'd)

SILENT COMMAND (B. Price) - rider explained that the gelding travelled fairly during the event; however, from near the 700m did not respond to his riding and commenced to lose ground, and for this reason he elected not to ride SILENT COMMAND out to the finish. A post-race veterinary examination revealed no visible abnormalities.

DASHING DUCHESS (NZ) (J. Holder) - slow to begin.

SMILING ASSASSIN (M. Collett) - lost its off fore plate during the event.

SHADOW HAWK (NZ) (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

APEROL SPRINT (J. Eaton) - laid out under pressure in the straight.

BLUSHING TYCOON (D. Tourneur) - raced keenly in the early and middle stages of the event.

RACE 9: SPORTSBET SAME RACE MULTI HANDICAP - 1400 Metres

BRAVE STAR (NZ) (R. Milnes) - raced wide without cover throughout the event.

SOCIAL CONSCIENCE (S. Clarke) - raced keenly in the early and middle stages of the event.

MERCHANT BOSS (T. Pannell) - jumped away awkwardly and was slow into stride.

KOMACHI (IRE) (B. Price) - jumped away awkwardly and was slow into stride.

ARTILLERY (NZ) (J. Eaton) - raced keenly in the early and middle stages of the event. Rider reported that the gelding did not handle the track condition. A post-race veterinary examination revealed no visible abnormalities.

DAWNBURST (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

BULLS ON PARADE (C. Murray) - laid out under pressure in the straight.

KAYSERI (NZ) (H. Grace) - rider reported that the gelding had only travelled fairly in the early stages, from near the 600m it became awkward in its action, and approaching the 200m he became concerned with its action and for this event he eased the gelding. A post-race veterinary examination revealed no visible abnormalities.

GENERAL:

Prior to taking his first ride jockey J. Potter, provided a breathalyser sampled which detected the presence of alcohol at a concentration above the limit proscribed under AR136(1)(f) and was stood down from riding for the day. An inquiry into this matter was adjourned to a time and date to be fixed.

RIDER SAMPLING:

All twenty-three (23) riders provided a breathalyser and saliva sample prior to their first ride. One rider returned a positive result and all other riders returned negative results.

Three (3) riders provided urine samples: D. Caboche, S. Logan, M. Collett.

Race 8 - HEART OF PUISSANCE, LAKE'S FOLLY, DIXIE WHISTLER, DASHING DUCHESS (NZ), SMILING ASSASSIN.

Race 9 - BRAVE STAR (NZ), BIT OF A REBEL, DAWNBURST, ROSE OF DUPORTH, AIGUILLETTE.
