STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks
by the South Australian Jockey Club on Monday, 3 October 2011

RACE 1 : SUPPORT LABOUR DAY RACES MAIDEN PLATE - 1400 metres

In the vicinity of the 1200 metres REDLINE VECTOR (N. Rose) shifted in and inconvenienced STEAL THE JEWELS (L. Hopwood), which had to be steadied. N. Rose was reminded of his obligations when shifting ground in future. Thereafter STEAL THE JEWELS commenced to lay out making the turn near the 1000 metres very wide.

Approaching the 1000 metres TERRAFIRE (A. Herrmann) became awkward on the heels of BEAU OF BLUE (M. Hoppo) for a number of strides as the pace slackened.

BEAU OF BLUE (M. Hoppo) over-raced in the early stages and raced very ungenerously inside the 1000 metres for some distance.

L. Hopwood, the rider of STEAL THE JEWELS, reported her mount laid out throughout the event. STEAL THE JEWELS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : FLIGHT CENTRE TWILIGHT DEC 16 MAIDEN PLATE - 1000 metres

EVE'S DELIGHT (A. Herrmann) jumped away awkwardly, shifted in and contacted SMOOTH EXCELERATOR (S. Price), which was taken in. As a consequence EMPRESS WU (S. Westover) was hampered and was slow into stride.

KOODA DAWN (A. Patterson) laid out approaching the 600 metres until near the entrance to the straight.

EMPRESS WU was examined by the Club's Veterinary Surgeon who reported lacerations to both corners of the mouth.

RACE 3 : CITC MAIDEN PLATE - 1400 metres

KOODA DESTINY (G. Davis) jumped away awkwardly, shifted out and contacted with MEADOWS MOLLIE (L. Hopwood), which was taken out onto HONG KONG MISSY (J. Potter), which in turn was taken onto the heels of KLONDIKE LIL (S. Cahill). As a consequence HONG KONG MISSY lost its position.

In the vicinity of the 1200 metres PARMIGIANA (T. Baker) shifted in and away from FORCRYINGOUTLOUD (C. Lindop), which improved to its outside, and as a consequence FLAME OF LANKA (N. Rose) was obliged to be steadied when racing inside the heels of PARMIGIANA.

Racing to the 1000 metres FLAME OF LANKA (N. Rose) became awkwardly placed on the heels of PARMIGIANA (T. Baker), shifted out and brushed with LITTLE LUCKY (D. Tootell), which was taken wider. As a consequence RADMILA (A. Patterson), which was following, was hampered and shifted out, resulting in SUMMER WITH ROSIE (NZ) (C. Lions) shifting out and away from that horse. Thereafter LITTLE LUCKY made the turn in the vicinity of the 1000 metres very wide.

Inside the 1000 metres MEADOWS MOLLIE (L. Hopwood) shifted in and inconvenienced FORCRYINGOUTLOUD (C. Lindop).

Inside the 500 metres PARMIGIANA (T. Baker), which was following KOODA DESTINY (G. Davis), which had commenced to give ground, was inconvenienced and obliged to alter course to the outside of that mare to obtain clear running.

G. Davis, the rider of KOODA DESTINY, reported his mount laid out throughout the event. KOODA DESTINY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : UNITED VOICE HANDICAP - 1400 metres

SLIM HENRY was a late scratching by order of Stewards at 8.45 am. Mr. W. Clarken, the Trainer of SLIM HENRY, was fined \$100 under LR.19.1.1 for failing to scratch the gelding by the required time.

PELICANO (M. Neilson) jumped away awkwardly, shifted out and contacted JESTQUILL (J. Potter), which was taken out onto RIVIERA QUEEN (C. Lindop), resulting in that filly shifting out and brushing with ZEN (A. Herrmann).

M. Neilson, the rider of PELICANO, was questioned regarding his use of the whip prior to the 100 metres. M. Neilson was fined \$500 under ARR.137A(5)(a)(ii) for using his whip in a forehand manner on more than five occasions prior to the 100 metres. In arriving at a decision on penalty, Stewards considered the manner in which this breach occurred did not justify a more severe penalty.

RACE 5 : SA UNIONS HANDICAP - 1550 metres

RIKBAT was a late scratching by order of Stewards at 8.15 am. Having considered the explanation provided by Mr. C. Baker, the Trainer of RIKBAT, and after consultation with the Trainers' Service Centre, Stewards were satisfied regarding the bona fides of this scratching.

TABULATED (N. Rose) jumped away awkwardly, shifted in and brushed ELECTRIC CIRCUS (S. Cahill), which dipped as a consequence.

RACE 5 : SA UNIONS HANDICAP - 1550 metres (Cont'd)

In the vicinity of the 1200 metres TABULATED (N. Rose) shifted in to obtain a position closer to the inside running rail. Shortly after obtaining this position behind SONO PICCOLO (L. Stojakovic), QUICK THOUGHTS (S. Westover), to its inside, improved to a position outside the heels of SONO PICCOLO and in doing so brushed with TABULATED taking that mare wider on the track. As a consequence TABULATED raced three wide without cover for some distance thereafter.

Approaching the 200 metres WANAKA GOLD (C. Lindop) became held up for a short distance when disappointed for a run between the heels of QUICK THOUGHTS (S. Westover), which rolled in, and SONO PICCOLO (L. Stojakovic), which rolled out.

ELECTRIC CIRCUS (S. Cahill) had difficulty obtaining clear running in the early part of the straight when racing on the heels of MASTER BECKETT (M. Neilson) and was obliged to alter course to the outside of TABULATED (N. Rose) in the vicinity of the 200 metres.

N. Rose, the rider of TABULATED, explained that after receiving pressure from QUICK THOUGHTS (S. Westover) near the 1200 metres and being forced to race three wide without cover, he was unable to reclaim a position closer to the rail due to ELECTRIC CIRCUS (S. Cahill) improving to his inside.

RACE 6 : ASU ACTIVE STRONG UNITED HANDICAP - 1400 metres

CRUISING EAGLE was a late scratching by order of Stewards at 8.45 am.

PENZEVENGI (N. Rose) was slow to begin.

GO FOR HOME (S. Westover) jumped away awkwardly, shifted out and contacted TUREEN (L. Hopwood).

S. Westover, the rider of GO FOR HOME, reported his mount hung out from the 600 metres. GO FOR HOME was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Potter, the rider of CRUZIERO, explained his instructions and intentions were to take up a forward position in this event and after beginning well he managed to take an easy lead in the race. He stated thereafter the gelding ran comfortable sectionals but on straightening, when asked for an effort, was one paced and did not respond in the manner he had expected. CRUZIERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : CFMEU HANDICAP - 1000 metres

EIKEPT (M. Neilson) was slow into stride.

CONDUCTION (J. Potter) over-raced in the early stages of the event.

In the vicinity of the 200 metres CONDUCTION (J. Potter) was obliged to alter course to the inside of GLOBALWARMNSCEPTIC (S. Cahill) as that gelding rolled out.

M. Neilson, the rider of EIKEPT, explained his instructions were to take up a forward position just behind the lead but due to the gelding proving a little fractious in the barriers it was slow to muster early speed on jumping away and as a consequence he was obliged to encourage his mount to take up a forward position. He added that in the vicinity of the 800 metres he had obtained a position, which he was comfortable with and which complied with his

instructions. He stated thereafter on entering the straight the gelding was very disappointing and failed to respond to his riding. EIKEPT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. T. McEvoy, the Trainer of EIKEPT, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : CBUS HANDICAP - 1250 metres

The start of this race was delayed approximately two minutes owing to the bridle and blinkers fitted to MOUNTAIN CAT becoming undone when the mare was fractious after being loaded into the barriers.

SOPHIELICIOUS (M. Neilson) shifted out at the start and tightened MOUNTAIN CAT (S. Cahill) onto STELLA JEUNE (C. Lindop), resulting in MOUNTAIN CAT being hampered and losing its position.

MOUNTAIN CAT (S. Cahill) and STELLA JEUNE (C. Lindop) over-raced in the early stages of the event.

In the vicinity of the 700 metres SOPHIELICIOUS (M. Neilson) rolled out and inconvenienced STELLA JEUNE (C. Lindop), which was taken wider.

Racing to the 200 metres EXALTED WONDER (M. Hoppo) shifted in under pressure and brushed with ANDRONICA (A. Patterson). Shortly thereafter ANDRONICA was obliged to shift in to obtain clear running.

Approaching the finish EXALTED WONDER (M. Hoppo) again shifted in under pressure and crossed the running line of STELLA JEUNE (C. Lindop), which was obliged to steady off that mare's heels shortly after passing the winning post. M. Hoppo was severely reprimanded and advised to ensure he straightens his mounts when they commence to shift ground.

S. Cahill, the rider of MOUNTAIN CAT, explained he was unable to take up a more forward position in the race due to suffering interference shortly after the start as a result of the shift of SOPHIELICIOUS (M. Neilson) to his inside and the slight movement of STELLA JEUNE (C. Lindop) to his outside, and as a consequence he was obliged to settle further back in the field.
