Report on Race Meeting held at the Port Lincoln Racecourse

RACE 1 : EXCLUSIVE FROCK SALON / SABOIS MAIDEN PLATE – 1200 metres

EVEN DOZEN (N. Rose) was slow to begin.

JAPAN (A. Patterson) jumped out awkwardly, bumping with SECRET RETREAT (M. Hoppo).

SECRET RETREAT (M. Hoppo) was inclined to race greenly in the straight.

RACE 2 : CARLTON DRAUGHT RATING 0-72 HANDICAP – 1350 metres

JEWEL KING (P. Roff) jumped away awkwardly.

WORLD RULER (NZ) (J. Potter) and TYPHOONGEORGE (A. Patterson) were slow to begin.

W. Kerford, the rider of SARI BAYIR, which performed below expectations, explained the gelding jumped away fairly but was unable to muster the speed it had in previous starts, also at the 800 metres he tested the gelding and shortly after was forced to ride aggressively but the gelding was barely able to hold its position. He suggested the Trainer might experiment with gear in order to improve SARI BAYIR's performances. SARI BAYIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : PORT LINCOLN HOTEL / SABOIS 3YO RATING 0-61 HANDICAP – 1000 metres

RAJ HARREB (T. Zanker) and MEGA QUEEN (M. Hoppo) were slow to begin.

MISS HARREB (J. Potter) stood flat-footed at the start and as a result was slow to begin.

CASINO EXIT (J. Frew) was inconvenienced at the start when tightened for room by LYN SHEE (A. Herrmann), which jumped away awkwardly and shifted out, and GONE WITH GRACE (L. Hopwood), which jumped away awkwardly and shifted in.

RACE 3 : PORT LINCOLN HOTEL / SABOIS 3YO RATING 0-61 HANDICAP – 1000 metres
(Cont'd)

Racing at the 600 metres MISS HARREB (J. Potter) was inclined to race greenly.

From the 100 metres CASINO EXIT (J. Frew), which had commenced to improve, became held up and was not fully tested running to the finish.

Near the 100 metres LYNSHEE (A. Herrmann) shifted in onto GYRO (T. Baker), which was forced to steady. A. Herrmann was reprimanded under ARR.137(a) in that she had allowed her mount to shift ground when insufficiently clear.

Correct Weight for this event was delayed owing to T. Baker, the rider of the fourth placegetter GYRO, lodging an objection against LYNSHEE (A. Herrmann) being declared the third placegetter on the grounds of alleged interference near the 100 metres. Acting on evidence put forward, on their observations and on viewing the official footage, Stewards *upheld* T. Baker's objection. The amended placings were –

RACE 4 : YALUMBA RATING 60+ HANDICAP - 1000 metres

OUT FOR LUNCH (J. Potter) and HIGHTOM (M. Hoppo), after being loaded, broke through the front of the barriers and were quickly restrained by their riders. OUT FOR LUNCH and HIGHTOM were examined by the Club's Veterinary Surgeon and ruled fit to race.

CARBON DATE, which had become fractious in the barriers and became cast, was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, CARBON DATE was withdrawn at 2.48 pm by order of Stewards. Mr. C. Hansen, the Trainer of CARBON DATE, was advised a warning had been placed on the mare.

RONORIK (T. Baker) was slow to begin.

SUPER HIT (L. Stojakovic) jumped awkwardly bumping with HIGHTOM (M. Hoppo).

Racing to the 100 metres PASS THE ACE (J. Frew) laid in under pressure bumping with OUT FOR LUNCH (J. Potter).

RACE 5 : REVOLUTION ROOFING RATING 0-68 HANDICAP - 1000 metres

MISS ELIZA, which dislodged its rider M. Neilson after leaving the mounting enclosure was withdrawn by Stewards at 3.18 pm as this mare dislodged its rider M. Neilson en route to the barriers. M. Neilson was uninjured in the incident. Mr. T. Haddy, the Trainer of MISS ELIZA, was advised similar unruly behaviour in future would lead to action being taken against it.

ZIPAROO (J. Matthews) and KIPPSY (A. Herrmann) were slow to begin.

Racing to the 100 metres ROLL ON BAI (K. Bishop) was inclined to lay in under pressure.

RACE 6 : PORT LINCOLN TIMES RATING – 59 HANDICAP (Division 1) - 1000 metres

OFF THE RICHTER (M. Neilson) jumped away awkwardly.

DREAM THIEF (M. Hoppo) jumped away awkwardly and shifted in onto KOODA SURPRISE (N. Rose) and as a result DREAM THIEF was unbalanced when the horse's hindquarters were turned out. KOODA SURPRISE was then tightened in onto FIRE 'EM UP (A. Herrmann), which was taken in making severe contact with MUM'S MAGIC (T. Zanker), as that mare shifted out. As a result KOODA SURPRISE and FIRE 'EM UP were severely hampered.

Shortly after the start MUM'S MAGIC (T. Zanker) shifted in away from FIRE 'EM UP (A. Herrmann) resulting in LAGO AZZURRO (T. Baker) being bumped.

In the vicinity of the 700 metres OFF THE RICHTER (M. Neilson) was obliged to steady away from the heels of FINAL DYNASTY (P. Roff), which shifted in. P. Roff was severely reprimanded under ARR.137(a) in that he allowed his mount to shift in when insufficiently clear. In consequence OFF THE RICHTER (M. Neilson) shifted in brushing with DREAM THIEF (M. Hoppo).

RACE 7 : PORT LINCOLN TIMES RATING 0-59 HANDICAP (Division 2) – 1000 metres

HEART OF STONE (J. Potter) was slow to begin.

Making the turn into the straight CLEAR AZ MUD (L. Stojakovic) shifted out taking FRAARBELLE (M. Hoppo) wider on the track.

RACE 8 : DOUG WATSON'S MENSWEAR RATING 0-59 HANDICAP - 1200 metres

Mr. C. Hansen, the Trainer of DIRE WARNING, which was reluctant to be ridden to the start, was advised that if in future the gelding could not be ridden to the start, action would be taken against it.

YE BEAUTY (A. Patterson) jumped away awkwardly shifting out onto NOTRHSIDE STAR (A. Herrmann) tightening that gelding onto DIRE WARNING (S. Westover) as that gelding was taken in by VIOLATION (P. Roff), which jumped awkwardly, shifting in. As a result DIRE WARNING and NORTHSIDE STAR were inconvenienced and lost their positions.

YE BEAUTY (A. Patterson) was inclined to lay in under pressure in the straight.

SULLENBERGER, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
