RACE 1 : PEWSEY VALE HANDICAP - 2038 metres

QUEEN'S FASHION (N. Rose) was slow to jump.

FOXHAM and TEXAN WARNEY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : JANSZ TASMANIA HANDICAP - 1529 metres

FURLINE (D. Lane) jumped away awkwardly.

In the middle stages of the race GRAND TITLE (H. McKechnie) was inclined to race keenly.

At the entrance to the straight for a short distance FURLINE (D. Lane) became held up when racing behind MANILA JEWEL (N. Rose) and inside PARIS MEMORY (M. Neilson).

From the entrance to the straight until the vicinity of the 200 metres SIMPLY BOGGIE (NZ) (L. Hopwood) was held up when racing between the heels of MANILA JEWEL (N. Rose) and WINGS ON HER FEET (D. Holland).

Inside the 200 metres SIMPLY BOOGIE (NZ) (L. Hopwood) was struck by the whip of D. Holland, the rider of WINGS ON HER FEET (D. Holland).

M. Neilson, the rider of PARIS MEMORY, reported that at the entrance to the straight his saddle shifted back abruptly.

GRAND TITLE and SIMPLY BOOGIE (NZ) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : SEELEY INTERNATIONAL PLATE - 1000 metres

LA CASINO (D. Holland) was inclined to rear on jumping away.

LITTLE CRITTER (M. Neilson) jumped away awkwardly.

RAPPERS DELIGHT (N. Rose) jumped away awkwardly and was then slow into stride.

Making the turn in the vicinity of the 700 metres PORTICI (L. Hopwood) was inclined to race greenly and lay out.

RACE 3 : SEELEY INTERNATIONAL PLATE - 1000 metres (Cont'd)

Approaching the 200 metres PORTICI (L. Hopwood) was inclined to lay in and away from RAPPERS DELIGHT (N. Rose).

After entering the straight RAPPERS DELIGHT (N. Rose) was inclined to lay in.

PORTICI, RAPPERS DELIGHT and FOREST CAT were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : HILL SMITH STAKES - 1800 metres

RAMPLING (D. Moor) jumped away awkwardly and brushed QUENCH THE THIRST (S. Price).

In the early stages QUENCH THE THIRST (S. Price) was inclined to race keenly.

MOSSEGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : LEUKAEMIA FOUNDATION OF AUSTRALIA HANDICAP - 1100 metres

VINTAGE TRIUMPH (N. Rose) jumped away awkwardly.

On jumping away PELICAN RED (L. Stojakovic) shifted in and brushed ORNAMENTAL (D. Holland).

BLAME GAME (C. Lindop) was obliged to race wide without cover throughout the event.

From the 700 metres ORNNAMENTAL (D. Holland) was inclined to lay out. ORNAMENTAL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

VINTAGE TRIUMPH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : BRIDGESTONE AUSTRALIA HANDICAP - 1200 metres

On jumping away THORNY DEVIL (T. Pannell) rolled in onto EL PRADO GOLD (S. Westover), which was inconvenienced.

On jumping away ZEN (A. Herrmann) was hampered when tightened between JESSICA ROSE (D. Lane), which jumped away awkwardly and shifted in, and MINUTE BY MINUTE (N. Rose), which shifted out.

MINUTE BY MINUTE (N. Rose) raced wide without with cover throughout the event.

From the 200 metres PETMAN (T. Baker) shifted out abruptly. PETMAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. Hyam, the Trainer of PETMAN, was advised a repetition of the gelding's manners may lead to action being taken against it.

T. Baker, the rider of PETMAN, was questioned regarding the use of his whip in a forehand manner prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

BELLA DOLCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : AIR DIFFUSION AGENCIES PTY LTD HANDICAP - 1600 metres

TABULATED (T. Pannell) jumped away awkwardly and shifted in, brushing JEUNEALISTIC (H. McKechnie).

Shortly after the start DOUBLE CREAM (T. Baker) rolled in onto GOLDRIDGE (NZ) (J. Hickmott), which shifted in and contacted SEA CORAL (M. Neilson).

L. Hopwood, the rider of NOTHING SHALL PASS, which raced forward at its previous start, explained her instructions today were to attempt to lead if possible from the good barrier, which were similar to those issued when successful at Strathalbyn to attempt. She stated she had attempted to be positive from the barrier, however, runners to her outside had superior speed and were able to cross NOTHING SHALL PASS quickly denying her the opportunity to fulfil her instructions.

C. Lindop, the rider of OTTANA, reported in her opinion the gelding may not have been suited by the Norton bit added today as it may have affected its breathing. C. Lindop added that she would discuss further experimenting with gear with the gelding's Trainers, Mr. L. Macdonald and Mr. A. Gluyas.

RACE 8 : BLACKBOCKS HANDICAP - 1200 metres

Near the 200 metres, in attempting to improve, CONDELAGO (C. Lindop), which rolled out marginally, brushed with IDALOU (A. Herrmann), which was inclined to lay in.

At the entrance to the straight BOLD LINE (N. Rose), which was inclined to shift about, rolled in and brushed ROWDY ROCKER (L. Hopwood).

In the vicinity of the 900 metres IDALOU (A. Herrmann) shifted in onto ROWDY ROCKER (L. Hopwood), which was obliged to race in restricted room for some distance resulting in ROWDY ROCKER being forced to steady, losing its position. When being restrained ROWDY ROCKER was inclined to get its head up and be ungenerous. A. Herrmann was severely reprimanded and advised in future to ensure she was sufficiently clear before permitting her mounts to shift ground. In arriving at this decision, the Stewards considered that although A. Herrmann had attempted to take measures to relieve the pressure to ROWDY ROCKER, she was prevented from doing so by TROPIC THUNDER taking a legitimate position outside IDALOU.

When questioned regarding his riding of TROPIC THUNDER, particularly in the early stages of the race, S. Westover explained he had been instructed to ride the gelding where it was comfortable and had been alerted that from time to time the gelding could race keenly and be difficult to handle. He stated that after not being well away he had given TROPIC THUNDER a dig in the hope of acquiring a position with cover closer to the lead. He stated that approaching the first turn, as the pace steadied, he realised he could not obtain the position on the back of EXALTED THOMAS and therefore allowed TROPIC THUNDER to stride forward rather than race three wide without cover. Mr. S. Kavanagh, representing Mr. M.A.T. Kavanagh, the Trainer of TROPIC THUNDER, stated he had advised S. Westover the gelding could miss away but emphasised not to be aggressive on the gelding and attempt to keep it balanced. S. Westover was advised in similar circumstances in future he should make a greater effort to comply with instructions provided.

IDALOU suffered a bi-lateral bleeding attack during the race. Mr. T. Dansie, the Trainer of IDALOU, was advised the gelding was now suspended from racing for a period of three months in accordance with ARR.53A.

RACE 9 : YALUMBA HANDICAP - 1200 metres

TOP BILLING (NZ) (T. Baker) and ABOUT ME (T. Baker) jumped away awkwardly.

INTENCION (T. Rodder) raced wide without cover throughout the event. INTENCION was examined by the Club's Veterinary Surgeon who reported a slow recovery

EXALTED LADY lost its off fore plate during the event.
