THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville by the South Australian Jockey Club on Saturday, 22 October 2011

RACE 1: DOMINANT HANDICAP - 1600 metres

As the horses left the mounting yard for this event Mr A Gluyas, Co-Trainer of MAGIC MILADY, informed Stewards that apprentice J Matthews had been instructed, if possible, not to lead the race. The Stewards established the instructions had been provided to apprentice J Matthews at trackwork that morning. When questioned as to his failure to inform Stewards within the timeframe prescribed by the Rules, Mr. Gluyas conceded he had overlooked his obligation. After considering his explanation, Mr. Gluyas was charged with an offence under ARR.135A in that he had failed to provide information as soon as was practical. Mr Gluyas was found guilty and fined \$250.

THORNY DEVIL (T Pannell) jumped away awkwardly and shifted out, brushing HARRY HIGH PANTS (J Frew).

In the vicinity of the 600 metres until the entrance to the straight, THORNY DEVIL (T Pannell) was inclined to lay out. T Pannell was questioned regarding his use of the whip in the vicinity of the 500 metres. After considering his explanation T Pannell was charged with an offence under ARR.137A(4)(a) in that he had used his whip forward of the shoulder. T Pannell was found guilty and fined \$100.

WORLD DOMINATION and ZERRPRISE US ALL were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

THORNY DEVIL was examined by the Club's Veterinary Surgeon who reported the gelding had sustained a small lesion to the upper offside lip.

RACE 2 : ADELAIDE CASINO HANDICAP - 2050 metres

Approaching the 400 metres, when attempting to improve, SILENT SURROUND (S Westover) shifted out and contacted SEAN BAILE MOR (J Frew), which was inconvenienced when taken wider. Stewards cautioned S Westover against riding in such an aggressive manner in the future.

RACE 2: ADELAIDE CASINO HANDICAP - 2050 metres (continued)

SILENT SURROUND was examined by the Club's Veterinary Surgeon who reported the mare had a higher than expected heart rate.

EVEN MORE ACTION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Subsequent to the event the Club's Veterinary Surgeon reported SEAN BAILE MOR had evidence of blood in its offside nostril. Mr. T Balfour, the Trainer of SEAN BAILE MOR, was advised that in accord with ARR.53A(7) the mare would be required to gallop 1000 metres to the Stewards' satisfaction prior to presenting for a future trial or race. The Stewards also ordered a post race blood sample be taken from SEAN BAILE MOR for the purpose of TCO₂ testing.

Following this event at 1.10 pm, the Stewards reclassified the track to a Good 3.

RACE 3: ACG SECURITY HANDICAP - 1100 metres

In the early and middle stages of the event IMPERIAL FURY (J Potter) was inclined to get its head up and race ungenerously.

Inside the 300 metres GONSKI GIRL (J Frew) was obliged to ease and alter course away from the heels of JULIET'S PRINCESS (USA) (J Matthews) as a result of that mare being taken out by SISTER SWIFT (L Hopwood).

Inside the 100 metres ASHEERAH (N Rose) rolled in marginally onto JULIET'S PRINCESS (USA) (J Matthews), which, whilst attempting to improve outside IMPERIAL FURY (J Potter), was struck by that rider's whip.

RACE 4 : SPORTINGBET HANDICAP - 1600 metres

On jumping away RIGHT FONG (S Westover) shifted out and brushed EVEN ADAM (N Rose).

GOLD SAND (R Wheeler) jumped away awkwardly and shifted out onto CYBERCYN (J Frew), which was inconvenienced.

In the straight, GOLD SAND (R Wheeler) laid out under pressure. R Wheeler reported the gelding was inclined to lay out throughout the event.

S Cahill, the rider of RIALYA, was in advised in future to ride his mounts to the finish in accordance to the Rules. RIALYA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: THE JUNCTION \$59 MELB CUP DAY LUNCH - 1500 metres

ANDRONICA was required to be re-saddled at the barriers.

On arrival at the barriers GRAND TITLE was examined by the Club's Veterinary Surgeon and ruled fit to start.

On jumping away DAILY FLYER (S Price) and CLEARLY PASSIONATE (A Patterson) made contact, which inconvenienced CLEARLY PASSIONATE.

In the early stages SHIMANO MISS (NZ) (J Potter) was inclined to race keenly.

RACE 5: THE JUNCTION \$59 MELB CUP DAY LUNCH - 1500 metres (continued)

In the vicinity of the 1200 metres SHIMANO MISS (NZ) (J Potter), which continued to race keenly, was obliged to steady away from the heels of CLEARLY PASSIONATE (A Patterson), which shifted in.

When questioned regarding his riding of CLASSIC CAMEO from the 600 metres, N Rose explained he had been instructed to attempt to ride the mare in a similar manner to its start at Morphettville in which it was ridden forward. N Rose stated that in contrast to that run CLASSIC CAMEO had not begun as well and as a consequence he had elected to attempt to slot in and ride the mare quietly. He stated that inside the 700 metres he had considered improving under TOP BILLING (NZ) (S Westover) as that mare improved, however, had resisted due to concern he would expose CLASSIC CAMEO sooner than the Trainer would prefer. From the entrance to the straight he said he had difficulty in obtaining clear running and his options were restricted due to the position of TABULATED to his outside. N Rose was advised his explanation would be reported.

RACE 6: LACHLAN HARRIS HANDICAP - 1500 metres

UNSER and PENZEVENGI were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: MORPHETT ARMS HOTEL HANDICAP - 1800 metres

Mr K Healy, the Trainer of EIGHT RED, advised Stewards that from the outside barrier, depending in how the gelding began, he would instruct jockey J Potter to attempt to settle EIGHT RED off the pace if possible with cover rather than race forward as has been its usual pattern.

Shortly after the start RIKBAT (A Herrmann) was awkward for several strides when racing between MASTER BECKETT (N Rose) and BELLUNESE (S Price), which was inclined to lay out.

At the entrance to the straight DIVINE BEING (L Hopwood) was obliged to ease away from the heels of EIGHT RED (J. Potter), which rolled out as it commenced to give ground.

RACE 8: FLIGHT CENTRE TWILIGHT DEC 16 HANDICAP - 1200 metres

AUDACITY (S Price) jumped away awkwardly and shifted in onto GUMNUTS (A Herrmann), which was inconvenienced when tightened onto STARALAN (S Westover), as that gelding rolled out.

Inside the 700 metres FAST FRANK (J Maund) shifted in brushing BLAME GAME (J Matthews).

HORATIUS and EXALTED BEAUTY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 9: MELB CUP DAY AT MORPHETTVILLE NOV 1 HANDICAP - 1100 metres

VALOROSO (S Price) jumped away awkwardly.

MR GOOD CAT lost its off fore plate during the event.

GENERAL:

RACE 7: MORPHETT ARMS HOTEL HANDICAP - 1800 metres

Mr. S. Turner, the Trainer of FRAACLASE, was questioned regarding a lead bag being omitted from the gear when being saddled. The discovery was made by the Assistant Starter as FRAACLASE entered the parade ring. Mr. Turner was charged with an offence under Rule ARR.140A in that he was careless in saddling FRAACLASE. He pleaded guilty and was fined \$200.
