RACE 1 : BARRETT DISTRIBUTORS / SABOIS MAIDEN PLATE - 1100 metres

As no other rider was available, Apprentice S. Westover was granted permission to ride CENTRE LEFT half a kilogram overweight.

OLLY I AM was a late scratching at 1.10 pm by order of Stewards as T. Pannell was dislodged on leaving the mounting enclosure. OLLY I AM galloped for a substantial distance and collided with fencing prior to being recaptured. T Pannell was uninjured in the incident. OLLY I AM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. L Farrugia, the Trainer of OLLY I AM, was advised the horse would be required to complete an Official Barrier Trial prior to accepting for a future race.

TEARAWAY BELL (C. Puls) stood flat footed at the start and as a result was very slow to begin. Mr S. Turner, the Trainer of TEARAWAY BELLE, was advised a warning had been placed on this filly.

CENTRE LEFT (S. Westover) was slow to begin.

MISS FAMECHON (A. Herrmann) was inclined to race greenly throughout the event.

For a short distance from the 800 metres COSTLY ARGUMENT (J. Potter) was inclined to race ungenerously.

Racing to the 500 metres MISS FAMECHON (A. Herrmann), which was racing greenly, brushed SILKEN THREAD (J. Maund).

Correct Weight for this event was delayed to allow J. Maund, rider of the second placegetter SILKEN THREAD, to view the official photo image for first.

RACE 2 : THIRSTY CAMEL / SABOIS MAIDEN PLATE - 1300 metres

ARISTARKAS (S. Harrison) was slow to begin.

In the straight DUBLEO FIVE (P. Marks) was inclined to lay in under pressure.

RACE 2 : THIRSTY CAMEL / SABOIS MAIDEN PLATE - 1300 metres (Cont'd)

T. Pannell, the rider of WARMONGER, which performed below expectations, explained the gelding jumped away fairly and travelled well in the early and middle stages of the event. He stated that racing from the 800 metres to the 600 metres, he was unable to keep in contact with the leaders and hold his position. He said from the 600 metres WARMONGER began to improve but shortly after entering the home straight he was forced to ride aggressively and despite his riding was unable to hold his position. He added that WARMONGER was inclined to change his lead leg rounding the home turn. WARMONGER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : XXXX GOLD / SABOIS FILLIES & MARES RATING 0-65 HANDICAP – 1200 metres

DANISH QUEEN (A. Herrmann) was slow to begin.

OLIVIA LASS (K. Bishop) jumped away awkwardly and shifted out, brushing with DIAMONDCONI (J. Potter).

RACE 4 : COCO-COLA RATING 0-65 HANDICAP - 1900 metres

BIRCHMORE ROAD (J. Potter) stood flat footed and missed the start approximately three lengths.

Shortly after the start DOUBLE CREAM (J. Matthews) shifted in and away from SCOOP THE LOT (C. Puls) and as a consequence brushed MY EX MATE (S. Cahill).

In the early and middle stages of the event MUSEE MARKET (A. Patterson) was inclined to race ungenerously.

RACE 5 : WOOLSHED INN HOTEL MOTEL RATING 64+ HANDICAP - 1200 metres

NEW AUSTRALIAN (M. Munday) was slow to begin.

CHANGING EYES (J. Maund) jumped away awkwardly and shifted out, taking LOLLY RAIN (C. Puls), BOLD LINE (A. Patterson) and ALMOST CHEVAL (J. Frew) wider on the track.

Racing from the 500 metres to the 400 metres, ACE OR JOKA (J. Matthews) was held up for clear running on the heels of CIRO PRINCE (S. Cahill).

From the entrance to the straight until the 100 metres ACE OR JOKA (J. Matthews) was held up for clear running behind ALMOST CHEVAL (J. Frew).

ACE OR JOKA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

<u>RACE 6 : WISE FORD – WISE FARM EQUIPMENT RATING 0-59 HANDICAP</u> - 1100 metres

IMPERIAL RAIN (J. Frew) jumped away awkwardly and shifted out, taking STRAIGHT AS (J. Matthews) and BRAVE AS (M. Munday) wider on the track.

OUR DESTINATION (T. Zanker) raced ungenerously in the early and middle stages of the event.

<u>RACE 6 : WISE FORD – WISE FARM EQUIPMENT RATING 0-59 HANDICAP</u> – 1100 metres (Cont'd)

Approaching the 150 metres OURHALO (K. Post) and HE'S A HOUNDOG (A. Herrmann) bumped when OURHALO rolled in under pressure.

Inside the 150 metres HE'S A HOUNDOG (A. Herrmann), when racing tight to the outside of FLOWER FORCE (J. Potter), had to momentarily steady when FLOWER FORCE rolled out, resulting in HE'S A HOUNDOG being taken out, brushing OURHALO (K. Post). J. Potter was reprimanded under ARR.137(a) in that he allowed his mount to shift ground when insufficiently clear.

Correct Weight for this event was delayed owing to A. Herrmann, the rider of the second placegetter HE'S A HOUNDOG, lodging an objection against FLOWER FORCE (J. Potter), being declared the winner on the grounds of alleged interference near the 150 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* A. Herrmann's objection.

IMPERIAL RAIN, which performed poorly, was examined by the Club's Veterinary Surgeon, who reported the gelding to be lame in the off foreleg. Mr R. Moore, the Trainer of IMPERIAL RAIN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 7 : BORDERTOWN HARDWARE RATING 0-65 HANDICAP - 1300 metres

TEE EN TEE (A. Patterson) and SWIPER (P. Marks) were slow to begin.

Racing to the 400 metres SWIPER (P. Marks) was held up between the heels of KELVOLI (A. Herrmann) and ARTECHS (T. Zanker).

In the straight ARTECHS was inclined to lay in under pressure.
