RACE 1: REAL PROPERY MATTERS MAIDEN PLATE - 1050 metres

COTTON ROAD (P. Gatt) was slow to begin.

FERRARI RED (C. Lions) raced ungenerously in the early and middle stages of the event whilst being restrained.

In the vicinity of the 200 metres ALCOHOL (L. Hopwood) rolled in onto SHAABAM (T. Pannell), which had to ease momentarily.

From the 200 metres until the finish DOOHAN (S. Westover) laid in under pressure. DOOHAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HINT OF EGO was examined by the Club's Veterinary Surgeon who reported a minor laceration to the near fore fetlock.

COTTON ROAD lost its off hind plate during the event.

RACE 2: DRAKE SUPERMARKETS MAIDEN PLATE - 1050 metres

On arrival at the barriers EVE'S DELIGHT was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Acting on this advice, Stewards withdrew EVE'S DELIGHT at 12.52 pm.

Mr. D. Balfour, the Trainer of TIGERLANI, which proved difficult to load, was advised a warning had been placed on the filly and should it prove difficult to load in future, action may be taken against it.

On jumping away TIGERLANI (T. Pannell) and SHEZA TEASE (J. Matthews) came together and brushed.

P. Gatt, the rider of LIVE IN BLACK, reported the filly never travelled throughout the event and after being placed under pressure early in the straight, had failed to respond to his riding and in the vicinity of the 300 metres he had eased the filly from the event as he became concerned with its action. LIVE IN BLACK was examined by the Club's Veterinary Surgeon who reported the filly was lame in both hind legs. Mr. L. Kennewell, Trainer of LIVE IN BLACK was advised that a Veterinary Certificate of Fitness would be required prior to accepting for future trial or race.

RACE 3: ANGELAKIS BROS HANDICAP - 1050 metres

Stewards received a submission from Mr. S. Kavanagh, representing Mr. M.A.T. Kavanagh, the Trainer of ZIGGY'S CROWN, that Apprentice M. Speers be replaced by a senior rider. After considering his explanation, Stewards denied the request and advised Mr. Kavanagh that ZIGGY'S CROWN would be required to be ridden by an Apprentice jockey. Mr. Kavanagh then put a submission to Stewards that in the stable's opinion, none of the available Apprentice riders were suitable and they wished to scratch the horse. Stewards acceded to this request and withdrew ZIGGY'S CROWN at 11.20 am.

Mr. B. Dunn, the Trainer of ALWAYS FOCUS, which proved fractious in the barriers after being loaded, was advised a warning had been placed on the mare and should it perform in a similar manner in future, action may be taken against it.

ALWAYS FOCUS (J. Potter) jumped away awkwardly and shifted out abruptly onto THREE STAR GENERAL (N. Rose), which was hampered and forced to lose its position when tightened onto EXOCET EDDY (S. Price).

HEROICA (J. Matthews) jumped away awkwardly.

SILENT FAITH (C. Lions) was inclined to rear on jumping away.

L. Hopwood, the rider of OUR LITTLETREASURE, reported the mare was inclined to lay out under pressure in the straight. OUR LITTLETREASURE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: 1300 AUSTRALIA HANDICAP - 1800 metres

Acting on confirmed advice from Mr. T. Vasil, the Trainer of KINGDOM OF WAR, that the colt was showing symptoms of colic and was unfit to race, Stewards withdrew KINGDOM OF WAR at 9.20 am.

SALVATION (N. Rose) stood flat footed and was slow to begin.

RACE 4: 1300 AUSTRALIA HANDICAP - 1800 metres (Cont'd)

In the vicinity of the 500 metres DIVINE BEING (M. Pegus) shifted out onto ROYAL IMPULSE (J. Potter) which was forced to steady to avoid that gelding's heels. M. Pegus was severely reprimanded and advised in future to only shift ground when entitled to do so.

At the entrance to the straight ROYAL IMPULSE (J. Potter) had to take hold when tightened between the heels of SOPHIELICIOUS (A. Patterson), which shifted out slightly, at the same time as DIVINE BEING (M. Pegus) shifted in slightly.

RACE 5: DIRECT INTERIORS MAIDEN PLATE - 1600 metres

STAR ON BROADWAY (N. Rose) jumped away awkwardly.

From the vicinity of the 400 metres until approaching the 200 metres FANTASTIC REIGN (A. Patterson) became held up when racing on the heels of OL' SLAMMER (J. Matthews) which had commenced to give ground. In consequence BLEVIC LAD (S. Westover), which was racing on the heels of FANTASTIC REIGN (A. Patterson), was held up from the vicinity of the 400 metres until near the 300 metres.

From the vicinity of the 400 metres until the vicinity of the 300 metres, WAR HAWK (M. Pegus) was held up when awkwardly placed between the heels of HOLY SHEMOLEY (J. Potter) and STAR ON BROADWAY (N. Rose).

FOSSICKING (P. Gatt) was held up from the vicinity of the 400 metres until the entrance to the straight when racing on the heels of HOLY SHEMOLY (J. Potter) and inside of MEADOWS MOLLIE (L. Hopwood).

T. Baker rider of HEAVENSAKE reported to Stewards that the gelding had lost its action and ground in the vicinity of the 900 metres and from this point on had not travelled and he was disappointed with how it had finished off its race. HEAVENSAKE was examined by the Club's Veterinary Surgeon who reported it was lame in the near hind. Mr. J. Hyam, the Trainer of HEAVENSAKE was advised that a Veterinary Certificate of Fitness would be required prior to accepting for future trial or race.

RACE 6: COMMERCIAL AIR SERVICES MAIDEN PLATE - 1200 metres

MESHMAKER (J. Matthews) shifted out on jumping away and contacted MYKONOS SUNSET (P. Gatt).

On jumping away SOCIAL GAZE (S. Price) shifted in taking MOSSE DIVA (N. Rose) in onto TRUTHS (T. Baker) which had to be steadied off the heels of MYKONOS SUNSET (P. Gatt) and lost its position.

From the vicinity of the 800 metres until near the 600 metres SOCIALGAZE (S. Price) raced keenly whilst being restrained off the heels of ROLLING STONES (J. Maund).

In the vicinity of the 500 metres MOSSE DIVA (N. Rose) shifted out to improve and in doing so contacted DJETICH (L. Stojakovic) which was inconvenienced.

Approaching the 300 metres DJETICH (L. Stojakovic) was momentarily held up on the heels of VIVA LA RANGA (J. Potter) and in attempting to obtain clear ground, shifted out abruptly to the outside of MOSSE DIVA (N. Rose) which shifted in.

RACE 6: COMMERCIAL AIR SERVICES MAIDEN PLATE - 1200 metres (Cont'd)

Approaching the 200 metres MESHMAKER (J. Matthews) shifted to the outside of the heels of PARMIGIANA (A. Herrmann) in an attempt to obtain clear ground and in doing so contacted ROLLING STONES (J. Maund) which became unbalanced. J. Matthews was reprimanded and advised in future to ensure there was sufficient room prior to attempting runs.

ROLLING STONES lost its off hind plate during the running of the event.

QUARTERDECK, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MOSSE DIVA, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: UNITY GROUP HANDICAP - 1200 metres

Mr. M. Hickmott, Trainer of ALWAYS DISCREET, advised Stewards that he would instruct L. Hopwood not to lead if possible in this event due to the apparent pace in the event.

On jumping away VONROB (S. Price) and INVINCIBLE DIVA (J. Matthews) came together and bumped.

On jumping away DARK DIVA (NZ) (T. Baker) and FABULIST (NZ) (M. Pegus) came together and brushed.

N. Rose, rider of MOUNTAIN CAT which performed poorly, explained that shortly after entering the straight the mare had shortened its stride and he had become concerned with its action and for this reason had not ridden MOUNTAIN CAT out in his usual manner over the concluding 200 metres. MOUNTAIN CAT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

EXALTED LADY lost its near fore plate during of the event.

RACE 8: GUARDIAN INSURANCE BROKERS HANDICAP - 1600 metres

RESENDA (T. Baker) stood flat footed and missed the start losing many lengths.

D. Evans, rider of WEE MATE, reported that gelding was inclined to lay out throughout the event until the final 100 metres where it commenced to lay in. WEE MATE had left the course prior to being examined by the Club's Veterinary Surgeon. Trainer, Mr. L. Jarvis, advised Stewards that there were no abnormalities with the horse on return to its stables.

RACE 9: TRENCHLESS PIPELAYING HANDICAP - 1200 metres

Mr. M. Hickmott, Trainer of MISSIONARY MAN, advised Stewards that he would instruct the rider, M. Pegus to settle more forward than it has at previous starts today, if possible.

N. Rose, rider of NICODORA, reported that the gelding had travelled well during the event however when placed under pressure in the vicinity of the 600 metres, had failed to respond to his riding and, in his opinion, had finished its race off poorly. NICODORA was examined by the Club's Veterinary Surgeon who reported a slower than expected recovery.

RACE 9: TRENCHLESS PIPELAYING HANDICAP - 1200 metres (Cont'd)

- T. Baker, rider of LAGO AZZURRO, reported that he was concerned with that gelding's action in the straight and it pulled up with excess respiratory noise. LAGO AZZURRO was examined by the Club's Veterinary Surgeon who reported had a abnormal upper respiratory noise. Trainer, Mr. J. Hyam, was advised that the results of a laryngoscopic exam would be required to be forwarded to the TRSA Veterinary Surgeon prior to accepting for future trial or race.
- S. Westover, rider of ORNAMENTAL, reported that he was concerned with that mare's action over the concluding 200 metres and for this reason had not ridden the mare out in his usual manner. ORNAMENTAL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Price, rider of TUSCAN BREEZE, reported that, in his opinion, the gelding may have been feeling its feet. TUSCAN BREEZE had left the course prior to being examined by the Club's Veterinary Surgeon. Trainer, Mr. S. Brown, advised Stewards that there were no abnormalities with the horse on return to its stables.

SECRET VINTAGE (J. Matthews), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
