RAIL: Out 0.5 metres from the 1000 metres to the home turn and 2 metres from the home turn to the winning post. True for the remainder.

RACE 1 : REVOLUTION ROOFING RATING 0-68 HANDICAP - 1750 metres

In the early stages of the event TARVON (A. Herrmann) was inclined to pull hard.

Near the 200 metres WORLD RULER (J. Potter) had to shift wider on the track to improve around the heels of VOLATION (M. Hoppo) resulting in WORLD RULER having to momentarily steady off the heels of HE'S HOT TO TROT (A. Patterson).

Correct Weight was delayed to allow J. Potter, rider of the second placegetter WORLD RULER, to view the official vision.

RACE 2 : COMPLETE BUSINESS & ACCOUNTING SERVICES / SABOIS MAIDEN PLATE
- 1250 metres

RED WRAPPER (L. Cribbin) jumped away awkwardly resulting in the gelding being reluctant to race throughout the event. RED WRAPPER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. D. Carrison, Trainer of RED WRAPPER, was advised the horse would be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to accepting for a future race.

In the early and middle stages of the event, EXCEL WITH PRIDE (N. Rose) was inclined to race ungenerously.

Near the 1200 metre MOONTA BAY (W. Kerford) and CURRASILLA (A. Patterson) brushed on a number of occasions resulting in MOONTA BAY being placed awkwardly on the heels of REAL GLAMOUR (T. Zanker) resulting in MOONTA BAY clipping heels. At the same time REAL GLAMOUR was being taken in by AKAVARDO (M. Hoppo). M. Hoppo was reminded of his obligations when shifting ground in future.

RACE 3 : JET WAVE / SABOIS 3YO RATING 0-61 HANDICAP - 1200 metres

On jumping away, MEGA QUEEN (M. Hoppo) was inconvenienced when tightened for room between GYRO (T. Baker) which jumped away awkwardly and shifted out, and SOVEREIGN DANCER (L. Cribbin), which jumped away awkwardly and shifted in.

MEMORY COVE (W. Kerford) jumped away awkwardly and brushed with MISS HARREB (J. Potter).

Racing to the 1000 metres MISS HARREB (J. Potter), when racing ungenerously, had to steady off the heels of MEMORY COVE (W. Kerford).

On the home turn MISS HARREB (J. Potter), shifted out under pressure onto SOVEREIGN DANCER (L. Cribbin), which was forced to steady. J Potter was severely reprimanded under ARR.137(a) in that he had allowed his mount to shift ground when insufficiently clear.

Racing near the 300 metres MIGHTY MOMENT (P. Roff) and SOVEREIGN DANCER (L. Cribbin) brushed on a number of occasions.

EXCEL WITH PRIDE was reluctant to race throughout the event. EXCEL WITH PRIDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T. Trenowden, Trainer of EXCEL WITH PRIDE, was advised the horse would be required to complete an Official Barrier Trial to the satisfaction of stewards prior to accepting for a future race.

RACE 4 : SHILLABEER CRANES CLASS 2 HANDICAP - 1350 metres

MASTER PICKLES (W. Kerford) stood flat footed and missed the start several lengths.

In the early and middle stages of the event TROBEN (A. Herrmann) was inclined to race ungenerously.

In the home straight HUNTED ANGEL (L. Stojakovic) was inclined to lay in under pressure.

HUNTED ANGEL was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both fore legs. Mr. C. Hanson, the Trainer of HUNTED ANGEL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

VEKASHA who performed bellow expectations was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T. Haddy, the trainer of VEKASHA was advised a warning had been placed on this mare's racing performance.

RACE 5 : CLASSIC ELEGANCE / SABOIS F&M RATING 0-68 HANDICAP - 1250 metres

ARTFUL TERRA (N. Rose), SKYELILLY MISS (M. Hoppo) and FIRER ME (T. Zanker) were slow to begin.

Racing to the 100 metres STRANGMEAD (T. Baker), which was reluctant to improve between WALTZING MATILDA (A. Patterson) and SKYELILLY MISS (M. Hoppo) was momentarily steadied in order to alter course to attempt a run inside WALTZING MATILDA.

RACE 6 : PURCELL RATING 60+ HANDICAP - 1200 metres

POLDA ROCK (L. Cribbin) jumped away awkwardly and as a result was very slow to begin.

FIGHTING FURY (T. Baker) jumped away awkwardly brushing with SUPER HIT (L. Stojakovic).

RACE 6 : PURCELL RATING 60+ HANDICAP - 1200 metres (Cont'd)

Approaching the finish WORTH THE EFFORT (J. Potter) was accidently struck with the whip from P. Roff (ACHENAR).

Correct Weight was delayed to allow J. Potter, rider of the second placegetter WORTH THE EFFORT, to view the official films.

RACE 7 : EUROPCAR RATING 0-68 HANDICAP - 1000 metres

On arrival at the barriers TAKOOKACHOOK was examined by the Club's Veterinary Surgeon who ruled the gelding to be lame in the nearside knee. Acting on that advice TAKOOKACHOOK was withdrawn at 4.51 pm by order of Stewards. Mr. D. Carrison, Trainer of TAKOOKACHOOK was advised that a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

On jumping away FINAL DYNASTY (P. Roff) was inconvenienced and lost its position when tightened for room between CHIEVO VERONA (N. Rose) which jumped away awkwardly and shifted out, and MISS ELIZA (M. Neilson) which jumped away awkwardly and shifted in.

HOOLIGAN (W. Kerford) was slow to begin.

ZIPAROO (L. Cribbin) jumped away awkwardly and as a result was slow to begin.

Near the 200 metres MISS ELIZA (M. Neilson) rolled in under pressure momentarily inconveniencing BIG SAI WAN (M. Hoppo).

RACE 8 : YALUMBA C,G&E RATING 0-61 HANDICAP - 1200 metres

CARDHU MALT, which had become fractious in the barriers , was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, CARDHU MALT was withdrawn at 5.32 pm by order of Stewards. Mr. M Whittle, the Trainer of CARDHU MALT, was advised a warning had been placed on the gelding.

From the 200 metres to the winning post BLACK WHISKEY (J. Potter) was unable to obtain clear ground and was untested running to the finish.

N. Rose reported that his mount, SAVAGE MONKEY, was inclined to lay in rounding the home turn and in the home straight.
