Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Thursday, 3 November 2011

RACE 1 : GAWLER SOUTH BAKERY / SABOIS DISTANCE MAIDEN PLATE - 2100 metres

On arrival at the start KING ROSELAND, which struck a fence en route to the barriers, was examined by the Club's Veterinary Surgeon and was ruled fit to race.

On jumping away DELZARGO (A. Patterson) shifted out slightly onto RADMILA (S. Price) and was taken back in making heavy contact with BUDZEAL (D. Evans), which was hampered when tightened onto UMAMOX (W. Kerford).

Approaching the winning post on the first occasion BUDZEAL (D. Evans), which was racing keenly, shifted out onto DELZARGO (A. Patterson), which had to be steadied. D. Evans was reprimanded and advised in future he would be required to make a greater effort to restrain his mounts in similar circumstances.

AUSSIE BLUE (P. Gatt) raced keenly in the early and middle stages of the event.

KING ROSELAND (J. Potter) laid out under pressure in the straight.

D. Evans, the rider of BUDZEAL, reported the gelding raced keenly throughout the event.

KING ROSELAND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

UMAMOX, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : MAIN ST BAKEHOUSE CLARE RATING 0-62 HANDICAP - 2100 metres

On jumping away HIDDEN TEARS (W. Kerford) shifted out and brushed ETON HALL (J. Matthews).

RACE 2 : MAIN ST BAKEHOUSE CLARE RATING 0-62 HANDICAP - 2100 metres (Cont'd)

J. Maund, the rider of ARAZAMATAZ, reported the gelding had settled well during the run, however, after placing ARAZAMATAZ under pressure in the vicinity of the 800 metres, it failed to respond to his riding and by the vicinity of the 600 metres commenced to weaken and he was disappointed with how it had finished off the event. ARAZAMATAZ was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

J. Potter, the rider of FAINEANT, reported the gelding made the turn in the vicinity of the 600 metres awkwardly and shifted wider on the track.

J. Matthews, the rider of ETON HALL, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3 : WESTON MILLING / SABOIS MAIDEN PLATE - 1100 metres

STAR LEGION (W. Kerford) jumped away awkwardly and shifted out brushing RULING DOUBT (J. Potter).

STRATA XAAR (J. Maund) and OUR SENTIMENT (D. Tootell) came together and brushed on jumping away.

NO HITTER (A. Herrmann) jumped away awkwardly.

From the vicinity of the 600 metres until the entrance to the straight MR SECURITY (L. Stojakovic) was held up when racing on the heels of CANNY PREVAIL (J. Matthews) and inside of INDEPENDENT AIR (S. Price).

In the vicinity of the 200 metres DE VIGNERON (S. Cahill) shifted out to improve and in doing so brushed MR LA RUE (M. Hoppo).

When questioned regarding the apparent improved performance of CANNY PREVAIL, Mr. G. Searle, the Trainer of the gelding, explained CANNY PREVAIL had returned to his stable after having two runs with another Trainer and in his opinion had worked no differently than it had previously when in his care. He added he had added blinkers and a tongue tie for this run as in his opinion that gear resulted in the gelding performing best when previously in his care.

OUR SENTIMENT, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RULING DOUBT suffered a bi-lateral bleeding attack during the event. Mr. C. Bromley, the Trainer of RULING DOUBT, was advised the gelding was now suspended from racing for a period of three months in accordance with ARR.53A.

RACE 4 : GAWLER SOUTH BAKERY / SABOIS MARES MAIDEN PLATE - 1200 metres

The start of this race was delayed approximately five minutes initially owing to LADY SONRO, which was fractious in the mounting enclosure, rearing over and dislodging its rider T. Zanker. LADY SONRO continued to be fractious when T. Zanker attempted to remount. Mr. P. Moody, the Trainer of LADY SONRO, put a submission to Stewards that the mare be scratched as it had, in his opinion, a significant amount of blood in its mouth and had lost its composure. Stewards acceded to this request and withdrew LADY SONRO at 3.19 pm. Mr. P. Moody was advised a warning had been placed on LADY SONRO in relation to it being fractious in the mounting enclosure.

<u>RACE 4 : GAWLER SOUTH BAKERY / SABOIS MARES MAIDEN PLATE</u> - 1200 metres (Cont'd)

En route to the start, PAM ANN, which was reluctant to travel to the barriers, dislodged its rider T. Baker. PAM ANN was lead to the barriers by the Clerk of the Course. On arrival at the start PAM ANN was examined by the Club's Veterinary Surgeon and ruled fit to start. PAM ANN was then reluctant to approach the barrier stalls. Ms. R. Hodson, the Trainer of PAM ANN, was advised the mare would be required to travel to the barriers satisfactorily and load without delay in an Official Trial prior to accepting for a future race.

MADAM KAFOOPS was reluctant to proceed to the barriers. Mr. P. Cole, the Trainer of MADAM KAFOOPS, was advised a warning had been placed on the mare in relation to its manners.

BURSWOOD (D. Tootell), proved difficult to load. Miss A. Chapman, the Trainer of BURSWOOD, was advised a warning had been placed on the mare.

KUITPO DANCER (S. Cahill) shifted out jumping away and brushed REGIFTED (S. Price).

BURSWOOD (D. Tootell) raced wide without cover throughout the event.

From the vicinity of the 400 metres until the entrance to the straight MISS FABULEUX (P. Gatt) was held up when racing behind DESERT TALES (J. Maund).

MADAM KAFOOPS (S. Westover) raced in restricted room over the concluding 100 metres when awkwardly positioned inside DESERT TALES (J. Maund), which rolled in slightly.

BURSWOOD, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following this race, the Judge Mr. C. Kutcher, reported to Stewards that the photo finish camera had malfunctioned. The Judge semaphored the numbers as he and his assistant had recorded them over the line.

Correct Weight was delayed when T. Pannell, the rider of the fourth placegetter ATTITUDE PROBLEM, requested to view the photo. After Stewards explained the situation to T. Pannell, he requested to view the Sky Channel vision of the finish and confirmed his placing.

RACE 5 : ADELAIDE MOBILE LUNCH SERVICE CLASS 2 HANDICAP - 1200 metres

MORNIN' SAM (J. Matthews) and GREYBROW (S. Price) came together and brushed on jumping away.

In the vicinity of the 400 metres T. Baker, the rider of JEULUNA, accidentally dropped his whip. T. Baker was reprimanded and advised that future carelessness may result in a penalty being imposed.

J. Potter, the rider of FLOWER FORCE, explained he was instructed to lead on the mare, however, he was unable to comply with this request despite his efforts and in his opinion FLOWER FORCE was not comfortable racing behind other horses. He added that he put the mare under pressure from the vicinity of the 600 metres and it only responded moderately to his efforts. FLOWER FORCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GLENN'S WAY, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : KERRY PINNACLE MARES 0-81 HANDICAP - 1500 metres

DIAMONDCONI (W. Kerford) raced keenly in the early and middle stages of the event.

RACE 7 : GAWLER SOUTH BAKERY CLASS 1 HANDICAP - 1500 metres

TYPHOONGEORGE (J. Maund) was slow to begin.

MASTRO ANTONIO (D. Evans) over-raced in early and middle stages of the event.

In the vicinity of the 500 metres MASTRO ANTONIO (D. Evans) shifted out to improve and in doing so contacted ALICE LONGING (A. Patterson), which was inconvenienced when taken wider on the track. D. Evans was reprimanded and advised in future he would be required to make an assessment to determine if he was clear prior to commencing to shift ground.

ALICE LONGING (A. Patterson) was inclined to lay in under pressure in the straight. ALICE LONGING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
