RACE 1 – CEDUNA PHARMACY / SABOIS MAIDEN PLATE – 1000 metres

Prior to the start of this race being effected, the barriers malfunctioned resulting in the Starter activating the false start.

Stewards declared the event a no-race. All monies invested were ordered to be refunded.

All horses were examined by the Club's Veterinary Surgeon. GYRO, which was declared lame in front and STAR MOON, which was declared lame in the near foreleg, were declared unfit to race. Acting on this advice, Stewards withdrew these horses at 3.00pm.

The Trainers of all other runners were provided with the opportunity to withdraw their horses without penalty.

Mr. T. Trenowden, the Trainer of JET FUSION and KONOWALCHUK made representation that his runners be scratched as he believed it would be of no benefit for them to race again. Stewards acceded to his request and withdrew JET FUSION and KONOWALCHUK at 2.45pm.

Race 1 was re-run at 4.15pm and fresh betting was conducted.

ALASTAR (M. Neve) stood flat footed when the gates were released.

MUMAJET (P. Roff) jumped away awkwardly.

P. Roff, the rider of MUMAJET, reported the gelding hung out severely throughout the event. MUMAJET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 – PHILL STEVENS & ASSOCIATES / PRESCOTT SECURITIES – 0-68
HANDICAP – 1000 metres**

CLEAR AZ MUD (M. Henderson) and HOOLIGAN (B. Hoppo) brushed on jumping away.

On entering the straight ZIPAROO (L. Cribbin) raced very wide.

MASTER PICKLES (D. Evans) laid in under pressure in the straight.

B. Hoppo, the rider of HOOLIGAN, reported that gelding had hung in in the straight. HOOLIGAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 – CEDUNA HOME TIMBER & HARDWARE RATING 0-59 HANDICAP
– 1200 metres**

Throughout the event, NORTHSIDE STAR (M. Neve) raced very wide without cover.

RACE 4 – CEDUNA FOODLAND CHRISTMAS RATING 0-77 HANDICAP – 1300 metres

ROLL ON ROYCE (K. Bishop) was slow into stride.

Rounding the home turn, FIRER ME (M. Tyndall) raced very wide.

FIGHTING FURY (L. Cribbin) laid in under pressure.

In the vicinity of the 100 metres ROLL ON ROYCE (K. Bishop) was tightened momentarily when JACKIE'S PAPER (B. Hoppo) rolled in slightly.

B. Hoppo, the rider of JACKIE'S PAPER, reported his mount was difficult to steer throughout the event. JACKIE'S PAPER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

K. Dyson, the rider of DOUBLE COVER reported the gelding had contacted the back of the barrier stall before jumping away. DOUBLE COVER was examined by the Club's Veterinary Surgeon who reported a superficial laceration to the near hind leg. First aid was administered.

RACE 5 – GYPSUM RESOURCES AUSTRALIA RATING 0-59 HANDICAP – 1600 metres

BRACKEN BLUE (L. Cribbin) was inclined to rear when the gates were released, resulting in the gelding being slow into stride.

Correct weight for this event was delayed to allow P. Roff, the rider of the fourth place getter, STREET RELATED to view the official photograph for third place.
