### RACE 1: MAGIC MILLIONS / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1000 metres

DEBEERSONUS (B. Hoppo) and MR KARGER (W. Kerford) were slow to begin.

ROAD TO DANTREE (M. Neve) was inconvenienced when tightened for room between RIFF RAFF (M. Henderson), which jumped away awkwardly and shifted in, and HOST WITH THE MOST (B. Carlile), which jumped away awkwardly and shifted out.

JUST PURE FUN (T. Zanker) jumped away awkwardly and soon after the start began to buck for a short distance and dislodged its rider. T. Zanker was examined by the on course Ambulance personnel and passed fit to fulfil her remaining riding engagements. Mr. S. Drewitt, the Trainer of JUST PURE FUN, was advised the filly would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race.

RIFF RAFF (M. Henderson) and DEEP BLUE (M. Hoppo) raced greenly throughout the event.

ROAD TO DANTREE (M. Neve) raced greenly in the home straight.

DEBEERSONUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 2 : ROWETT ENGINEERING & STEEL FABRICATION PTY LTD / SABOIS MAIDEN PLATE - 1000 metres

GINDRINKA (K. Bishop) was slow to begin.

SOVEREIGN DANCER (D. Robinson) jumped away awkwardly, brushing with CARBON HUNTER (A. Patterson).

# RACE 2 : ROWETT ENGINEERING & STEEL FABRICATION PTY LTD / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)

Racing to the 800 metres CARBON HUNTER (A. Patterson) had to be momentarily steadied when racing in tight room between EXCEL WITH PRIDE (P. Roff) and SOVEREIGN DANCER (D. Robinson).

GINDRINKA (K. Bishop) was inclined to hang out making the home turn.

### RACE 3: MORTLOCK SERVO / SABOIS MAIDEN PLATE - 1350 metres

Prior to this event, T. Zanker was again examined by the on course Ambulance personnel and was ruled unfit to fulfil her remaining riding engagements.

MILLIGANS (T. Baker) was slow to begin.

PRISCILLA ROSE (M. Neve) jumped away awkwardly.

At the entrance to the straight PRISCILLA ROSE (M. Neve) had to be momentarily steadied when racing on the heels of EVEN DOZEN (P. Roff).

Racing to the 100 metres EVEN DOZEN (P. Roff) was momentarily held up for clear running on the heels of JAEN (L. Stojakovic).

MILLIGANS (T. Baker) was inclined to lay in under pressure in the home straight.

TELLURIUM was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. J. Dunn, the Trainer of TELLURIUM, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

### RACE 4: WIBBERLEYS CHARTERED ACCOUNTANTS RATING 0-68 HANDICAP - 1200 metres

OLIVIA LASS (K. Bishop), EAGLEHAWK STAR (T. Baker) and LOW CUT (W. Kerford) were all slow to begin.

#### RACE 5: PORT LINCOLN REAL ESTATE RATING 0-64 HANDICAP - 1000 metres

After being loaded CARDHU MALT broke through the front of the barriers and was quickly restrained by its rider A. Patterson. CARDHU MALT was examined by the Club's Veterinary Surgeon who declared the gelding fit to race.

RICKTIN (M. Hoppo) jumped away awkwardly and severely contacted the starting gates, placing its rider at a disadvantage for a short distance.

After entering the straight the saddle on RICKTIN shifted forward and as a result M. Hoppo was unable to ride his mount out to the line.

RICKTIN was examined by the Club's Veterinary Surgeon who reported the rig to be lame in the off foreleg. Ms. C. Monaghan, the Trainer of RICKTIN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Subsequent to the event M. Hoppo, the rider of RICKTIN, was examined by the on course Ambulance personnel and ruled unfit to fulfil his remaining riding engagements.

### RACE 6: LEADER DISTRIBUTORS RATING 0-61 HANDICAP - 1750 metres

Stewards granted permission for Apprentice K. Bishop to replace M. Hoppo as the rider of BARTER TIME as there was no other rider available. K. Bishop was granted permission to ride the gelding 2 kg overweight.

DANTE'S BEST and RIPASON, which dislodged their riders en route to the barriers and left the course were withdrawn by Stewards at 3.50 pm. L. Stojakovic and D. Robinson were examined by the on course Ambulance personnel. D. Robinson was ruled unfit to fulfil his remaining riding engagements. L. Stojakovic was passed fit to fulfil her remaining riding engagements. Upon return to the course RIPASON and DANTE'S BEST were examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. M. Dunn, the Trainer of RIPASON, and Mrs. S. Williams, the Trainer of DANTE'S BEST, were advised warnings had been placed on their horses and should they perform in a similar manner in future, action will be taken against them.

On arrival at the barriers TARVON was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Acting on that advice, Stewards withdrew TARVON at 3.51 pm. Mr. J. Dunn, the Trainer of TARVON, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

BRACKEN BLUE (P. Roff) and DARK ASSASSIN (A. Patterson) were slow to begin.

DARK ASSASSIN (A. Patterson) raced ungenerously in the early and middle stages of the event.

DISCOUNTED was examined by the Club's Veterinary Surgeon who reported the gelding to the lame in the off foreleg. Mr. B. Lear, the Trainer of DISCOUNTED, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

#### RACE 7: INDEPENDENT DISTILLERS RATING 60+ HANDICAP - 1350 metres

HASTEIN (NZ) (M. Pegus) was slow to begin.

ROLL ON BAI (K. Bishop) knuckled on jumping away and as a result was slow to begin.

SEA FACTOR (B. Hoppo) jumped out awkwardly, bumping with HASTEIN (NZ) (M. Pegus).

ROLL ON ROYCE (N. Rose) raced ungenerously in the early and middle stages of the event.

Racing to the 200 metres SEA FACTOR (B. Hoppo) was momentarily held up for clear running when racing in tight room between IMMORTALITY (A. Patterson) and GALLIPOLI BEACH (M. Henderson), which momentarily shifted in under pressure.

### RACE 8: SIGN FX & T SHIRTS RACING 0-59 HANDICAP - 1350 metres

LOGICALLY was a late scratching at 4.41 pm as there was no rider available.

FIRER ME (M. Neve) jumped away awkwardly brushing with DOUBLE COVER (B. Carlile).

EPOCHAL (NZ) (A. Patterson) and HUNTED ANGEL (B. Hoppo) were both slow to begin.

Approaching the 100 metres SECRET RETREAT (S. Westover) was inclined to lay in under pressure.

### RACE 8: SIGN FX & T SHIRTS RACING 0-59 HANDICAP - 1350 metres (Cont'd)

Approaching the 50 metres EPOCHAL (NZ) (A. Patterson) was disappointed for a run when improving to a tight run between SECRET RETREAT (S. Westover), which was inclined to lay in, and GIGGLING DOLLAR (M. Pegus) which maintained it line.

DOUBLE COVER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. D. Courtney, the Trainer of DOUBLE COVER, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

GIGGLING DOLLAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
