**RACE 1 : SPORTINGBET PLATE - 1050 metres**

GOSSIP GURU (C. Lindop) was slow to jump.

From the 700 metres FAST AND LOOSE (S. Price) was inclined to lay in.

S. Price, the rider of FAST AND LOOSE, explained his instructions largely depended on how the filly, which was having its first race start, began. After FAST AND LOOSE began well, he had noted that other riders to his inside were intent on leading and therefore, rather than be caught wide, he elected to come back to obtain cover. He stated that after obtaining a position close to the fence in the vicinity of the 700 metres FAST AND LOOSE had commenced to lay in and continued to do so for the remainder of the event. FAST AND LOOSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

S. Price, the rider of FAST AND LOOSE, was questioned regarding his use of the whip in the vicinity of the 200 metres. S. Price was found guilty of a charge under ARR.137A(4)(a) in that he used his whip forward of his mount's shoulder and was fined \$200.

Subsequent to this event Jockey S. Price reported experiencing pain to his neck and back. S. Price was examined by the Club's Doctor and declared unfit to fulfill his remaining engagements.

**RACE 2 : ADELAIDE GALVANISING HANDICAP - 1200 metres**

ROCK ON RENNIE (A. Patterson) was slow to jump.

Near the 400 metres REACHFAR (A. Herrmann), when attempting to improve, shifted out onto WINE LOVER (N. Rose), which was inconvenienced.

## **RACE 2 : ADELAIDE GALVANISING HANDICAP - 1200 metres (Cont'd)**

Approaching the finish PETMAN (T. Baker) shifted out onto SNIP 'N' RUN (C. Lindop), which was severely hampered when taken onto ALPHA MAN (H. McKechnie), tightening that gelding onto REACHFAR (A. Herrmann), which was inconvenienced. T. Baker was charged with Careless Riding under ARR.137(a) in that he failed to attempt to straighten PETMAN as it continued to shift ground under riding when insufficiently clear. He pleaded guilty and was suspended from riding in races for a period to commence at midnight on Sunday, 15 January and to conclude at midnight on Wednesday, 25 January 2012; a period of five (5) meetings.

Correct Weight for this event was delayed to permit H. McKechnie, the rider of the second placegetter, the gelding's Trainer Ms. H. Lehmann, A. Herrmann, the rider of the third placegetter REACHFAR, the filly's Trainer Mr. G. Richards and Mr. L. Macdonald, the Trainer of the fourth placegetter SNIP 'N' RUN, to view the official footage of the final 100 metres. After doing so H. McKechnie lodged an objection against PETMAN (T. Baker) being declared the winner on the grounds of alleged interference over the final 100 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* H. McKechnie's objection.

PETMAN was examined by the Club's Veterinary Surgeon who reported a minor laceration to the inside bulb of the heel on the off hind leg. First Aid was administered.

## **RACE 3 : ADELAIDE CASINO ADELAIDE CUP MAR 12 HANDICAP - 1600 metres**

SILENT ATTITUDE (S. Cahill) was slow to jump.

Shortly after the start CHERILYN (A. Herrmann) rolled out onto REVIEW THE MOMENT (A. Patterson), which was inconvenienced.

MEADOWS MOLLIE (L. Hopwood) raced wide without cover throughout the event.

SILENT ATTITUDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 4 : KRISTIN GRANTHAM'S 30TH BIRTHDAY HANDICAP - 1600 metres**

Mr. J. Hyam, the Trainer of ABOUT ME, advised Stewards that due to the outside barrier draw and so as not to be trapped wide, he would instruct Jockey T. Baker to ride the gelding off the pace with cover if possible.

The start of this race was delayed owing to SACHSE, which lost its near fore plate during its preliminary, requiring Farrier attention.

SACHSE (M. Hoppo) was inclined to race keenly in the early stages of the event.

Inside the 200 metres TAJ MAHER (A. Herrmann) rolled in onto REGANSBURG (A. Patterson) as that gelding commenced to improve taking it in onto BLUE MAGGICH (NZ) (J. Holder), which was obliged to steady.

BLUE MAGGICH (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 5 : SPRING GULLY HANDICAP - 2050 metres**

HOLLYWOOD AND VINE (A. Patterson) and MAESTRO OF MURANO (J. Frew) were slow to jump.

From the entrance to the straight until approaching the 200 metres, MONTJEU MADAME (NZ) (H. McKechnie) became held up when racing behind LOUKOUMI (P. Gatt) and inside the heels of MAESTRO OF MURANO (J. Frew).

When questioned regarding the circumstances in which MONTJEU MADAME (NZ) became held up from the vicinity of the 400 metres, H. McKechnie explained that ideally she would have attempted to follow LENNYBE (M. Neilson) for some distance as it improved, however, considering that neither LOUKOUMI (P. Gatt) nor MAESTRO OF MURANO (J. Frew) were improving and her mount was full of running, she considered that she would have to concede too much ground to shift across the heels of MAESTRO OF MURANO. Having considered her explanation and on reviewing the vision Stewards accepted her explanation.

Approaching the finish M. Neilson, the rider of LENNYBE, dropped his whip. M. Neilson was reprimanded and advised that future carelessness may result in a penalty being imposed. .

OCSEMPOP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : BREAKA CHOCOLATE MILK HANDICAP - 1800 metres**

SCRUBLANDS (N. Rose) jumped away awkwardly.

On jumping away DARK ASSASSIN (A. Patterson) was reluctant to get into stride.

Shortly after the start NO DOUBTFIRE (H. McKechnie) rolled in and brushed GOLDSTINGER (M. Neve).

Shortly after the start KING'S DREAM (C. Lindop) shifted in onto INDEED I AM (A. Herrmann), which was inconvenienced.

Near the 1400 metres ZONED IN (J. Rule) shifted in onto NO DOUBTFIRE (H. McKechnie), which was forced to steady. In being steadied NO DOUBTFIRE commenced to race keenly and got its head up. J. Rule was reprimanded and advised in future to give riders to his inside the room to which they are entitled.

Near the 600 metres, in attempting to improve, ZONED IN (J. Rule) shifted out and brushed INDEED I AM (A. Herrmann).

Inside the 500 metres, when attempting to improve between INDEED I AM (M. Herrmann) and FRENCH ACADEMY (T. Pannell) which rolled out marginally, ZONED IN (J. Rule) clipped the heels of FRENCH ACADEMY, severely unbalancing the rider. J. Rule was cautioned against attempting to improve into a position where there was insufficient room in future.

### **RACE 7 : CAM MANAGEMENT HANDICAP - 1100 metres**

RIALYA (N. Rose) and A WEE DRAM (T. Pannell) were inclined to rear as the gates opened.

On jumping away PRODUCED (NZ) (J. Matthews) shifted out onto SEQUALLAN (M. Hoppo), which was inconvenienced.

STRONG CAMPAGNE (T. Baker) raced wide without cover throughout the event.

**RACE 7 : CAM MANAGEMENT HANDICAP - 1100 metres (Cont'd)**

Inside the 300 metres SEQUALLAN (M. Hoppo) became held up when attempting to improve between STRONG CAMPAGNE (T. Baker), which rolled in, and KENNY KID (P. Gatt), which rolled out.

Inside the 200 metres STRONG CAMPAGNE (T. Baker) shifted out onto BARBIE'S BOMBSHELL (C. Lindop), which was taken out and obliged to steady away from the heels of CHIEF OF STAFF (S. Cahill).

After entering the straight until approaching the 100 metres LILGIGGLEO (J. Holder) had difficulty obtaining clear ground.

A WEE DRAM was examined by the Club's Veterinary Surgeon who reported the mare to be exhibiting symptoms of heat stress. First Aid was administered.

**RACE 8 : ACG SECURITY HANDICAP - 1200 metres**

Approaching the 100 metres GLENBURNIE DANE (A. Herrmann) was obliged to steady when tightened between NOBLE MISTRESS (M. Neilson), which rolled out, and OUR IRIDIUM (S. Westover), which rolled in.

Correct Weight for this event was delayed to permit H. McKechnie, the rider of the second placegetter, the gelding's Trainer Ms. H. Lehmann, A. Herrmann, the rider of the third placegetter REACHFAR, the filly's Trainer Mr. G. Richards and Mr. L. Macdonald, the Trainer of the fourth placegetter SNIP 'N' RUN, to view the official footage of the final 100 metres. After doing so H. McKechnie lodged an objection against PETMAN (T. Baker) being declared the winner on the grounds of alleged interference over the final 100 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* H. McKechnie's objection.

PETMAN was examined by the Club's Veterinary Surgeon who reported a minor laceration to the inside bulb of the heel on the off hind leg. First Aid was administered.

## **RACE 3 : ADELAIDE CASINO ADELAIDE CUP MAR 12 HANDICAP - 1600 metres**

SILENT ATTITUDE (S. Cahill) was slow to jump.

Shortly after the start CHERILYN (A. Herrmann) rolled out onto REVIEW THE MOMENT (A. Patterson), which was inconvenienced.

MEADOWS MOLLIE (L. Hopwood) raced wide without cover throughout the event.

SILENT ATTITUDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 4 : KRISTIN GRANTHAM'S 30TH BIRTHDAY HANDICAP - 1600 metres**

Mr. J. Hyam, the Trainer of ABOUT ME, advised Stewards that due to the outside barrier draw and so as not to be trapped wide, he would instruct Jockey T. Baker to ride the gelding off the pace with cover if possible.

The start of this race was delayed owing to SACHSE, which lost its near fore plate during its preliminary, requiring Farrier attention.

SACHSE (M. Hoppo) was inclined to race keenly in the early stages of the event.

Inside the 200 metres TAJ MAHER (A. Herrmann) rolled in onto REGANSBURG (A. Patterson) as that gelding commenced to improve taking it in onto BLUE MAGGICH (NZ) (J. Holder), which was obliged to steady.

BLUE MAGGICH (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 5 : SPRING GULLY HANDICAP - 2050 metres**

HOLLYWOOD AND VINE (A. Patterson) and MAESTRO OF MURANO (J. Frew) were slow to jump.

### **RACE 5 : SPRING GULLY HANDICAP - 2050 metres (Cont'd)**

From the entrance to the straight until approaching the 200 metres, MONTJEU MADAME (NZ) (H. McKechnie) became held up when racing behind LOUKOUMI (P. Gatt) and inside the heels of MAESTRO OF MURANO (J. Frew).

When questioned regarding the circumstances in which MONTJEU MADAME (NZ) became held up from the vicinity of the 400 metres, H. McKechnie explained that ideally she would have attempted to follow LENNYBE (M. Neilson) for some distance as it improved, however, considering that neither LOUKOUMI (P. Gatt) nor MAESTRO OF MURANO (J. Frew) were improving and her mount was full of running, she considered that she would have to concede too much ground to shift across the heels of MAESTRO OF MURANO. Having considered her explanation and on reviewing the vision Stewards accepted her explanation.

Approaching the finish M. Neilson, the rider of LENNYBE, dropped his whip. M. Neilson was reprimanded and advised that future carelessness may result in a penalty being imposed. .

OCSEMPOP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : BREAKA CHOCOLATE MILK HANDICAP - 1800 metres**

SCRUBLANDS (N. Rose) jumped away awkwardly.

On jumping away DARK ASSASSIN (A. Patterson) was reluctant to get into stride.

Shortly after the start NO DOUBTFIRE (H. McKechnie) rolled in and brushed GOLDSTINGER (M. Neve).

Shortly after the start KING'S DREAM (C. Lindop) shifted in onto INDEED I AM (A. Herrmann), which was inconvenienced.

Near the 1400 metres ZONED IN (J. Rule) shifted in onto NO DOUBTFIRE (H. McKechnie), which was forced to steady. In being steadied NO DOUBTFIRE commenced to race keenly and got its head up. J. Rule was reprimanded and advised in future to give riders to his inside the room to which they are entitled.

Near the 600 metres, in attempting to improve, ZONED IN (J. Rule) shifted out and brushed INDEED I AM (A. Herrmann).

Inside the 500 metres, when attempting to improve between INDEED I AM (M. Herrmann) and FRENCH ACADEMY (T. Pannell) which rolled out marginally, ZONED IN (J. Rule) clipped the heels of FRENCH ACADEMY, severely unbalancing the rider. J. Rule was cautioned against attempting to improve into a position where there was insufficient room in future.

### **RACE 7 : CAM MANAGEMENT HANDICAP - 1100 metres**

RIALYA (N. Rose) and A WEE DRAM (T. Pannell) were inclined to rear as the gates opened.

On jumping away PRODUCED (NZ) (J. Matthews) shifted out onto SEQUALLAN (M. Hoppo), which was inconvenienced.

STRONG CAMPAGNE (T. Baker) raced wide without cover throughout the event.

**RACE 7 : CAM MANAGEMENT HANDICAP - 1100 metres (Cont'd)**

Inside the 300 metres SEQUALLAN (M. Hoppo) became held up when attempting to improve between STRONG CAMPAGNE (T. Baker), which rolled in, and KENNY KID (P. Gatt), which rolled out.

Inside the 200 metres STRONG CAMPAGNE (T. Baker) shifted out onto BARBIE'S BOMBSHELL (C. Lindop), which was taken out and obliged to steady away from the heels of CHIEF OF STAFF (S. Cahill).

After entering the straight until approaching the 100 metres LILGIGGLEO (J. Holder) had difficulty obtaining clear ground.

A WEE DRAM was examined by the Club's Veterinary Surgeon who reported the mare to be exhibiting symptoms of heat stress. First Aid was administered.

**RACE 8 : ACG SECURITY HANDICAP - 1200 metres**

Approaching the 100 metres GLENBURNIE DANE (A. Herrmann) was obliged to steady when tightened between NOBLE MISTRESS (M. Neilson), which rolled out, and OUR IRIDIUM (S. Westover), which rolled in.
