Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Sunday, 8 January 2012

RACE 1: PURE BLONDE / SABOIS MAIDEN PLATE - 1200 metres

On arrival on course CAPTAIN PERCY was examined by the Club's Veterinary Surgeon who reported the gelding to have a deep laceration to the head and unfit to race. Acting on that advice, Stewards withdrew CAPTAIN PERCY at 12.23 pm.

LOVERS ROCKS, which became fractious in the barriers, was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, Stewards withdrew LOVERS ROCKS at 1.13 pm. Mr. D. Carrison, the Trainer of LOVERS ROCKS, was advised a warning had been placed on the mare regarding its behavior. Jockey B. Hoppo was examined by the on course Ambulance personnel and passed fit to fulfill his remaining riding engagements.

After being loaded BEAU RAJA, which was fractious, broke through the front of the barriers and was quickly captured by the Clerk of the Course. BEAU RAJA was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, Stewards withdrew BEAU RAJA at 1.13 pm.

DULCIE DEE, which became fractious in the barriers, was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, Stewards withdrew DULCIE DEE at 1.13 pm.

SIR TRENTIN (A. Patterson) and LUNAR SPECIAL (M. Hoppo) were slow to begin.

RACE 2 : EYRE PENINSULA OWNERS & TRAINERS ASSOCIATION / SABOIS MAIDEN PLATE - 1750 metres

PRAYER ACADEMY (A. Patterson) jumped out awkwardly brushing with CURRASILLA (T. Baker).

Approaching the winning post on the first occasion PRISCILLA ROSE (M. Neve) shied away resulting in that mare shifting out. Shortly after PRISCILLA ROSE shifted in making heavy contact with the running rail, resulting in M. Neve being severely unbalanced. PRISCILLA ROSE raced ungenerously soon after, shifting out, inconveniencing CURRASILLA (T. Baker) and WILD ALLY (M. Pegus), which were taken wider on the track.

PRISCILLA ROSE (M. Neve) was inclined to race ungenerously in the middle stages.

From the 500 metres to the 300 metres EVEN DOZEN (M. Hoppo) was held up on the heels of PRISCILLA ROSE (M. Neve).

Racing to the 200 metres CURRASILLA (T. Baker) was inclined to lay in and as a result T. Baker was unable to ride his mount out to the line. CURRASILLA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PRISCILLA ROSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : THE PRINTING PRESS / SABOIS 3YO RATING 0-61 HANDICAP – 1000 metres

MISS HARREB (B. Hoppo) and GONE WITH GRACE (M. Neve) jumped away awkwardly and bumped heavily.

UNCLE CHIKO (A. Patterson) was inclined to race ungenerously in the early and middle stages.

Racing to the 700 metres UNCLE CHIKO (A. Patterson), which continued to race ungenerously, shifted in and away from LYNSHEE (A. Herrmann), resulting in MIGHTY MOMENT (M. Pegus), which was racing to the inside of UNCLE CHIKO, being momentarily inconvenienced.

From the home turn to the 100 metres MISS HARREB (B. Hoppo) was inclined to lay in under pressure.

Approaching the 100 metres LYNSHEE (A. Herrmann) was inclined to lay in under pressure.

UNCLE CHIKO was examined by the Club's Veterinary Surgeon who reported the gelding had suffered a bi-lateral bleeding attack. Mr. G. Searle, the Trainer of UNCLE CHIKO, was advised the gelding was suspended from racing for a period of three months in accordance with ARR.53A.

RACE 4 : LINCOLN GOURMET MEATS RATING 60+ HANDICAP - 1750 metres

SEA FACTOR, which dislodged its rider M. Hoppo after leaving the mounting enclosure, galloped for a short distance before being recaptured. SEA FACTOR was examined by the Club's Veterinary Surgeon and ruled fit to race.

COS IN COURT (A. Patterson) reared on jumping.

In the early and middle stages of the event COS IN COURT (A. Patterson) was inclined to race ungenerously.

RACE 4: LINCOLN GOURMET MEATS RATING 60+ HANDICAP - 1750 metres (Cont'd)

Near the 1400 metres COS IN COURT (A. Patterson), which was racing ungenerously, shifted out, resulting in JEWEL KING (L. Stojakovic) being taken out and having to steady off the heels of SEA FACTOR (M. Hoppo).

RACE 5: NAVIGATORS MOTEL RATING 60+ HANDICAP - 1000 metres

Near the 400 metres OUT FOR LUNCH (L. Stojakovic) had to momentarily steady when racing in tight room between ACHENAR (J. Maund) and HARREB LADY (B. Hoppo), which rolled out marginally.

RACE 6: REILLY'S WINES RATING 0-64 HANDICAP - 1200 metres

Jockey B. Hoppo, who injured his ankle in Race 1, reported the injury had deteriorated and as he considered he could not properly discharge his obligations on his remaining mounts, he stood down for the remainder of the day. B. Hoppo was advised a Doctor's Certificate is required before riding again.

FINAL DYNASTY, which dislodged its rider T. Baker and galloped for a distance, was withdrawn by Stewards at 4.07 pm as the gelding broke through the outside fence. T. Baker was uninjured in the incident. Mr. W. Drewitt, the Trainer of FINAL DYNASTY, was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race. FINAL DYNASTY was examined by the Club's Veterinary Surgeon who reported the gelding to have a laceration to the off foreleg. Mr. W. Drewitt, the trainer of FINAL DYNASTY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or Race.

SUPERBAD (M. Hoppo) was slow to begin.

SPARTAN EAGLE (M. Pegus) and EXTREME WAYS (L. Stojakovic) brushed on jumping.

RACE 7: D K QUARRIES RATING 0-64 HANDICAP - 1350 metres

Stewards granted permission for M. Pegus to replace B. Carlile as the rider of DEVLINO as there was no other rider available. M. Pegus was granted permission to ride the gelding two kilograms overweight.

JACKIE'S PAPER was withdrawn by Stewards at 4.17 pm as there was no rider available.

STELLA'S PEARL, which became fractious in the barriers, was examined by the Club's Veterinary Surgeon and ruled unfit. Acting on that advice, Stewards withdrew STELLA'S PEARL at 4.50 pm. Mr. B. Cozamanis (Jnr), the Trainer of STELLA'S PEARL, was advised a warning had been placed on the mare regarding its behavior.

ALL ABOUT HEART was examined by the Club's Veterinary Surgeon and ruled fit to start.

DIRE WARNING (M. Hoppo), ORCHESTRAL (L. Stojakovic) and ARTFUL TERRA (T. Zanker) were all slow to begin.

From the 400 metres to the 300 metres DIRE WARNING (M. Hoppo) was held up for clear running when awkwardly placed on the heels of FIRER ME (M. Neve).

Racing to the 200 metres STREET RELATED (S. Westover) had to momentarily steady off the heels of ORCHESTRAL (L. Stojakovic), which shifted in under pressure.

RACE 7 : D K QUARRIES RATING 0-64 HANDICAP - 1350 metres (Cont'd)

Over the concluding stages EPOCHAL (NZ) (A. Patterson) had to steady when racing tight between ALL ABOUT HEART (T. Baker) which shifted out to its inside and DEVLINO (M. Pegus) to its outside. T. Baker was reminded of his obligations when shifting ground.

WOOFNOOF was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JOCKEY SAMPLING (2):

T. Baker and B. Hoppo provided urine samples for analysis.
