## RACE 1: COOPERS RATING 0-68 HANDICAP - 1215 metres

Approaching the 800 metres FERROQUEST (W. Kerford) was obliged to steady when DEMOB (M. Tyndall) rolled in.

In the vicinity of the 400 metres SIMMONA (D. Evans) became held up behind FERROQUEST (W. Kerford) and to the inside of SILVER RAVEN (M. Hoppo) and was unable to obtain clear ground until inside the 200 metres.

Correct weight for this event was delayed to allow D. Evans, the rider of the second placegetter SIMMONA to view the official footage in the vicinity of the 400 metres.

#### RACE 2: SEALINK TRAVEL RATING 0-61 HANDICAP - 1750 metres

In the vicinity of the 300 metres SIERRA SKIES (M. Hoppo) shifted out onto BONDI BACHELOR (W. Kerford) taking that gelding out onto HENDON (K. Dyson) which was taken wider on the track.

Approaching the 200 metres TROBEN (K. Bishop) laid out onto SIERRA SKIES (M. Hoppo) which shifted away.

Inside the 200 metres BONDI BACHELOR (W. Kerford) reacted away from the shift of SIERRA SKIES (M. Hoppo) making contact with HENDON (K. Dyson) taking that gelding wider on the track.

From in the vicinity of the 100 metres CURRASILLA (D. Evans) commenced to lay out.

Over the concluding stages HENDON (K. Dyson) laid in under pressure.

Correct weight for this event was delayed to allow K. Dyson, the rider of second placegetter HENDON to view the official footage in the vicinity of the 300 metres.

TROBEN, HENDON and CURRASILLA were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 2: SEALINK TRAVEL RATING 0-61 HANDICAP - 1750 metres (Cont'd)

BONDI BACHELOR was examined by the Club's Veterinary Surgeon who reported the gelding suffered a bi-lateral bleeding attack during the event. Mr. D. Halliday, the Trainer of BONDI BACHELOR, was advised the gelding was suspended from racing for a period of three (3) months in accordance with ARR.53A.

# RACE 3: HAZYBLUR WINES HANDICAP - 1385 metres

In the vicinity of the 400 metres COS IN COURT (T. O'Donnell) made the turn awkwardly and as a result raced wide for the remainder of the event.

### RACE 4: DUDLEY WINES RATING 0-58 HANDICAP - 1385 metres

FLYING BOMB (B. Carlile) raced wide in the early and middle stages of the event.

B. Carlile, the rider of FLYING BOMB, reported that she had no option but to race wide without cover in an attempt to gain a forward position in the field from the 1200 metres. She added that from in the vicinity of the 500 metres, when placed under pressure, the gelding failed to respond to her riding. FLYING BOMB was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 5: INGRAM'S HOME HARDWARE / SABOIS MAIDEN PLATE - 1008 metres

LA CRANKSTA (B. Carlile) and BALARAT (D. Tootell) were slow to begin.

Approaching the finish BIG POND (W. Kerford) was obliged to alter course when TORPIFY (T. O'Donnell) rolled in marginally.

### RACE 6: KILDEA PHARMACY RATING 0-58 HANDICAP - 1008 metres

Mr. P. Cole, the Trainer of RETAIN BELIEF, was questioned regarding the reason he had presented the gelding without winkers, which was its approved gear. After considering Mr. Cole's explanation, he was reprimanded under ARR.140A for presenting the gelding in the parade ring without its correct gear.

From in the vicinity of the 600 metres until near the 400 metres KASHINITE (T. O'Donnell) laid in.

In the vicinity of the 300 metres SWISS BANKER (D. Evans) shifted in onto BIRDSEID (K. Dyson) taking that mare in onto ROYAL IMPULSE (K. Bishop) which was tightened for galloping room, resulting in ROYAL IMPULSE having to be steadied. D. Evans was advised of his obligations when his mounts commence to shift ground in future.

B. Carlile, the rider of RETAIN BELIEF, the third placegetter, who failed to weigh in after the event, was severely reprimanded under ARR.144.

RETAIN BELIEF was examined by the Club's Veterinary Surgeon who reported the gelding to be exhibiting signs of colic, First Aid was administered.

KASHINITE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
