Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 8 February 2012

RACE 1 : WATERSEARCH / SABOIS DISTANCE MAIDEN PLATE - 2122 metres

S'AMUSE (J. Holder) jumped away awkwardly, shifted out and contacted FREE ENTRY (J. Frew).

FIVE IRON (P. Gatt) and VOTE FOR LUST (A. Patterson) were slow to begin.

FREE ENTRY (J. Frew) raced wide without cover in the early and middle stages of the event.

COUNT FEDELM I (S. Price) jumped the crossing near the 1800 metres.

Inside the 1800 metres PRAYER ACADEMY (M. Tyndall) rolled out and inconvenienced FREE ENTRY (J. Frew) and when being corrected, PRAYER ACADEMY shifted in, resulting in ALL ROSES (L. Stojakovic) being hampered for a short distance when awkwardly placed on the heels of PRAYER ACADEMY.

Near the 300 metres TSARINA WONDER (C. Lindop) shifted out abruptly of its own accord and inconvenienced S'AMUSE (J. Holder).

FIVE IRON lost its near fore plate during the event.

L. Stojakovic, the rider of ALL ROSES, reported the mare felt awkward in its action in the straight. ALL ROSES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PRAYER ACADEMY was examined by the Club's Veterinary Surgeon who reported a laceration to the back of the near hind leg. First Aid was administered.

RACE 2 : KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE -1211 metres

The start of this race was delayed approximately two minutes owing to LADY KAHUNA and SHESHOOSSHESCORES proving difficult to load.

RACE 2 : KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE – 1211 metres

LADY KAHUNA (L. Hopwood) and DAKADAN PRINCESS (S. Cahill) jumped away awkwardly.

BELLA DOLCE (D. Tourneur) became held up for clear running from the vicinity of the 600 metres until near the 300 metres when racing behind ROCK STAR BABY (C. Lever) and to the outside of HENGELLO (A. Patterson).

LADY KAHUNA (L. Hopwood) became held up for clear running between the 400 metres and the 300 metres when racing on the heels of CHLOE'S WAY (T. Zanker) and was obliged to alter course after entering the straight.

After pulling up near the 1500 metres C. Lever, the rider of ROCK STAR BABY which proved difficult, was dislodged from the filly. C. Lever was examined by the on-course ambulance personnel and passed fit to fulfil his remaining riding engagements. ROCK STAR BABY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : SA BOOKMAKERS LEAGUE / SABOIS COLTS, GELDINGS & ENTIRES
MAIDEN PLATE - 1211 metres

On arrival on course HALAYR JET was examined by the Club's Veterinary Surgeon and ruled fit to start.

TOKEN ONE (P. Gatt) jumped away awkwardly and as a consequence was slow to begin.

BRAWNY FOX (J. Frew) was slow to begin.

BEAU OF BLUE (B. Hoppo) jumped away awkwardly, shifted out and inconvenienced PELICAN RED (L. Stojakovic).

BEAU OF BLUE (B. Hoppo) hung out from in the vicinity of the 800 metres and raced very wide into the straight. BEAU OF BLUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HALAYR JET (M. Pegasus), which improved inside the 600 metres, was obliged to race wide when taken wider by BEAU OF BLUE (B. Hoppo) in the vicinity of the 500 metres and raced wide into the straight.

MISTY EYES (M. Neilson) hung out from in the vicinity of the 500 metres. M. Neilson reported MISTY EYES laid out during the event resulting in him being unable to fully assist his mount to the line. MISTY EYES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Approaching the entrance to the straight PELICAN RED (L. Stojakovic) shifted out slightly to improve to the outside of EXALTED DUKE (D. Tourneur) and brushed with KING KAVIAR (S. Price), which shifted out and away onto BAKLAVA BOY (NZ) (J. Holder), which was taken out onto TOKEN ONE (P. Gatt), which was taken wider onto HALAYR JET (M. Pegasus). As a result KING KAVIAR, BAKLAVA BOY (NZ), TOKEN ONE and HALAYR JET were all inconvenienced.

Approaching the 200 metres EXALTED DUKE (D. Tourneur) rolled out, resulting in PELICAN RED (L. Stojakovic) shifting out and away from that gelding, crossing the running of KING KAVIAR (S. Price), which had to be steadied.

RACE 4 : GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE - 1511 metres

The start of this race was delayed approximately two minutes owing to CORNISH LAD, MAID OF FINNISS and SUREFIRE proving fractious after being loaded into their barrier stalls. SUREFIRE was examined by the Club's Veterinary Surgeon and ruled fit to start.

ELANCER (M. Tyndall) was slow to begin, losing three to four lengths.

In the vicinity of the 1400 metres CORNISH LAD (L. Hopwood), which shifted in to improve, inconvenienced BESA BOLA (S. Price) and CARESSA (J. Toeroek) for a number of strides, resulting in both horses having to be momentarily steadied. Thereafter CARESSA got its head up and raced keenly for some distance inside the 1200 metres.

SET TO EXCITE (P. Gatt) became held up for clear running from in the vicinity of the 300 metres when racing between the heels of CORNISH LAD (L. Hopwood) and POWER TO POSSESS (D. Tourneur). As a consequence DISTILLATION (T. Pannell), which was following, became held up on the heels of SET TO EXCITE and CARESSA (J. Toeroek). Thereafter SET TO EXCITE, in an attempt to obtain clear running in the vicinity of the 200 metres, altered course to the outside of POWER TO POSSESS and in doing so brushed with CARESSA, which was taken out across the running of CHAVELLI (J. Frew), which was inconvenienced. DISTILLATION was only able to obtain clear running inside the 200 metres.

Following the running of this race P. Gatt, who was feeling unwell, was examined by the on-course Ambulance personnel and ruled unfit to fulfil his remaining riding engagements.

RACE 5 : COOPERS PALE ALE / SABOIS + CLASS 2 HANDICAP - 2122 metres

On arrival at the barriers HIDDEN TEARS was examined by the Club's Veterinary Surgeon and ruled fit to start.

In the vicinity of the 400 metres BLUE SIMONE (J. Frew) became awkwardly placed on the heels of TROBEN (K. Bishop) for a number of strides and was obliged to alter course to the outside of that gelding to obtain clear running.

PARNISSIUS (R. Stewart) became held up for clear running from in the vicinity of the entrance to the straight when racing behind MASTER ROBBIE (T. Zanker) and to the inside of HIDDEN TEARS (L. Stojakovic) and was unable to obtain clear running until inside the 100 metres where it was obliged to alter course to the outside of MASTER ROBBIE.

PARNISSIUS was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. L. Kavanagh, representing Mr. M.A.T. Kavanagh, the Trainer of PARNISSIUS, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 6 : COOPERS PREMIUM LIGHT RATING 0-62 HANDICAP - 1111 metres

AROC (D. Tourneur) jumped away awkwardly, shifted in and brushed LADY LIGHTFOOT (S. Price).

PROPHETS (C. Lever) jumped away awkwardly and shifted out, taking KOSCIUSZKO'S SIDE (J. Maund) out onto SEYMOUR SNAKE (J. Lions), which was tightened onto the heels of LADY LIGHTFOOT (S. Price), resulting in SEYMOUR SNAKE losing its position.

AMBITIOUS BRIDE (B. Hoppo) became held up for clear running behind PROPHETS (C. Lever) and to the inside of LADY LIGHTFOOT (S. Price) for a short distance shortly after entering the straight.

RACE 6 : COOPERS PREMIUM LIGHT RATING 0-62 HANDICAP - 1111 metres (Cont'd)

OUR BELVOIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

KOSCIUSZKO'S SIDE was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 7 : COOPERS CLEAR RATING 0-71 HANDICAP - 1716 metres

On arrival at the barriers INDEE'S HOPE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg and unfit to race. Acting on that advice, Stewards withdrew INDEE'S HOPE at 4.19 pm.

STEELY RESOLVE (J. Toeroek) jumped away awkwardly, shifted out and contacted GRAND TITLE (C. Lindop).

Inside the 1300 metres MEADOWS MAGIC (L. Stojakovic), which improved onto the heels of CAPE SILVER (R. Stewart), which was taken in slightly by GLENBURNIE DANE (S. Price), which shifted in, appeared to clip the heels of that gelding and had to be checked, losing its position.

STEELY RESOLVE (J. Toeroek) raced wide without cover in the early and middle stages of the event, was inclined to lay in under pressure and shifted in, in the vicinity of the 50 metres and brushed the hindquarters of JUST A GIGGLE (T. Pannell).

JEWEL OF JOHAR (NZ) lost its off hind plate during the event.

PARTY RAYJA was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mrs. N. Bruggemann, the Trainer of PARTY RAYJA, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

CAPE SILVER was examined by the Club's Veterinary Surgeon who reported an abrasion to the back of the near hind leg above the hock.

RACE 8 : COOPERS LAGER RATING 0-68 HANDICAP - 1211 metres

On arrival on course MASSIAH was examined by the Club's Veterinary Surgeon and ruled fit to start.

TAJ MAHER, which struck the gate on leaving the mounting yard, was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

The start of this race was delayed approximately three minutes owing MASSIAH, which lost its off fore plate en route to the barriers, requiring Farrier attention.

MASSIAH (L. Cribbin) jumped away awkwardly, shifted in and contacted MONSTARHIT (S. Cahill).

RUN BARRY RUN (M. Tyndall) jumped away awkwardly.

Inside the 800 metres when SLIPPERY NINJA (A. Patterson) crossed to take up a forward position on the rail, VISUAL IMPACT (J. Holder) shifted out to obtain a position outside the heels of SLIPPERY NINJA and in doing so inconvenienced MASSIAH (L. Cribbin), which was taken wider.

RACE 8 : COOPERS LAGER RATING 0-68 HANDICAP - 1211 metres (Cont'd)

MONSTARHIT (S. Cahill) was disappointed for clear running for a short distance in the vicinity of the 300 metres.

RUN BARRY RUN (M. Tyndall) hung out throughout in the straight. RUN BARRY RUN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SHARADA (J. Frew) was eased out of the event approaching the 200 metres. J. Frew reported as he felt there was something amiss with the mare, he had eased it out of the event shortly after entering the straight. SHARADA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
