# Report on Race Meeting held at the Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 12 February 2012

## RACE 1: HENRYS DRIVE RATING 0-72 HANDICAP - 1000 metres

Shortly after the start SCARY SMOKOVEC (S. Price) was inconvenienced when tightened for room between FLYING MERKEL (J. Toeroek), who jumped away awkwardly and shifted out and CONSOLIDATED GLASS (P. Marks), who jumped away awkwardly and shifted in.

In the home straight OGUNDE (S. Harrison) was inclined to lay out under pressure.

Approaching the 50 metres OGUNDE (S. Harrison) shifted out under pressure brushing with CONSOLIDATED GLASS (P. Marks).

## RACE 2: SOUTHEAST MOTOR CO / SABOIS MAIDEN PLATE - 1000 metres

LASTDANCE AT GRETA (A. Patterson) and SPARK OF CHOICE (S. Harrison) were slow to begin.

AKERBOY (K. Walters) jumped away awkwardly and as a result was slow to begin.

Racing to the 600 metres DIAMOND JACK (J. Beriman) hung out momentarily inconveniencing FRONT PEW (P. Marks).

Racing to the 450 meters MISS HALF PENNY (J. Potter) accidently struck the running rail when racing greenly.

Racing to the 400 metres MISS HALF PENNY (J. Potter), when attempting to improve to the outside of BELZARGO (H. McKechnie), shifted out momentarily inconveniencing MYSTIC MORN (D. Tourneur).

Racing to the 300 metres MISS HALF PENNY (J. Potter), when shifting wider on the track to improve outside the heels of BELZARGO (H. McKechnie), shifted out when insufficiently clear of MYSTIC MORN (D. Tourneur), who was forced to check his mount and lost his position. J. Potter was severely reprimanded under ARR.137(a) and advised to take greater care when shifting ground.

DIAMOND JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MULTIPAROUS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3: BARRETT DISTRIBUTORS HANDICAP - 1200 metres

BLITZ'EM RILEY (NZ) (N. Rose) was slow to begin.

## RACE 4: COOPERS / SABOIS MAIDEN PLATE - 1430 metres

MOVIE'S LAST STAND (P. Marks) was slow to begin.

BRAZILIAN LADY (NZ) (M. Walters) jumped away awkwardly and shifted out bumping SPRAY TAN (D. Tootell).

Racing to the 100 metres O'JAY (J. Beriman) shifted out under pressure brushing MOVIE'S LAST STAND (P. Marks) who in turn was taken out, making contact with SIR ANTHONY (M. Neilson) resulting in SIZZLING DAN (J. Potter) being taken wider on the track.

BRAZILIAN LADY (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 5: MARANA PARK RATING 0-65 HANDICAP - 2000 metres

KOBAN (M. Neilson) was slow into stride.

Racing from the 500 metres to the 300 metres LATORULE (A. Patterson) was held up for clear ground behind HOLDEM (J. Frew) which commenced to tire.

Near the 150 metres PEACE AN QUIET (K. Walters) shifted in under pressure brushing with TONTO'S PRIDE (J. Potter).

HOLDEM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 6: G J GARDNER HOMES RATING 0-68 HANDICAP - 1430 metres

CARD SHARP (C. Lever) and ACTION AGAIN (D. Tourneur) were slow to begin.

Racing to the 400 metres FOODEATER (J. Beriman), when improving around the heels of KANEJAKE (J. Dertilis), brushed OUR MOVIE STAR (J. Toeroek).

CROCMAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7: MINI JUMBUK / SABOIS + NARACOORTE CUP - 2000 metres

HE'S HOT TO TROT (A. Patterson) was slow to begin.

LOTTO MEO (J. Toeroek) jumped away awkwardly and shifted out bumping with BISHOP OF DERRY (J. Beriman) resulting in CLUB ROYALE (H. McKechnie) being inconvenienced.

DIAMONDSONDINSIDE (C. Lever) jumped away awkwardly and shifted in bumping with SCENIC SCENE (N. Rose).

Racing inside the 200 metres COUNTRY RUN (J. Potter) was accidentally struck with the whip by J. Beriman, the rider of BISHOP OF DERRY.

## RACE 7: MINI JUMBUK / SABOIS + NARACOORTE CUP - 2000 metres (Cont'd)

Over the concluding stages HE'S HOT TO TROT (A. Patterson) was held up for clear running on the heels of ORIENTAPED (S. Price).

SCENIC SCENE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 8: TOLL / IPEC RATING 0-65 HANDICAP - 1200 metres

This race was rescheduled to 5.21pm due to the on course ambulance personnel having to attend to a member of the general public.

SAINT RICH (C. Puls) jumped away awkwardly and shifted out brushing with KIORA (D. Tourneur).

KVINNAKEL (M. Neilson) jumped away awkwardly.

AL MUNIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BANYAN was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off side foreleg. Ms. A. Marshall, the Trainer of BANYAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
