Report on Race Meeting held at Kingscote Racecourse

RACE 1 : CYGNET PARK FARMS RATING 0-61 HANDICAP - 1008 metres

EIGHT RED (T. O'Donnell) was slow to begin.

SAKURABA (S. Cahill) and CALEJA (M. Hoppo) jumped away awkwardly and contacted shortly after the start.

JUNOOD (T. Baker) laid out from in the vicinity of the 400 metres.

In the vicinity of the 300 metres SAKURABA (S. Cahill) shifted to the outside of DINKY (D. Tourneur) to improve and in doing so crossed the running of CALEJA (M. Hoppo), which was obliged to steady. S. Cahill was reprimanded and advised to take greater care in future when shifting ground.

In the vicinity of the 200 metres DINKY (D. Tourneur) shifted out abruptly of its own accord taking SAKURABA (S. Cahill) wider on the track.

RACE 2 : SEALINK HANDICAP - 1215 metres

HANDOUT (A. Patterson) was slow into stride and reluctant to gallop in the early part of the event despite the efforts of its rider.

COURT BELL (S. Cahill) laid out from in the vicinity of the 500 metres.

A. Patterson, the rider of HANDOUT, was questioned regarding his use of the whip prior to the 100 metres. A. Patterson pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3 : MILTON TURNER MEMORIAL / SABOIS MAIDEN PLATE - 1385 metres

BRAWNY FOX (M. Tyndall) was slow to begin, losing approximately three lengths.

From near the entrance to the straight until the finish BIG POND (W. Kerford) was inclined to lay in, resulting in that rider having to stop riding and straighten his mount on a number of occasions to avoid the heels of KINGS AND JACKS (A. Herrmann), which was inclined to roll out slightly, placing W. Kerford at a disadvantage.

RACE 4 : GERARD LIGHTING / SABOIS MAIDEN PLATE - 1008 metres

As Stewards were able to identify GET UP STAND UP from their own records, they permitted the filly to start. Mr. J. Stephens, the Trainer of GET UP STAND UP, pleaded guilty to a charge under ARR.59A for failing to have the Thoroughbred Identification Card (TIC) available for inspection. He was fined \$50.

KOODA DAWN (A. Herrmann) jumped away awkwardly, shifted in and contacted LORD BANNER (A. Patterson). Thereafter KOODA DAWN (A. Herrmann) shifted out abruptly and inconvenienced LORD BANNER (A. Patterson).

In the vicinity of the 900 metres BOSSED (S. Cahill) was inconvenienced by DESTITUTE (M. Hoppo), which shifted in and away from PARMIGIANA (T. Baker), and as a result had to momentarily steady off the heels of GET UP STAND UP (D. Tourneur).

FRAAR'S ROSE (W. Kerford) raced wide without cover throughout the event.

GET UP STAND UP (D. Tourneur) raced greenly in the straight.

RACE 5 : ZEN HOME ENERGY RATING 0-59 HANDICAP - 1215 metres

HERBIE VEEDUB (M. Tyndall) jumped away awkwardly and shifted out onto SIR TRENTIN (A. Patterson), which was inconvenienced.

TAOS LIGHTNING (W. Kerford) jumped away awkwardly and was slow to begin.

In the vicinity of the 400 metres OUR DESTINATION (A. Herrmann) became held up for a short distance when awkwardly placed between the heels of SIR TRENTIN (A. Patterson) and LEATHAL'S LEGACY (P. Marks).

D. Tourneur, the rider of EMPOWERING, reported his saddle slipped back in running rounding the home turn and he became concerned with the mare's action from that point on and as a consequence he did not fully assist his mount over the concluding stages. EMPOWERING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : AURORA OZONE HOTEL RATING 0-59 HANDICAP - 1750 metres

Passing the winning post on the first occasion DASHAGH (S. Cahill) shifted in and tightened CROCMAN (C. Lindop) onto ARE EFF GEE (P. Marks), resulting in CROCMAN and ARE EFF GEE racing in restricted room for a number of strides. Shortly thereafter, in the vicinity of the 1500 metres, TROBEN (A. Patterson), which had commenced to over-race, became awkwardly placed inside the heels of ARE EFF GEE, which shifted in after being corrected.

TROBEN (A. Patterson) was held up for clear running from in the vicinity of the 600 metres until the entrance to the straight when racing behind ISABELLE LASS (M. Hoppo) and inside DASHAGH (S. Cahill).

In the vicinity of the 100 metres RHODES TO GLORY (W. Kerford), which was inclined to lay in, altered course to the inside of EPOCHAL (NZ) (K. Dyson).

RACE 6 : AURORA OZONE HOTEL RATING 0-59 HANDICAP - 1750 metres (Cont'd)

DASHAGH was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. P. Cole, the Trainer of DASHAGH, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 7 : COOPERS KANGAROO ISLAND CUP - 1880 metres

LOTTO BLUES (T. O'Donnell) made the turn near the 1500 metres awkwardly and raced wide for a short distance.

J. Maund, the rider of FRESH TELL, explained his mount was slow to begin and reluctant to gallop in the early stages of the event and as a consequence he was unable to race from a position mid-field as intended. He added that the gelding continued to fail to respond to his riding and in the vicinity of the 800 metres, when attempting to improve around GRANZIG (K. Dyson), FRESH TELL again failed to respond and lost contact with the field as the pace increased. He stated the gelding felt normal in its action and in his opinion did not run a genuine race. FRESH TELL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities other than a lower than expected heart rate.

RACE 8 : PHIL HOFFMAN TRAVEL RATING 0-64 HANDICAP - 1385 metres

FERROQUEST (W. Kerford) stood flat-footed as the gates were released and lost two to three lengths.

FAST EDDIE (T. Baker) became held up for clear running on the heels of KASHINITE (T. O'Donnell) and inside MIDARAS (M. Hoppo) from in the vicinity of the 500 metres until shortly after entering the straight.
