STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks
by the South Australian Jockey Club on Saturday, 10 March 2012

RACE 1 : PROPERTY ROAD HANDICAP - 1950 metres

On jumping away DIRTY ONA DRINK (T. Pannell) and GENERAL MAZERATTI (R. Stewart) brushed.

Near the 400 metres ELECTRONIC MILLION (NZ) (Jordon Frew) rolled in onto GENERAL MAZERATTI (R. Stewart), which was inconvenienced.

T. Pannell, the rider of DIRTY ONA DRINK, explained that backing up three times in three weeks might have had a detrimental effect on the gelding which was under pressure earlier than he had expected.

M. Pegus, the Rider of PORT VELL (NZ), which travelled away from the rail for most of the event, explained that he had been informed the gelding could get pulling and for that reason he was content to allow the gelding to travel where it was comfortable rather than pull it around in running. PORT VELL (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL MAZERATTI sustained a small laceration to the off fore cannon during the event.

RACE 2 : MCCLUSKY & CO PUBLIC RELATIONS HANDICAP - 1000 metres

On jumping away ALLSTAR (L. Hopwood) shifted out onto SHEKINAAR (J. Frew), taking that mare out onto CUSTODIAN (J. Potter), which was inconvenienced and lost its position when tightened onto BELIEVE IN MORE (T. Baker).

SHEKINAAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : HINDMARSH PLUMBING HANDICAP - 1000 metres

LONCAY, which was kicked by another runner behind the barriers, was examined by the Club's Veterinary Surgeon and ruled unfit to race. Acting on that advice, Stewards withdrew LONCAY at 1.33 pm.

RACE 3 : HINDMARSH PLUMBING HANDICAP - 1000 metres (Cont'd)

Shortly after the start MONICA KATE (A. Patterson) rolled out and brushed with TORMENTED (M. Pegus) on several occasions resulting in the filly's hindquarters being turned out and as a consequence it shifted back in on to MONICA KATE, which was inconvenienced.

Making the turn in the vicinity of the 700 metres DAYTONA GREY (C. Lindop) brushed the inside rail.

At the entrance to the straight CUT TO THE CACHE (M. Hoppo) rolled out onto FATHER TONY (D. Tourneur), which was momentarily inconvenienced.

Approaching the finish VELONSKI (S. Cahill) rolled out onto CLEARWATER BAY (P. Gatt) taking the filly out.

LANGUISH was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. A. Freedman, the Trainer of LANGUISH, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

CLEARWATER BAY and VELONSKI were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

EXALTED BROTHER lost its near fore plate during this event.

RACE 4 : CARBINE CLUB HANDICAP - 1400 metres

LUCARIO (NZ) jumped away awkwardly and shortly after the start was inconvenienced by GLACIAL MISS (M. Neilson) when taken wide.

FURLINE (J. Holder) jumped away awkwardly.

Making the turn in the vicinity of the 600 metres GLACIAL MISS (M. Neilson) shifted out onto CELLARMASTER (NZ) (S. Westover), which was inconvenienced.

Approaching the 500 metres CELLARMASTER (NZ) (S. Westover) rolled in onto GLACIAL MISS (M. Neilson), which was inconvenienced.

From the 200 metres PARIS MEMORY (P. Gatt) was eased out of the event. P. Gatt explained in his opinion the mare was exhibiting lameness in a foreleg and for that reason did not persist in his riding. PARIS MEMORY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of GLACIAL MISS, explained he had intended to settle a little further back, however, the mare was difficult to manage and over-raced in the early stages. He stated that in the vicinity off the 800 metres he had become concerned that GLACIAL MISS would not finish off its race and under pressure had been disappointing. He added the pace of the race may not have suited GLACIAL MISS. GLACIAL MISS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. Robinson, representing Mr. A. McEvoy, undertook to report any abnormalities detected in post race examinations.

Correct Weight for this race was delayed to allow M. Neilson, the rider of the fourth placegetter GLACIAL MISS, to view the official vision in the vicinity of the 600 metres.

RACE 5 : PORTOBELLO MAGIC HANDICAP - 1400 metres

GRAND TITLE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg and to have speedy cutting on the off hind pastern. Mr. S. Dodd, the Trainer of GRAND TITLE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 6 : PRO PAINT 'N' PANEL HANDICAP - 1000 metres

HEAVEN FOR SURE (L. Stojakovic), HEURIGER (B. Hoppo) and COLUMBUS (N. Rose) were slow to jump.

Shortly after the start COUNTER SIGN (C. Lindop) shifted out onto HEAVEN FOR SURE (L. Stojakovic), which was inconvenienced when tightened onto HEURIGER (B. Hoppo).

From the 500 metres HEAVEN FOR SURE (L. Stojakovic) was inclined to hang out and as a consequence, made the turn into the straight wide. HEAVEN FOR SURE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr. B. Bogarts, the Trainer of HEAVEN FOR SURE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Near the 400 metres PIXIU (J. Holder) became held up when racing between STRIDING SUCCESS (J. Maund) and COUNTER SIGN (C. Lindop).

At the entrance to the straight, when attempting to improve, COUNTER SIGN (C. Lindop) shifted out and contacted FLYING MERKEL (S. Westover), which was inconvenienced.

From the vicinity of the 300 metres until inside the 200 metres PIXIU (J. Holder) was unable to obtain clear ground when racing inside COUNTER SIGN (C. Lindop), which rolled in, and behind GRAND TAJ (M. Tyndall), which had commenced to give ground.

RACE 7 : ROB HODGE HANDICAP - 1250 metres

LITTLE MISS BOURKE (M. Pegasus) was slow to jump and shortly afterwards was inconvenienced by BELLEAP (J. Potter), which shifted out.

THAWAABET (P. Gatt) jumped away awkwardly and shortly afterwards was hampered when tightened between SHESHOOTSSHESCORES (T. Pannell), which shifted out, and HERE DE SPEAKER (R. Stewart), as a result of that filly being taken in by LA VITA MOMENTO (M. Hoppo).

Inside the 1200 metres HEX (D. Moor) shifted in onto BELLEAP (J. Potter), which was forced to check, losing its position, when taken in onto LADY AKATAK (J. Frew), which was checked, losing its position when tightened for room. D. Moor pleaded guilty to a charge of Careless Riding under ARR.137(a) in that he permitted his mount to shift ground when insufficiently clear. He was suspended from riding in races for a period to commence at midnight on Saturday, 17 March and to conclude at midnight on Wednesday, 28 March 2012; a period of six (6) meetings.

Making the turn in the vicinity of the 800 metres NASSAU (M. Neilson) became awkward and lost its position.

In attempting to avoid the heels of NASSAU (M. Neilson), HEX (D. Moor) shifted out onto MAGIC MILADY (C. Lindop), which thereafter was obliged to race wide without cover.

Approaching the 600 metres NASSAU (M. Neilson), which was inclined to lay out, MAGIC MILADY (C. Lindop) and HEX (D. Moor) continued to brush on several occasions.

RACE 7 : ROB HODGE HANDICAP - 1250 metres (Cont'd)

Correct Weight for this event was delayed to permit D. Moor, the rider of the third placegetter HEX, to view the official footage from the 800 metres.

HEX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : PAGEL GLASS HANDICAP - 1550 metres

On jumping away OUR IRIDIUM (S. Westover) knuckled.

SOUTHERN FORTUNE (A. Patterson) jumped away awkwardly and shifted out onto OUR IRIDIUM (S. Westover), which was inconvenienced.

PENN STATION (NZ) (C. Lindop) was obliged to race wide without cover throughout the event.

Approaching the 400 meters ROMAN EYE (C. Lever) was obliged to steady away from the heels of TICKET TO VEGAS (J. Frew).

After entering the straight until the vicinity of the 200 metres TICKET TO VEGAS (J. Frew) had difficulty obtaining clear ground when racing on the heels of OUR IRIDIUM (S. Westover) and inside QUEEN'S FASHION (P. Gatt), which maintained a tight line.

After entering the straight QUEEN'S FASHION (P. Gatt) was unable to obtain clear ground until approaching the 100 metres.
