RACE 1 – FLINDERS PORTS RATING 0-64 HANDICAP – 1000 metres

JACKIE'S PAPER (P. Roff) was slow to begin.

RACE 2 – THEVENARD IGA / SABOIS MAIDEN PLATE - 1000 metres

The start of this race was delayed owing to NORTH HILL proving difficult to load. Mr T. Haddy, the Trainer of NORTH HILL, was advised a warning had been placed on the gelding in respect to its loading manners.

MASTER EVERETT (D. Evans) and NORTH HILL (P. Roff) were slow to begin.

Inside the 200 metres MUMAJET (M. Henderson) was inclined to lay in under pressure for a short distance.

MASTER EVERETT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 - MGA INSURANCE RATING 0-59 HANDICAP - 1200 metres

In the early stages of the straight, PICTORELLA (K. Bishop) laid in under pressure.

RACE 4 - VITERRA THEVENARD CUP - 1600 metres

As there was no other rider available, Stewards permitted L. Miller to ride MISS ABERDEEN half a kilogram over the allotted weight.

- P. Roff, the rider of MEI WENTI, explained in his opinion he felt the gelding had not responded to his riding and as a consequence he eased the gelding out of the event in the vicinity of the 200 metres. MEI WENTI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- D. Evans, the rider of SUPER HIT, was questioned regarding his use of the whip prior to the 100 metres. D. Evans pleaded guilty to a charge under ARR.137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded.

RACE 5 – FLINDERS PORTS RATING 0-64 HANDICAP – 1400 metres

KONOWALCHUK (K. Bishop) was inclined to rear when the gates were released.

DIAMOND JUDDY was examined by the Club's Veterinary Surgeon who reported a suspensory ligament injury to the near foreleg. First Aid was administered. Ms. S. Williams, the Trainer of DIAMOND JUDDY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
