**STIPENDIARY STEWARDS REPORT**

**Report on Race Meeting held at Clare Racecourse**  
**by the Clare Valley Racing Club on Sunday, 11 March 2012**

**TRACK: Good 3**

**RACE 1 : KIRRIHILL WINES / SABOIS DISTANCE MAIDEN PLATE - 1800 metres**

On jumping away BESA BOLA (D. Tourneur) shifted out brushing BOOLCUNDA GOLD (J. Toeroek), which shifted in.

Approaching the 400 metres BOOLCUNDA GOLD (J. Toeroek) hung out.

Inside the 300 metres ALL ROSES (L. Stojakovic) laid out.

Approaching the finish ALL ROSES (L. Stojakovic) was eased out of the race. L. Stojakovic reported she had become concerned with the mare's action from the home turn, so she elected not to place the mare under pressure over the final stages of the event. ALL ROSES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ALL ROSES lost its off hind plate during the event.

BOOLCUNDA GOLD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : MAYORS CUP (RATING 0-71 HANDICAP) - 1200 metres**

ANOTHER DISCUSSION (J. Frew) jumped away awkwardly.

Approaching the 400 metres ANOTHER DISCUSSION (J. Frew) became held up momentarily on the heels of UNDER THE RADAR (D. Tourneur).

Approaching the 200 metres ANOTHER DISCUSSION (J. Frew) shifted out and brushed EUREKA REIGN (J. Toeroek).

**RACE 3 : MAGIC FM / 5CS / SABOIS 3YO MAIDEN PLATE - 1200 metres**

VIVA LA RANGA (T. Pannell) raced keenly in the middle stages of the event.

Inside the 300 metres RAVENHURST (J. Holder) became held up momentarily on the heels of MYKONOS SUNSET (K. Bishop).

MYKONOS SUNSET (K. Bishop) was inclined to lay in, on entering the home straight.

**RACE 4 : CARDINHAM ESTATE / SABOIS MAIDEN PLATE - 1100 metres**

RUSTLE (D. Tourneur) shifted out on jumping away, resulting in BON CHERIE (L. Stojakovic) being inconvenienced.

#### **RACE 4 : CARDINHAM ESTATE / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)**

OH SO APPEALING (L. Hopwood) jumped away awkwardly brushing VALIK (J. Potter), taking that gelding in onto QUBELLE (J. Toeroek), at the same time as MADAM DAWN (T. Zanker) shifted out on jumping away, resulting in QUBELLE having to race in restricted room for a short distance.

Shortly after the start VALIK (J. Potter) continued to lay away from OH SO APPEALING (L. Hopwood) resulting in QUBELLE (J. Toeroek) being inconvenienced.

Inside the 600 metres DESTITUTE (M. Hoppo) commenced to lay out and continued to do so for the remainder of the race.

Inside the 300 metres OH SO APPEALING (L. Hopwood) laid out and commenced to lose ground. OH SO APPEALING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Hoppo, the rider of DESTITUTE, reported that when he placed the mare under pressure from inside the 600 metres, she failed to respond to his riding and laid out. DESTITUTE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct Weight for this event was delayed to allow J. Holder, the rider of the second placegetter QUENCH, and that filly's Trainer Mr. J. O'Connor, to view the official photo for first.

MISS KERCHING, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 5 : M J HALLET GENERAL BUILDERS / SABOIS FILLES AND MARES RATING 0-68 HANDICAP - 1800 metres**

The start of this event was delayed one minute to owing to a delay interstate.

Racing to the 400 metres HOME ON THE RIVER (J. Toeroek) laid out brushing TWILIGHT DANCER (B. Claridge). Shortly after TWILIGHT DANCER laid in onto HOME ON THE RIVER, which had to be steadied momentarily.

J. Potter, the rider of ALICE LONGING, was questioned regarding his use of the whip after passing the winning post. He pleaded guilty to a charge under ARR.137A(4)(e) and was fined \$100.

J. Maund, the rider of CONTANI, explained the mare did not feel the same as it did at its previous start at Strathalbyn at any stage throughout the event and when placed under pressure at the 600 metres CONTANI failed to respond to his riding. CONTANI was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Mr. C. Bromley, the Trainer of CONTANI, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

#### **RACE 6 : JIM BARRY WINES COLTS, GELDINGS AND ENTIRES RATING 0-59 HANDICAP - 1100 metres**

The start of this event was delayed three minutes owing to a delay interstate.

CLUB HA HA (W. Kerford) reared on jumping away and as a result was slow to begin.

Inside the 300 metres MONOTONE (J. Maund) rolled in under pressure onto SELBOURNE ROAD (S. Westover) taking that gelding in onto CLUB HA HA (W. Kerford), which was obliged to steady to avoid the heels of SELBOURNE ROAD.

**RACE 6 : JIM BARRY WINES COLTS, GELDINGS AND ENTIRES RATING 0-59  
HANDICAP - 1100 metres (Cont'd)**

W. Kerford, the rider of CLUB HA HA, explained the gelding had never travelled well during the event. He added that he had placed CLUB HA HA under pressure inside the 800 metres but it failed to respond to his riding and had finished the race off poorly. CLUB HA HA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HERBIE VEEDUB was examined by the Club's Veterinary Surgeon who reported the horse had suffered a bi-lateral bleeding attack during the event. Mr. R. Moore, the Trainer of HERBIE VEEDUB, was advised the horse was suspended from racing for a period of three (3) months in accordance with ARR.53A.

**RACE 7 : WOODSHIELD RATING 0-59 HANDICAP - 1700 metres**

Mr. B. Searle, the Trainer of CLUSO, advised Stewards he would instruct his rider J. Potter to try and find cover behind the pace if possible.

The start of this race was delayed approximately two minutes owing to CLUSO's starting gate releasing prematurely allowing the gelding to break from the gates. CLUSO was quickly restrained and examined by the Club's Veterinary Surgeon who ruled the gelding fit to start.

CLUSO (J. Potter) jumped away awkwardly.

Approaching the winning post on the first occasion ISABELLE LASS (L. Stojakovic), which was racing ungenerously, was obliged to steady when KINGS AND JACKS (J. Maund) improved to its outside.

MASTER ROBBIE (T. Zanker) raced wide without cover in the early and middle stages of the event.

Inside the 300 metres CLUSO (J. Potter) became held up momentarily on the heels of WALCOURT (S. Westover).
