Report on Race Meeting held at Streaky Bay Racecourse

RACE 1 : LETCHER & MORONEY CHARTERED ACCOUNTANTS/SABIOS MAIDEN PLATE
- 1000 metres

NORTH HILL (Jemma Frew) was slow to jump.

Approaching 400 metres NORTH HILL (Jemma Frew) was inclined to race greenly and lay out.

Inside the 200 metres MUMAJET (M. Henderson) laid out under pressure.

RACE 2 : BECK'S IGA & SIP N SAVE RATING 0-64 HANDICAP - 1000 metres

TRENDEAZ (T. O'Donnell) jumped away awkwardly and shifted in brushing REAL JACK (P. Roff).

Inside the 400 metres TRENDEAZ (T. O'Donnell) laid out for a short distance.

RACE 3 : STEAKY BAY RACING CLUB'S VALUED SPONSORS RATING 0-59 HANDICAP
- 1200 metres

On arrival on course JUST CALL ME BOB was examined by the Club's Veterinary Surgeon who reported the gelding, which had scrambled in the float en-route to the course, had superficial abrasions to all legs & significant swelling to its near fore fetlock and was ruled unfit to race. Acting on that advice, Stewards withdrew JUST CALL ME BOB at 12.25pm.

Inside the 300 metres until the 200 metres YOUKNOWTHERULES (D. Evans) became held up for a run when attempting a run to the inside CENTRED (J. Kah) and to the outside of PICTORELLA (K. Bishop), as that mare rolled out.

Inside the 200 metres YOUKNOWTHERULES (D. Evans) shifted out to obtain clear running and in doing so brushed with CENTRED (J. Kah).

Approaching the 50 metres YOUKNOWTHERULES (D. Evans) became held up on the heels of FIRER ME (M. Neve), which rolled in. YOUKNOWTHERULES shifted out to obtain clear running and in doing so made contact with CENTRED (J. Kah).

Correct Weight for this event was delayed to permit D. Evans, the rider of the third placegetter YOUKNOWTHERULES, and the gelding's Trainer Mr. T. Dawson, to view the official footage from the 500 metres.

RACE 4 : LINCOLN ESTATE WINES 0-68 HANDICAP - 1400 metres

The start of this event was delayed approximately 20 minutes to allow the ambulance staff to attend to a member of the public.

Over the concluding stages SUNPOINT (W. Kerford) was inclined to lay in.

HARAKA ZULU (D. Evans) laid in, in the straight. HARAKA ZULU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : XXXX GOLD STREAKY BAY COMMUNITY HOTEL CUP - 1800 metres

The start of this race was delayed for 15 minutes due to the delay in the previous race.

On jumping away DUJAC (T. O'Donnell), which jumped away awkwardly, shifted out onto GENEROUS HUKA (NZ) (D. Evans) taking that gelding out onto the heels of STREET RELATED (M. Henderson) obliging GENEROUS HUKA to be steadied, losing its position.

RACE 6 : STREAKY BAY & CEDUNA MEAT SERVICE RATING 0-58 HANDICAP - 1800 metres

The start of this race was delayed by five minutes due to the delay in the previous race.

On jumping away BRACKEN BLUE (W. Kerford) lost its footing in front, and as a result was slow to begin.

KONOWALCHUK (K. Bishop) raced wide in the early and middle stages.

SUNPOINT which performed below expectation was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
