RACE 1 : WILFRED GEORGE PAGE MEMORIAL RATING 0-59 HANDICAP
- 1000 metres

AKHA ROSE (T. O'Donnell) began awkwardly, shifted out and tightened JET FUSION (D. Evans) onto BUSTERWABBIT (W. Kerford).

JET FUSION (D. Evans) raced greenly and got its head up in the early stages.

Inside the 400 metres LORD BANNER (J. Kah) rolled in resulting in REAL JACK (P. Roff) having to be steadied and alter course. J. Kah was reminded of her obligations when her mounts commence to shift ground in future.

In the vicinity of the 200 metres LORD BANNER (J. Kah) rolled out taking REAL JACK (P. Roff) wider on the course. J. Kah was reminded of her obligations when her mounts commence to shift ground.

Correct weight for this event was delayed to enable Stewards to review the start.

RACE 2 : CEDUNA FORESHORE HOTEL MOTEL / SABOIS MADIEN PLATE
- 1200 metres

Stewards conceded to a request from D. Evans to be stood down as the rider of EMILY'S CHARM owing to medical grounds which were considered temporary of nature.

EMILY'S CHARM (L. Miller) stood flat footed at the start and as a result was slow to begin.

Inside the 200 metres JUST A BIT OF LUCK (M. Tyndall) was obliged to alter course to avoid the heels of PERFECTNESS (NZ) (J. Kah) which shifted out. J. Kah was reminded of her obligations when her mounts commence to shift ground in future.

EMILY'S CHARM (L. Miller), which had raced greenly throughout the event, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. T Dawson representing Mr. D. Carrison, the Trainer of EMILY'S CHARM, was advised the filly was suspended from racing until it can prove tractable in an Official Barrier Trial prior to accepting for a future event.

RACE 3 : CALTEX SE FUEL / PENONG STORE RATING 0-68 HANDICAP - 1200 metres

Prior to presenting for his ride in this race D. Evans was passed fit to ride by the ambulance personal.

Prior to the running of this event BUSTER TYPHOON was examined by the Club's Veterinary Surgeon and ruled fit to start.

BUSTER TYPHOON (E. Boyd) was slow to begin.

L. Miller, the rider of THE SNITCH, was reminded of his obligations to not make any celebratory gestures after the winning post.

RACE 4 : FAR WEST FARMERS PENONG CUP - 1600 metres

BRACKEN BLUE (W. Kerford) and GRANZIG (L. Miller) were slow to begin.

RACE 5 : - PENONG TRUCK STOP / PENONG HOTEL RATING 0-59 HANDICAP
- 1400 metres

W. Kerford, the rider of MALEBO MAGIC, reported that the mare dipped in the vicinity of the 1000 metres.
