# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

## Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Sunday, 25 March 2012

#### RACE 1 : KINGSFORD HOTEL / SABOIS DISTANCE MAIDEN PLATE - 2100 metres

BOOLCUNDA GOLD (L. Stojakovic) and CORNISH LAD (D. Tourneur) began awkwardly.

BOOLCUNDA GOLD (L. Stojakovic), which jumped the crossing near the 1800 metres, shifted out shortly thereafter and inconvenienced BAKLAVA BOY (NZ) (J. Holder), which made the crossing awkwardly, resulting in BAKLAVA BOY (NZ) having to be steadied to avoid the heels of BOOLCUNDA GOLD. Thereafter BOOLCUNDA GOLD was inclined to lay out.

POWER TO POSSESS (B. Claridge) became held up for clear running for a short distance, racing to the 400 metres when racing behind SUMMER WITH ROSIE (NZ) (W. Kerford).

BOOLCUNDA GOLD (L. Stojakovic) laid out rounding the home turn racing wide into the straight. BOOLCUNDA GOLD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### RACE 2 : GAWLER SOUTH BAKERY / SABOIS 3YO MAIDEN PLATE - 1500 metres

The start of this event was delayed approximately one minute owing to a number of horses proving difficult to load.

CONSIDER THIS (B. Hoppo) was slow to begin.

PRIDE OF OLIVIA (D. Tourneur) jumped away awkwardly.

Approaching the 600 metres CONSIDER THIS (B. Hoppo) appeared to clip the heels of runners in front, stumbled and dislodged B. Hoppo. An inquiry into this report was adjourned as B. Hoppo was transported to hospital for observation.

In the vicinity of the 200 metres MISS PRACTICALITY (J. Potter) raced in restricted room for a number of strides between KOOP CREEK (J. Toeroek) to its inside, and SHESHOOTSSHESCORES (T. Pannell) to its outside, which had commenced to lay in.

# RACE 2 : GAWLER SOUTH BAKERY / SABOIS 3YO MAIDEN PLATE - 1500 metres (Cont'd)

CONSIDER THIS was examined by the Club's Veterinary Surgeon who reported the gelding was suffering from cardiac arrhythmia and to be lame in the off hind leg. First Aid was administered. Mr. P. Cole, the Trainer of CONSIDER THIS, was advised a Veterinary Certificate of Fitness, including the results of an ECG, would be required and in addition the horse is to perform satisfactorily in an Official Barrier Trial prior to its next race start.

PRIDE OF OLIVIA (D. Tourneur) laid in throughout in the straight.

#### RACE 3: KNIGHTS ROSES / SABOIS MAIDEN PLATE - 1700 metres

VILLE DE BERNE, which struck the fence on leaving the mounting yard, was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to race.

Approaching the 1500 metres VILLE DE BERNE (L. Stojakovic) became tight when racing between CENTRE RIPPLE (K. Dyson) which rolled out, and LORD DUNRICH (NZ) (T. Baker) which shifted in, resulting in VILLE DE BERNE having to be steadied, losing its position.

Approaching the 1300 metres VILLE DE BERNE (L. Stojakovic) commenced to over race when the pace slackened.

MISS DOUBTFIRE (M. Neilson), LITTLE BUSTER (J. Potter) and UMALUKA (C. Lever) were all inclined to over race in the middle stages of the event.

Inside the 1200 metres LORD DUNRICH (NZ) (T. Baker) got its head up and raced ungenerously on the heels of CENTRE RIPPLE (K. Dyson) for a number of strides.

### RACE 4 : COCO-COLA / SABOIS MAIDEN PLATE - 1200 metres

Mr. M. Minervini, the Trainer of GLAMOROUS, was questioned regarding the Thoroughbred Identification Card not being available for the filly. As Stewards were able to establish the identity of GLAMOROUS from records held by them, the filly was permitted to start. Having considered the explanation provided, Mr. M. Minervini was fined \$50 under ARR.59A.

THE PEARLY GATES (T. Pannell), ALBATROSS (M. Neilson) and JUNOOD (T. Baker) jumped away awkwardly.

POP THE BUBBLE (T. Zanker) shifted out shortly after the start onto MORE THAN MUDDY (C. Lever) taking that horse out onto SIR GILES (K. Bishop) resulting in MORE THAN MUDDY and SIR GILES being inconvenienced

In the vicinity of the 500 metres POP THE BUBBLE (T. Zanker) rolled in taking KHALAH ROSE (L. Miller) in onto SIR GILES (K. Bishop) resulting in contact between these two horses and KHALAH ROSE being hampered.

SPURPARTS (J. Maund) became held up for clear running inside the heels of MORE THAN MUDDY (C. Lever) from in the vicinity of the 200 metres as MORE THAN MUDDY commenced to weaken and as a consequence SPURPARTS was unable to obtain clear running for the remainder of the event.

At the entrance to the straight PRESIDIUM (R. Stewart), which raced greenly, shifted out and inconvenienced GLAMOROUS (S. Cahill) which was taken wider and shifted out and away from PRESIDIUM. Thereafter approaching the 100 metres PRESIDIUM again shifted out and inconvenienced GLAMOROUS, which was taken out away from its rightful running line, losing its momentum. Over the concluding stages of the event, PRESIDIUM again shifted out and inconvenienced GLAMOROUS, which was taken wider.

## RACE 4 : COCO-COLA / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

Correct Weight for this event was delayed to permit S. Cahill, the rider of the second placegetter GLAMOROUS, to view the official footage in the straight. After doing so S. Cahill lodged an objection against PRESIDIUM (R. Stewart), being declared the winner on the grounds of alleged interference from the top of the straight to the finish on three separate occasions. After considering the evidence, on viewing the official footage and acting on their own observations Stewards *upheld* S. Cahill's objection.

#### RACE 5: TARRAWATTA MARES 0-68 HANDICAP - 1500 metres

HOME ON THE RIVER (T. Zanker) and SING SONG DANCE (L. Stojakovic) were awkward to begin.

INDEE'S HOPE (W. Kerford) raced wide without cover in the middle stages of the event.

M. Neilson, the rider of EXALTED VALUE, reported that this mare raced in a dower manner. EXALTED VALUE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 6: WATERSEARCH RATING 0-68 HANDICAP - 2100 metres

CASH ADVANCE was examined by the Club's Veterinary Surgeon on arrival at the barriers and found to be lame in the near foreleg. Acting on that advice, Stewards withdrew CASH ADVANCE at 3.33pm. Mr. J. O'Connor, the Trainer of CASH ADVANCE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

SIR ANTHONY (M. Neilson) raced keenly in the early stages.

In the vicinity of the 1600 metres IT'S A DUD (NZ) (J. Maund) rolled out and away from the heels of RIKBAT (D. Evans) and inconvenienced CHUDLEIGH (J. Potter).

SALLUM (Jemma Frew) raced keenly in the early stages and approaching the 1600 metres raced in restricted room for a number of strides when improving onto the heels of runners.

SOUTHERN FORTUNE (M. Pegus) raced wide without cover in the middle stages of the event.

D. Evans, the rider of RIKBAT, was reprimanded under ARR.137(c) for making a celebratory gesture prior to the winning post.

Jemma Frew, the rider of SALLUM, was reminded of her obligations when using the whip when her mounts are out of contention.

C. Lever, the rider of CHIEF RED HAWK, explained that he was obliged to race wide without cover from inside the 600 metres whilst improving his position and after entering the straight the horse had every opportunity but did not respond in the manner he had expected over the concluding stages and finished the race off only fairly. CHIEF RED HAWK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 7: COOPERS PALE ALE RATING 0-75 HANDICAP - 1500 metres

BOOM TRADER (T. Zanker) began awkwardly.

In the vicinity of the 1200 metres MAHMENTUM (L. Hopwood) shifted in when awkwardly placed inside the heels of TASTEOFENERGY (J. Maund) and tightened OUI SI ATTITUDE (T. Pannell) onto PENN STATION (NZ) (J. Holder), which rolled in onto BELLE ADDICTION (J. Toeroek) and brushed with this horse, resulting in BELLE ADDITION over-reacting when tightened onto the fence, losing its action and becoming unbalanced. L. Hopwood was reminded of her obligations when shifting ground.

SAVVY SMOKIN' was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off side cannon. First Aid was administered.

#### RACE 8: THE BETTY HAYES MEMORIAL CLASS 1 HANDICAP - 1200 metres

CANNY PREVAIL (M. Tyndall) reared at the start and then raced in restricted room for a short distance shortly after the start between DO IT NOW (D. Evans) and WINDERMERE ROAD (J. Potter) which both shifted ground marginally.

KOODA DIVA (T. Zanker) reared at the start.

MUSTANG SCHILLER (S. Cahill) was slow to begin.

Inside the 800 metres MUSTANG SCHILLER (S. Cahill) was obliged to be restrained off the heels of FOLAU (M. Neilson) when awkwardly placed on the heels of that runner and as a consequence MUSTANG SCHILLER shifted out wider.

ANOTHER DISCUSSION (Jordon Frew), which raced keenly, was obliged to be restrained off the heels of CALIFORNIAN DEVIL (K. Bishop) in the vicinity of the 800 metres.

In the vicinity of the 450 metres CALIFORNIAN DEVIL (K. Bishop) became held up for clear running on the heels of DO IT NOW (D. Evans) and CANNY PREVAIL (M. Tyndall) until near the entrance to the straight.

ANOTHER DISCUSSION (Jordon Frew) became disappointed for clear running for a short distance shortly after entering the straight between the heels of DO IT NOW (D. Evans) and CANNY PREVAIL (M. Tyndall) and was obliged to alter course to the inside of DO IT NOW to obtain clear running.

In the vicinity of the 300 metres, BOLD FURY (Jemma Frew), which had improved its position, was obliged to alter course to the inside of BICKER (J. Maund) to obtain clear running. Shortly thereafter, when improving to the inside of CANNY PREVAIL (M. Tyndall), BOLD FURY was further disappointed for clear ground and altered course to the outside of CANNY PREVAIL.

Approaching the 100 metres BOLD FURY (Jemma Frew) shifted out abruptly away from CANNY PREVAIL (M. Tyndall) which had shifted out and away form DO IT NOW (D. Evans) as that horse rolled out under pressure resulting in BOLD FURY shifting ground outwards towards KOODA DIVA (T. Zanker) which was inconvenienced when taken wider.

After passing the winning post near the crossing DO IT NOW (D. Evans) accidentally clipped the heels of BICKER (J. Maund) dislodging D. Evans, who was examined by the on course Ambulance staff and passed fit.

WINDERMERE ROAD was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off hind fetlock. First Aid was administered.
