# Report on Race Meeting held at the Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 22 April 2012

## RACE 1 : LIMESTONE COAST BOOKMAKERS / SABOIS MAIDEN PLATE - 1000 metres

The start of this race was delayed approximately three minutes owing to K. Post, the rider of I AM HARRY, being struck in the face by this gelding at the barriers. K. Post was examined by the on course ambulance staff who declared him fit to ride.

ELKE (K. Kawakami), I AM HARRY (K. Post) and FRADEMA (H. McKechnie) began awkwardly.

I AM HARRY (K. Post) raced greenly throughout the event.

SPLURGE (C. Lever) laid in, in the straight.

JEUNE KING CARLOS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. D. Kolpin, the Trainer of SPLURGE, was reprimanded under ARR.54.1 for failing to lodge a Stable Return indicating the ownership details in respect of this filly.

#### RACE 2: HAGE TRACTORS RATING 60 & OVER HANDICAP - 1200 metres

CUSTODIAN (D. Tourneur) jumped away awkwardly.

In the vicinity of the 500 metres SWIPER (NZ) (P. Marks) shifted in and inconvenienced FLAMING SAMBUCA (A. Herrmann) which was obliged to steady when taken in. Thereafter SWIPER (NZ) laid in for the remainder of the event.

#### RACE 2: HAGE TRACTORS RATING 60 & OVER HANDICAP - 1200 metres (Cont'd)

H. McKechnie, the rider of CASINO MISS, explained that although initially beginning well, from in the vicinity of the 500 metres the mare felt awkward in its action behind and dipped on a number of occasions and commenced to give ground quickly. As a consequence she eased this mare out of the event shortly thereafter. CASINO MISS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3: NARACOORTE TOYOTA RATING 60 & OVER HANDICAP - 2000 metres

The start of this event was delayed approximately eight minutes to allow for maintenance and repair work to be conducted in the vicinity of the 700 metres.

THE CASTLE (NZ) (Jemma Frew) and BISHOP OF DERRY (M. Tyndall) jumped away awkwardly.

#### RACE 4: NARACOORTE TOYOTA / SABOIS MAIDEN PLATE - 1430 metres

The start of this race was delayed approximately one minute owing to the delay experienced in Race 3.

MOVIE'S LAST STAND (M. Tyndall) was slow to begin.

HIDDEN COSTS (W. Kerford) raced ungenerously in the early stages.

PUZZLEMAN (J. Toeroek) raced wide in the middle stages of the event.

Approaching the 400 metres I'M A MENICE (D. Tourneur) became held up for a short distance when racing behind DASH OF VICTORY (S. Harrison) and to the inside of LOTS OF DOLLARS (H. McKechnie) and was obliged to alter course to the outside of DASH OF VICTORY to obtain clear running.

Approaching the 100 metres PUZZLEMAN (J. Toeroek), which commenced to lay in, shifted in under riding taking the running of TZARISTA (A. Patterson) which had to be steadied to avoid the heels of PUZZLEMAN and alter course to this horse's outside. J. Toeroek was severely reprimanded and advised in future he should stop riding and straighten his mounts when they commence to shift ground.

#### RACE 5: SOUTHEAST MOTOR CO. RATING 0-65 HANDICAP - 1100 metres

AFFECTIONATE ONE (K. Kawakami) was slow to begin.

SANDHILL TESS (D. Tourneur) was awkward and slow to begin.

AFFECTIONATE ONE (K. Kawakami) got its head up and raced ungenerously in the early stages of the event.

GAUSS (P. Marks) jumped away awkwardly, shifted out and contacted NAUGHTY MOMENTS (J. Cartwright) and shortly thereafter shifted back in onto DELCANOS (A. Herrmann) which began awkwardly, resulting in DELCANOS being taken in and inconvenienced.

## RACE 6 : SOUTH EAST COLLISON REPAIR CENTRE RATING 0-76 HANDICAP - 1430 metres

Jordan Frew pleaded guilty to a charge under ARR.120(b) and was fined \$100 for being overweight and having to be replaced on MELETE.

Correct weight was delayed to allow K. Walters to view the vision in the straight.

#### RACE 7: NARACOORTE FREIGHT CENTRE RATING 0-59 HANDICAP - 2000 metres

The start of this race was delayed approximately two minutes owing to IMAGINARIUM (Jemma Frew) taking charge of its rider behind the barriers and galloping for some distance before being returned to the mounting yard. IMAGINARIUM was withdrawn by order of Stewards at 4.04pm.

FLYING FIRST CLASS (C. Lever) began awkwardly.

MARKER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 8: NARACOORTE VETERINARY CENTRE RATING 0-59 HANDICAP - 1430 metres

In the vicinity of the 400 metres WILFUL LAD (J. Cartwright), which improved into a tight run between WAIT FORETTE (Jordan Frew) to its inside and CELTIC GHOST (A. Patterson) which had improved quickly to its outside, was obliged to be checked and lost its position as WAIT FORETTE and CELTIC GHOST rolled slightly.

In the vicinity of the 300 metres BACK TRACKS (A. Herrmann) was obliged to steady for a number of strides off the heels of DEVIOUS FLIGHT (C. Puls) which commenced to give ground.

D. Evans, the rider of CRUZ'N NOW, pleaded guilty to a charge under ARR.137(a) for carelessness in dropping his whip inside the 100 metres and was fined \$50.
