THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Thursday, 19 April 2012

RACE 1: HINDMARSH PLUMBING MAIDEN PLATE - 2050 metres

BABY BOY, which was kicked by another runner on arrival at the barriers, was examined by the Club's Veterinary Surgeon and passed fit to race.

KING ROSELAND (D. Tourneur) jumped away awkwardly, shifted out and inconvenienced ROSCREA ROSE (S. Westover) which was tightened onto MISS PRACTICALITY (P. Gatt) as that horse was taken in by HOBBS (J. Holder). As a consequence, MISS PRACTICALITY and ROSCREA ROSE were tightened and lost their positions.

MASKED INVADER (C. Lever) pulled hard in the early stages of the event.

In the vicinity of the 1100 metres KING ROSELAND (D. Tourneur) became awkwardly placed on the heels of HOBBS (J. Holder) for a short distance.

Approaching the 400 metres MASKED INVADER (C. Lever), which was inclined to lay out and weakened, was inconvenienced and obliged to steady off the heels of HOBBS (J. Holder) as that horse rolled in. J. Holder was reminded of his obligations when shifting ground in future.

In the vicinity of the 400 metres ROSCREA ROSE (S. Westover) rolled in and momentarily inconvenienced BAKLAVA BOY (NZ) (C. Lindop).

In the vicinity of the 300 metres ROSCREA ROSE (S. Westover) shifted in abruptly and crossed the running of BAKLAVA BOY (NZ) (C. Lindop), which had to be steadied to avoid the heels of ROSCREA ROSE. S. Westover was reminded of his obligations when his mounts commence to shift ground.

M. Neilson, the rider of SAIN ACADEMY, reported his mount was under pressure during the race and failed to respond to his riding and for that reason he eased his mount out of the event shortly after the entrance to the straight. A subsequent examination of SAIN ACADEMY by the Club's Veterinary Surgeon established that this gelding had suffered a bilateral bleeding attack. Mr. T. McEvoy, the Trainer of SAIN ACADEMY, was advised the gelding was suspended from racing for a period of three (3) months in accordance with ARR.53A.

RACE 1: HINDMARSH PLUMBING MAIDEN PLATE - 2050 metres (Cont'd)

MASKED INVADER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. J. Smith, the Trainer of MASKED INVADER, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race. Mr. J. Smith advised Stewards that MASKED INVADER would now be spelled.

RACE 2: JANSZ MAIDEN PLATE - 1050 metres

MRS WOLFE (L. Hopwood) jumped away awkwardly.

THE BOILERMAKER (D. Tourneur) jumped away awkwardly and shifted in onto GREISEN (C. Lever) which was tightened onto HEZAFRAAR (C. Lindop) as that horse began awkwardly and shifted out, resulting in GREISEN being hampered and losing its position.

C. Lever, the rider of GREISEN, reported the filly made a breathing noise during the event. GREISEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: EXPRESS COLOUR PRINTING MAIDEN PLATE - 1100 metres

BARELY A BEAT (L. Hopwood) jumped away very awkwardly.

WEEKEND AT BERNIES (C. Lindop) jumped away awkwardly.

DOUBLE GREY (A. Herrmann) jumped away awkwardly and was then slow into stride.

Near the 500 metres BARELY A BEAT (L. Hopwood) raced in tight room for a number of strides on the heels of DOUBLE GREY (A. Herrmann) and to the inside of WEEKEND AT BERNIES (C. Lindop).

- P. Gatt, the rider of DANCER'S DREAM, explained the filly travelled well in the early stages but shortly after the entrance to the straight, felt short in its action in front and failed to respond to his riding in the manner he expected. DANCER'S DREAM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- M. Neilson, the rider of WHITTEN'S DELIGHT, was questioned regarding his use of the whip prior to the 100 metres. M. Neilson pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: CAPITAL TRANSPORT MAIDEN PLATE - 1600 metres

WAGEN (NZ) (A. Herrmann) became held up for clear ground between the 500 metres and 400 metres when racing inside the heels of CREATIVEPERCEPTION (J. Potter).

At the entrance to the straight MYSTIC MORN (L. Hopwood) shifted out and brushed with CREATIVEPERCEPTION (J. Potter).

In the vicinity of the 300 metres MYSTIC MORN (L. Hopwood) shifted in taking WAGEN (NZ) (A. Herrmann) in, resulting in WAGEN (NZ) becoming awkward for a number of strides on the heels of THE PEARLY GATES (T. Pannell) and ROCK STAR BABY (M. Pegus) and shortly thereafter, as WAGEN (NZ) improved into a tight run between THE PEARLY GATES and ROCK STAR BABY, WAGEN (NZ) rolled in and brushed with ROCK STAR BABY which was inconvenienced.

T. Baker, the rider of CASH JOB, reported the gelding hung in throughout the event. CASH JOB was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: SCHWEPPES OAKS DAY 28TH APRIL HANDICAP - 1540 metres

BACK ON TRACK (J. Potter) and VERRAZANO (C. Lindop) jumped away awkwardly.

GRANULATOR (A. Patterson) raced wide without cover in the early and middle stages of the event.

GREY MUSTANG (C. Lever) became held up for clear running for a short distance in the vicinity of the 400 metres between the heels of SISTER SWIFT (P. Gatt) and GRANULATOR (A. Patterson), which was weakening.

In the vicinity of the 200 metres GREY MUSTANG (C. Lever), which was initially disappointed for clear running between BACK ON TRACK (J. Potter) and SHARPAY MAGIC (L. Stojakovic), altered course to the outside of SHARPAY MAGIC and attempted a very tight run between that horse and SISTER SWIFT (P. Gatt) to its outside. In doing so GREY MUSTANG shifted out and contacted SISTER SWIFT, which maintained its line. As a consequence GREY MUSTANG was obliged to check off the heels of SHARPAY MAGIC, becoming severely unbalanced, and was obliged to alter course to the inside of SHARPAY MAGIC to obtain clear running. C. Lever was severely reprimanded and advised in future to only attempt runs to which he is entitled.

LE ROI (GER) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: CENTREBET SA DERBY DAY 5TH MAY HANDICAP - 1200 metres

After becoming fractious in the mounting yard, making contact with the perimeter fence and losing a shoe, MCLAREN OVERTURE was examined by the Club's Veterinary Surgeon and ruled unfit to race. Acting on this advice, Stewards withdrew MCLAREN OVERTURE at 3.08pm. Mr. J. Kluske, the Trainer of MCLAREN OVERTURE, was advised the mare would be required to prove tractable in an Official Barrier Trial before accepting for a future race.

ELSEWHERE (M. Neve) began awkwardly.

Shortly after the start COUSTELLET (B. Knobel) became buffeted between TEEN SPIRIT (M. Tyndall) and RIVIERA QUEEN (K. Bishop), which both shifted ground.

In the vicinity of the 1000 metres AMBITIOUS BRIDE (J. Toeroek) shifted in taking TEEN SPIRIT (M. Tyndall) in onto RIVIERA QUEEN (K. Bishop), resulting in M. Tyndall having to check her mount to avoid the heels of AMBITIOUS BRIDE and RIVIERA QUEEN, being taken in onto GOD'S WAY (B. Spriggs), resulting in contact between RIVIERA QUEEN and GOD'S WAY and the hindquarters of GOD'S WAY being turned. J. Toeroek pleaded guilty to a charge of Careless Riding under ARR.137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 25 April and to conclude at midnight on Saturday, 5 May 2012; a period of four (4) meetings.

In the vicinity of the 300 metres RIVIERA QUEEN (K. Bishop) became held up for clear running behind AMBITIOUS BRIDE (J. Toeroek) and GOD'S WAY (B. Spriggs).

RACE 7: MORPHETT ARMS HOTEL HANDICAP - 1600 metres

Approaching the 200 metres OUR IRIDIUM (S. Westover) commenced to shift in under riding taking the running of JEUNEALISTIC (Jordan Frew), which was obliged to race in restricted room until near the 100 metres before being able to alter course to the outside of OUR IRIDIUM to gain clear ground. S. Westover was reprimanded and advised to ensure he stops riding and straightens his mounts when they commence to shift ground in future.

RACE 7: MORPHETT ARMS HOTEL HANDICAP - 1600 metres (Cont'd)

Correct Weight for this event was delayed to permit Jordan Frew, the rider of the second placegetter JEUNEALISTIC, to view the official footage in the straight. After doing so Jordan Frew lodged an objection against OUR IRIDIUM (S. Westover) being declared the winner on the grounds of alleged interference from in the vicinity of the 200 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards upheld Jordan Frew's objection.

S. Westover, the rider of OUR IRIDIUM, was questioned regarding his use of the whip prior to the 100 metres. S. Westover pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$400.

RACE 8: DISTINCTIVE HOMES GOODWOOD DAY 12TH MAY HANDICAP - 1050 metres

PIXIU (L. Stojakovic) jumped away awkwardly, shifted in and contacted RILEYS LUCK (M. Pegus).

ROLL OF THE DICE (D. Tourneur) jumped away awkwardly, shifted out and contacted MELBA (B. Knobel).

KUITPO DANCER (J. Potter) began awkwardly.

In the vicinity of the 900 metres ROLL OF THE DICE (D. Tourneur) shifted in, taking SHOT IN JEST (M. Neilson) in across the running line of SHANPANICHI (T. Baker), which had to be steadied. D. Tourneur was severely reprimanded for shifting ground when insufficiently clear.

Inside the 600 metres ALERT THE JEWELLER (A. Brown) became held up for clear ground for a short distance when racing to the inside of SHANPANICHI (T. Baker) and when awkwardly placed on the heels of NOIR RASOIR (S. Westover).

Shortly after entering the straight, approaching the 300 metres, ALERT THE JEWELLER (A. Brown), which was following NOIR RASOIR (S. Westover), shifted in to improve, attempting the same run as NOIR RASOIR, which shifted in, resulting in ALERT THE JEWELLER being obliged to continue inside NOIR RASOIR for a number of strides. As a consequence ALERT THE JEWELLER tightened KUITPO DANCER (J. Potter), which also attempted the same run and had to be checked. Thereafter ALERT THE JEWELLER and KUITPO DANCER shifted out to obtain clear ground.

Approaching the 200 metres MELBA (B. Knobel) rolled in and inconvenienced ROLL OF THE DICE (D. Tourneur).

Approaching the 100 metres ALERT THE JEWELLER (A. Brown) was inconvenienced when taken out by ROLL OF THE DICE (D. Tourneur). Thereafter ALERT THE JEWELLER became held up on the heels of RULING TO WIN (A. Patterson) and was untested to the line.

B. Claridge, the rider of TAJ MAHER, reported the gelding felt sore in its action in front during the early stages of the event. TAJ MAHER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
