**Report on Race Meeting held at Gawler Racecourse**

**RACE 1 : RETURNED SERVICES LEAGUE RATING 0-120 HURDLE - 3358 metres**

SALLUM (R. Molloy) reared as the gates opened.

From the 400 metres CLUSO (M. Kelly) was eased out of the race.

LORD DE VEER (L. Miller) struck the last hurdle near the 100 metres almost dislodging L. Miller who became unbalanced and brought down LORD DE VEER.

SALLUM was examined by the Club's Veterinary Surgeon who reported the gelding strained its near fore suspensory ligament. First aid was administered. Mr. J. O'Connor, the Trainer of SALLUM was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

FRAUGHTWITH DANGER (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. K. Frew, the Trainer of FRAUGHTWITH DANGER (NZ) was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

LORD DE VEER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CLUSO was examined by the Club's Veterinary Surgeon who reported the gelding suffered a bi-lateral bleeding attack during the event. Mr. B. Searle, the Trainer of CLUSO, was advised the gelding was suspended from racing for a period of three (3) months in accordance with ARR.53A.

**RACE 2 : LONG TAN / SABOIS MAIDEN PLATE - 1209 metres**

On arrival at the start KUNGKA CAN RUN required attention from the Farrier.

The start of this race was delayed owing to SHARK EYE, which was kicked behind the starting stalls, dislodging its rider and galloping riderless for some distance prior to being captured. Acting on Veterinary advice that the gelding was unfit to race, SHARK EYE was withdrawn by Stewards at 12.59pm.

## **RACE 2 : LONG TAN / SABOIS MAIDEN PLATE - 1209 metres (Cont'd)**

The start was further delayed when FULL OF CACHE, after being loaded, broke from its barrier stall and galloped riderless for some distance. FULL OF CACHE was withdrawn by Stewards at 1.09pm.

On jumping away VALIK (Jemma Frew) shifted in onto KUNGKA CAN RUN (B. Claridge) which was inconvenienced.

Approaching the 700 metres KUNGKA CAN RUN (B. Claridge) rolled out onto MONEY BAGS (A. Patterson) which clipped heels.

Inside the 400 metres WICKED ROMEO (J. Potter) became held up when racing on the heels of DANISH SPY (Jordan Frew) and LA CARAMBA (D. Tourneur) as that filly commenced to give ground.

Inside the 300 metres GOLDEN LION (D. Evans) was obliged to steady when disappointed in attempting a run inside LA CARAMBA (D. Tourneur) which was taken in by BOLTIN' HENRY (A. Herrmann) which shifted in. A. Herrmann was reprimanded and advised in future to shift ground only when entitled to do so. In consequence, until inside the 200 metres, GOLDEN LION continued to be held up inside the heels of LA CARAMBA which continued to give ground.

Inside the 200 metres KING RODNEY (S. Cahill) rolled in onto VALIK (Jemma Frew) which was inconvenienced.

## **RACE 3 : KAPYONG / SABOIS MAIDEN PLATE - 1509 metres**

B. Claridge replaced S. Cahill as the rider of ROCK STAR BABY as S. Cahill could not make the allotted weigh. Having evidenced his disciplinary record S. Cahill was reprimanded and advised that future instances may result in a penalty being imposed.

SPIRIT LINE (D. Tourneur) and TANTARA (A. Herrmann) were slow to jump.

PELL MELL lost its near hind plate during this race.

## **RACE 4 : TOBRUK RATING 0-68 HANDICAP - 1709 metres**

MASSIAH (L. Cribbin) jumped away awkwardly.

On jumping away TASTEOFENERGY (D. Tootell) shifted out and brushed MASSIAH (L. Cribbin).

On jumping away SELBOURNE ROAD (M. Tyndall) shifted out onto STRANGMEAD (A. Patterson) which was inconvenienced.

QUENCH THE THIRST was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 5 : LEADING EDGE TELECOMS – SALISBURY RATING 0-71 HANDICAP - 2109 metres**

After being loaded WILLEGO broke through the barriers, was quickly restrained and returned to the start. WILLEGO was examined by the Club's Veterinary Surgeon and ruled fit to start.

SOUTHERN FORTUNE (M. Pegasus) was slow to jump.

**RACE 6 : KOKODA RATING 0-62 HANDICAP - 1209 metres**

Acting on confirmed advice from Mr. D. Koch, the Trainer of ROYAL STORMY, that the gelding had a pulse on a hoof and was unfit to race, ROYAL STORMY was withdrawn by Stewards at 9.55am.

On jumping away INDEPENDENT AIR (C. Lever) shifted in and brushed YOU ARE SO VAIN (J. Kah).

On jumping away GOODNIGHT JOSS (B. Claridge) lost its position when tightened between SET TO TALK (M. Pegus) which shifted in and JULIE MARIE (J. Potter) which rolled out.

In the vicinity of the 1000 metres KING'S SPEECH (J. Holder) suffered an injury and was pulled out of the event. In consequence GOODNIGHT JOSS (B. Claridge) was obliged to alter course to avoid KING'S SPEECH (J. Holder).

SIERRA SKIES (E. Boyd) was obliged to race wide without cover.

KING'S SPEECH was examined by the Club's Veterinary Surgeon who confirmed the gelding had fractured its off fore cannon necessitating its being humanely euthanized.

**RACE 7 : LEADING EDGE TELECOMS – MUNNO PARA - 1109 metres**

Mr. W. Bogarts, the Trainer of RIP APART, which provide difficult to load, was warned that a repetition of its behaviour may lead to action being taken.

Near the 200 metres MAGICAL RUBY (L. Hopwood) shifted in onto RAKS MCLAREN (J. Potter) which was inconvenienced.

Approaching the finish DE KAAP VALLEY (C. Lever) was forced to ease when tightened for room between MEADOWS CAT (P. Gatt) which rolled in marginally and RAKS MCLAREN (J. Potter) which rolled out.

HERE'S ARCHIE (J. Holder) lost its off hind plate during the event.

**RACE 8 : GALLIPOLI RATING 0-86 HANDICAP - 1509 metres**

Acting on confirmed advice from Mr. S. Trenowden, the Trainer of DUBAI ME DIAMONDS, that the mare was exhibiting a temperature, DUBAI ME DIAMONDS was withdrawn by Stewards at 9.00am.

LITTLE AKIE (J. Potter) was slow to jump.

BALLYPATRICK (L. Stojakovic) raced wide without cover throughout the event.

S. Cahill, the rider of SILENT ATTITUDE, explained that mare never really travelled and when improving appeared hesitant with runners to its outside. He added that SILENT ATTITUDE did not finish its race off as well as previous occasions he had ridden it and might have reached the end of its preparation. SILENT ATTITUDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SCOUSE was examined by the Club's Veterinary Surgeon who reported the gelding suffered a bi-lateral bleeding attack during the event. Mr. S. Turner, the Trainer of SCOUSE, was advised the gelding was suspended from racing for a period of three (3) months in accordance with ARR.53A.

**RACE 9 : HAMEL RATING 0-62 HANDICAP - 1209 metres**

DELTA RHO SAM (M. Pegus) and TOPS 'N' TAILS (W. Kerford) brushed on jumping away.

Near the 1000 metres, when being restrained, CANNY PREVAIL (J. Toeroek) was inclined to get its head up and be ungenerous.

At the entrance to the straight DELTA RHO SAM (M. Pegus) rolled out and contacted JULIET'S PRINCESS (USA) (C. Lindop) as that filly shifted in to improve resulting in JULIET'S PRINCESS (USA) being unbalanced for several strides.

**GENERAL**

**RACE 1 : RETURNED SERVICES LEAGUE RATING 0-120 HURDLE - 3358 metres**

Trainer, Mr. K. Frew, was questioned regarding the late presentation of horses into the mounting yard for the event. Mr. Frew was reprimanded and advised in future he would be required to respond to Rule ARR.124.

The Stewards attempted to interview Trainer, Mr. J. A. O'Connor in regards to his failure to present SALLUM in the mounting yard in accordance with Rule ARR.124. Mr. O'Connor failed to comply with a direction of the Stewards to attend the Steward's room.

At a date to be fixed Mr. O'Connor will be required to attend a hearing to inquire (i) into the circumstances in which SALLUM was presented late into the mounting yard and (ii) into Mr. O'Connor's reasons for failing to comply with the direction of the Stewards.
