Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 5 May 2012

RACE 1 : ADELAIDE CASINO OAKLANDS PLATE - 1600 metres

CHOSEN MOMENT (K. McEvoy) jumped away awkwardly.

On jumping away JUST FORGET IT (R. McLeod) knuckled and shortly after was inconvenienced by CHOSEN MOMENT (K. McEvoy) which shifted out.

In the early stages of the race CHOSEN MOMENT (K. McEvoy) was inclined to race keenly.

At the entrance to the straight DONNA CATTIVA (NZ) (D. Dunn) shifted out onto WHITTEN'S DELIGHT (M. Neilson) which was obliged to ease momentarily.

WHITTEN'S DELIGHT, CHOSEN MOMENT and JUST FORGET IT were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

K. McEvoy, the rider of CHOSEN MOMENT, explained he had been instructed, if possible, to obtain cover however as CHOSEN MOMENT began brilliantly, he had been unable to fulfil these instructions.

RACE 2 : CENTREBET'S SUPERBESTPLUS HANDICAP - 1050 metres

HANK'S NEPHEW, which kicked a rail when leaving the mounting enclosure, was examined by the Club's Veterinary Surgeon and passed fit to race.

MONSOON POON (M. Neilson) was slow to jump.

DANCER'S DREAM (D. Dunn) jumped away awkwardly.

DAY PROCEDURE (M. Zahra) knuckled badly on jumping away.

Shortly after the start MARITIME LAD (J. Holder) shifted out onto SURPRISE US (C. Lindop) which was inconvenienced.

RACE 2 : CENTREBET'S SUPERBESTPLUS HANDICAP - 1050 metres (Cont'd)

Inside the 800 metres AVIGHNA (J. Bowditch) rolled in onto DANCER'S DREAM (D. Dunn) which was obliged to ease when tightened for room.

Near the 300 metres DAY PROCEDURE (M. Zahra) rolled onto AVIGHNA (J. Bowditch) which was momentarily inconvenienced.

After entering the straight IMPULSE BUY (A. Herrmann) was inclined to lay in under pressure and approaching the 200 metres laid in onto the heels of BEAU JEZ (M. Pegus). Thereafter IMPULSE BUY proved difficult to ride as it shifted ground. IMPULSE BUY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. G. Richards, the Trainer of IMPULSE BUY, was advised that a repetition of the gelding's manners may lead to action being taken against it.

RACE 3 : CENTREBET'S BEST OF BEST HANDICAP - 1050 metres

TAKEN THE ROAD (T. Pannell) reared as the gates opened.

Shortly after the start CUTE TO BOOT (D. Tourneur) rolled out onto ZAAMISSION (D. Dunn) which was inconvenienced, and lost its position when tightened for room.

Near the 300 metres, as ZAAMISSION (D. Dunn) commenced to improve outside the heels of HANDOUT (J. Berriman), that gelding rolled out taking ZAAMISSION (D. Dunn) out onto KUITPO DANCER (M. Pegus) taking that mare out onto CUTE TO BOOT (D. Tourneur) which was obliged to steady when tightened for room. J. Berriman was advised of her obligations when shifting ground in future.

RACE 4 : PETER ELBERG FUNERAL HANDICAP - 1100 metres

MOVING MONEY (J. Holder) reared as the gates opened.

On jumping away NOIR RASOIR (T. Pannell) shifted out onto HIDDEN VALUE (A. Herrmann) which was inconvenienced.

From the 400 metres, for a short distance, HIDDEN VALUE (A. Herrmann) became held up when racing between PETMAN (S. Arnold) and HOT DIAMOND (L. Stojakovic).

On entering the straight until the vicinity of the 300 metres MOVING MONEY (J. Holder) was unable to obtain clear ground.

After entering the straight READY TO REEL (M. Pegus) was unable to obtain clear ground for some distance.

Approaching the 300 metres SECRET STATUS (C. Lindop), which was inclined to lay in, was reluctant to accept a run which was available between SANDHILL JETT (D. Tourneur) and NOIR RASOIR (T. Pannell) which was inclined to roll out marginally.

Inside the 300 metres SANDHILL JETT (D. Tourneur), which had commenced to give ground, shifted out away from SECRET STATUS (C. Lindop), as that filly improved to its inside, resulting in READY TO REEL (M. Pegus) contacting the hind quarters of SANDHILL JETT and turning that gelding out. Consequently READY TO REEL (M. Pegus) was tightened for room and taken out onto the hind quarters of HIDDEN VALUE (A. Herrmann) which became unbalanced for several strides.

RACE 4 : PETER ELBERG FUNERAL HANDICAP - 1100 metres (Cont'd)

A. Herrmann, the rider of HIDDEN VALUE, which settled further back than in recent starts, explained that the instructions provided today were similar to those at its previous start. She stated on that occasion over 1400 metres from an inside barrier, HIDDEN VALUE had raced strongly on the bridle and had settled more forward than anticipated. She stated that her expectations today were to settle midfield with cover, if possible, however after receiving slight interference at the start HIDDEN VALUE had settled further back than intended. Mr. T. Dansie, the Trainer of HIDDEN VALUE, confirmed his instructions to the rider had been similar in its recent starts and essentially he was looking to have HIDDEN VALUE ridden similarly to when successful at Morphettville in March.

D. Oliver, the rider of DECIRCLES explained that he was instructed to allow the colt to settle where it was comfortable and he had expected to use his barrier to settle behind the speed or a horse further back as eventuated. He stated that from the vicinity of the 200 metres DECIRCLES had disappointed in the manner it got to the line.

LADY AKATAK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

NOIR RESOIR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr. D. Balfour, the Trainer of NOIR RESOIR was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

HIDDEN VALUE lost its near fore plate during the event.

RACE 5 : ADELAIDE GALVANISING ADELAIDE GUINEAS - 1600 metres

MESHMAKER, which kicked the outside rail at the gates, was examined by the Club's Veterinary Surgeon and passed fit to race.

JUST DISCREET (J. Holder) jumped away very awkwardly and shifted in onto BALZEUS (D. Tourneur) which was inconvenienced.

Approaching the 1300 metres ROUGH DEAL (A. Patterson) was obliged to ease in racing in restricted room between BALZEUS (D. Tourneur) and THE NEW BOY (D. Oliver).

Near the 1300 metres as the pace eased JUST DISCREET (J. Holder) was inclined to get its head up and be ungenerous.

D. Oliver, the rider of THE NEW BOY, explained that under pressure he had improved to be on the back of the eventual winner at the 400 metres but thereafter the gelding had responded only fairly to his riding.

Subsequent to this event MESHMAKER was examined by the Club's Veterinary Surgeon who reported an abrasion to the inside of the hock and cannon on the off hind leg and an abrasion just below the knee on the off foreleg. Mr. S. Kavanagh, the Trainer of MESHMAKER, confirmed the gelding would now be spelled.

RACE 6 : 2012 THOROUGHBRED RACING SA PROVINCIAL SUPER SERIES - 1600 metres

Acting on confirmed advice from Mr. S. Kavanagh, the Trainer of SAVANNAH'S CHOICE, that the mare had pulled a shoe, exhibited lameness in the off foreleg and was unfit to race, Stewards withdrew SAVANNAH'S CHOICE at 8.37am Central Standard Time.

RACE 6 : 2012 THOROUGHBRED RACING SA PROVINCIAL SUPER SERIES

- 1600 metres (Cont'd)

Near the 300 metres OAKBANK HEIGHTS (J. Holder) was obliged to ease momentarily off the heels of SEA CORAL (M. Neilson) which shifted out.

From inside the 100 metres DETOX (D. Tourneur) shifted in onto SEA CORAL (M. Neilson) which was inconvenienced when taken onto AURUMCERT (J. Bowditch).

RACE 7 : CENTREBET SOUTH AUSTRALIAN DERBY - 2500 metres

Near the winning post on the first circuit ALCOHOL (P. Gatt) was obliged to ease when tightened for room by CORNELL (K. McEvoy) which shifted in. K. McEvoy was reminded of his obligations when shifting ground in future.

After passing the winning post on the first circuit HEAVEN'S RICHES (M. Walker), which was inclined to lay out, shifted out onto WESTSOUTHWEST (M. Zahra) which was hampered when taken wide.

Near the 800 metres HEAVEN'S RICHES (M. Walker) became awkward and commenced to lay out onto the heels of REIGN OF TERROR (S. Parnham). M. Walker reported that the gelding continued to lay out for the remainder of the event. HEAVEN'S RICHES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Near the 700 metres, in attempting to avoid CORNELL (K. McEvoy) which had commenced to give ground, ALCOHOL (P. Gatt) shifted out and brushed REIGN OF TERROR (S. Parnham).

Near the 600 metres REIGN OF TERROR (S. Parnham) was obliged to steady to avoid the heels of ALCOHOL (P. Gatt) as that gelding shifted out. P. Gatt pleaded guilty to a charge of Careless Riding under ARR.137(a) in that he permitted his mount to shift ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday 12 May 2012 and to conclude at midnight on Saturday 19 May 2012; a period of four (4) meetings.

Inside the 600 metres CORNELL (K. McEvoy) was forced to check when tightened for room between BACKBONE (B. Rawiller), which rolled out when improving outside the heels of SOUTHERN INVASION (S. Cahill), as that gelding gave ground and LETHAL JONES (J. Whiting) which rolled in. As Stewards determined that SOUTHERN INVASION when tiring had rolled out onto BACKBONE and had contributed to the incident, no rider was considered to be culpable.

SOUTHERN INVASION was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mrs. M. Ruberry, the Trainer of SOUTHERN INVASION, was advised that a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

CORNELL was examined by the Club's Veterinary Surgeon who confirmed the gelding suffered a bi-lateral bleeding attack during the event. Mr. A. Freedman, the Trainer of CORNELL, was advised the gelding was suspended from racing for a period of three (3) months in accordance with ARR.53A.

RACE 8 : CENTREBET'S IPHONE APP HANDICAP - 1200 metres

DUBAWI GOLD was examined by the Club's Veterinary Surgeon and passed fit to race.

ICE TEE (T. Zanker) reared as the gates opened and lost considerable ground.

RACE 8 : CENTREBET'S IPHONE APP HANDICAP - 1200 metres (Cont'd)

Near the 400 metres WEHOLDTHEACE (J. Bowditch) shifted out onto ST FRASER (R. Stewart) taking that gelding out onto GRAND GINGER (M. Neilson) as that gelding rolled in resulting in it being inconvenienced. In being corrected, GRAND GINGER overreacted and shifted out onto VALOROSO (L. Stojakovic) which was inconvenienced and in consequence BOLD LINE (A. Patterson) was obliged to alter course.

ADDITIONAL REPORTS - MURRAY BRIDGE – 2 MAY 2012

RACE 1 : GOLDEN GRAIN HOTEL PINNAROO / SABOIS DISTANCE MAIDEN PLATE
- 2206 metres

P. Gatt, the rider of MISS PRACTICALITY, was questioned regarding his use of the whip in the forehand manner prior to the 100 metres. After considering his explanation and having reviewed the vision, P. Gatt was charged with having breached ARR.137A(5)(a)(ii) in that he used the whip in a forehand manner on more than five occasions prior to the 100 metres. He pleaded guilty and was fined \$200.

T. Pannell, the rider of WEEKEND DAZZLER was questioned regarding his use of the whip in the forehand manner prior to the 100 metres. After considering his explanation and having reviewed the vision, T. Pannell was charged with having breached ARR.137A(5)(a)(ii) in that he used the whip in a forehand manner on more than five occasions prior to the 100 metres. He pleaded guilty and was fined \$200. T. Pannell was also charged with having breached ARR.137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres. He pleaded guilty and was reprimanded.

RACE 5 : BENT ELBOW HOTEL RATING 0-62 HANDICAP – 1606 metres

J. Kah the rider of MAGIC TIGRESS was questioned regarding her use of the whip in the forehand prior to the 100 metres. After considering her explanation and having reviewed the vision, J. Kah was charged with having breached ARR.137A(5)(a)(ii) in that she used the whip in a forehand manner on more than five occasions prior to the 100 metres. J. Kah pleaded guilty and was reprimanded. In determining this penalty Stewards considered the apprentice's relative inexperience.

ADDITION REPORT - MORPHETTVILLE – 28 APRIL 2012

RACE 3 : SCHWEPPE'S COCKTAIL REVOLUTION HANDICAP - 2000 metres

D. Tourneur, the rider of MY EX MATE, was questioned regarding his use of the whip prior to the 100 metres and raising his arm above the point of the shoulder. After considering D. Tourneur's explanations and having reviewed the vision D. Tourneur was charged with having breached ARR 137A(4)(b) in that when using the whip he had consistently raised his arm above the shoulder. He pleaded guilty and was fined \$250. In determining this penalty the Stewards acknowledged D. Tourneur's plea of guilt and noted it was the rider's first offence of this rule in approximately 1800 race rides since August, 2009. In examining D. Tourneur's action in the straight, as the Stewards could not be satisfied that D. Tourneur's use of the whip prior to the 100 metres had not been in the backhand manner, as asserted by the rider, no further action was taken other than to remind D. Tourneur of his obligations under the Rules.

ADDITION REPORT - MORPHETTVILLE – 28 APRIL 2012 (Cont'd)

RACE 7 : SPORTINGBET CLASSIC - 1200 metres

Mr. J. O'Connor, the Trainer of TABULATED which had left the course prior to the time prescribed, explained that his staff had concerned at the additional traffic congestion to be negotiated on the day. He stated that TABULATED had undergone a thorough post race Veterinary examination as a consequence to what occurred. As the Stewards considered that mitigating factors were relevant, they accepted Mr. O'Connor's explanation although he was reminded in similar circumstances in future to ensure his staff obtained permission to leave the course.
