STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 12 May 2012

RACE 1 : THE JANSZ - 1200 metres

SHE'S A MONET (D. Dunn) was inclined to rear as the gates opened and jumped slowly as a consequence.

On jumping away KING VALENTINE (J. Bowditch) and BEAU JEZ (M. Rodd) brushed.

SHE'S A MONET lost its near fore plate during the event.

M. Rodd, the rider of BEAU JEZ, reported the gelding was inclined to lay out in the straight.

V. Duric, the rider of PAPILLON, explained that although the filly settled three deep it had cover and he had thought in the vicinity of the 400 metres, given the way it was travelling, it would figure in the placings. He said that from that point PAPILLON did not quicken as well as other runners and in hindsight it was inclined to be green in the early stages and may be improved by the experience. PAPILLON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of DINKUM DIAMOND, was questioned regarding her use of the whip prior to the 100 metres. C. Lindop pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

KING VALENTINE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. J. Hyam, the Trainer of KING VALENTINE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

DASHITUDE was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. C. Bieg, the Trainer of DASHITUDE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : CENTAUREA STAKES - 2005 metres

QUEEN'S FASHION (V. Duric) was slow to jump.

RACE 2 : CENTAUREA STAKES - 2005 metres (Cont'd)

D. Tourneur, the rider of DETOX, explained the mare had settled where he had intended, although inclined to over-race slightly. He stated that as DETOX had not relaxed as well as it had on previous occasions, it might be showing signs that it has come to the end of its preparation. DETOX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : VEOLIA PORT ADELAIDE CUP - 2500 metres

On jumping away DUMOSA (T. Pannell) shifted out and brushed MY EX MATE (S. Cahill) at the same time as ANDRONICA (J. Holder) shifted in, brushing TEXAN WARNEY (H. McKechnie), resulting in MY EX MATE and TEXAN WARNEY brushing.

In the early stages WILLEGO (J. Bowditch) was obliged to race three wide for some distance.

Correct Weight for this event was delayed to permit L. Stojakovic, the rider of the fourth placegetter BEAUTIFUL SOUL, to view the official image for third.

S. Cahill, the rider of MY EX MATE, explained his mount had a good run during the race and tracked forward with cover on the back of the winner, however, MY EX MATE's run had ended in the vicinity of the 200 metres. He stated, in his opinion, the gelding had had a long preparation and it may be in need of a spell. MY EX MATE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : SPORTINGBET SA FILLIES CLASSIC - 2500 metres

On arrival at the barriers, at the request of Jockey L. Nolen, RED TYPHOON was examined by the Club's Veterinary Surgeon and ruled fit to start.

QUICK RETORT (D. Oliver) was slow to jump.

Passing the winning post on the first occasion QUICK RETORT (D. Oliver) was obliged to ease away from the heels of BELLS OF TROY (M. Neilson), which shifted in, away from WEEKEND DAZZLER (T. Pannell).

In the early stages, on occasions, CRYSTALISED (NZ) (V. Duric) was inclined to get its head up and be ungenerous.

Inside the 600 metres FONSSAGRIVES (P. Gatt) was obliged to ease momentarily when tightened onto TEMPER TANTRUM (M. Payne) by BELLS OF TROY (M. Neilson) as that filly was taken out by ELLDAMI (D. Tourneur).

From the 200 metres PRINCESS ROCK (M. Walker) was inclined to lay out under pressure. M. Walker reported he had little control over the filly at that stage of the race. PRINCESS ROCK was examined by the Club's Veterinary Surgeon who reported lacerations to both cheeks.

D. Dunn, the rider of CRIMSON LADY (NZ), which settled more forward than in its previous two starts, explained Mr. Moroney had not provided him with instructions but did express a preference for settling mid-field. He added that Mr. Moroney had warned him that CRIMSON LADY (NZ) could over-race and expressed some doubt about the distance of this race. He stated that left to his own perspective, he felt that with the lack of apparent speed in the race, he should attempt to settle more forward and although he would have preferred to have obtained cover mid-race, that did not eventuate.

RACE 4 : SPORTINGBET SA FILLIES CLASSIC - 2500 metres (Cont'd)

D. Dunn, the rider of CRIMSON LADY (NZ), was questioned regarding his use of the whip prior to the 100 metres. D. Dunn pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions and was reprimanded. When determining this penalty the Stewards noted that D. Dunn had committed one breach of the Whip Rules since October 2010.

RACE 5 : DARLEY LAELIA STAKES - 1600 metres

JUST PUSH ON (T. Pannell) jumped away awkwardly and shifted out onto DAKADAN PRINCESS (J. Holder) taking that filly out onto LITTLE MISS BOURKE (A. Patterson), which was inconvenienced.

LUCKY PENNY lost its near hind plate during the event.

DAKADAN PRINCESS suffered a bi-lateral bleeding attack during the event. Mr. M. Minervini, the Trainer of DAKADAN PRINCESS, was advised the filly was now suspended from racing for a period of three months in accordance with ARR.53A.

RACE 6 : R A LEE STAKES - 1600 metres

ZABISCO (NZ) (D. Oliver) jumped away awkwardly and shifted in onto SO PRISTINE (L. Nolen), which was hampered.

Inside the 1300 metres ZABISCO (NZ) (D. Oliver), which was inclined to race keenly, became ungenerous for some distance when being restrained.

Near the 300 metres LINTON (S. Arnold) rolled out onto SEVILLE (GER) (M. Rodd), which was inconvenienced. S. Arnold was reminded of his obligations when shifting ground in future.

In the straight SEVILLE (GER) (M. Rodd) was inclined to lay in under pressure. This was confirmed by M. Rodd.

M. Neilson, the rider of SAINT DESIR (GB), reported he felt the horse was short in front on pulling up. SAINT DESIR (GB) was examined by the Club's Veterinary Surgeon who reported muscular stiffness in both shoulders. Mr. T. McEvoy, the Trainer of SAINT DESIR (GB), was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

When questioned as to her reasons for not attempting a run which became available between TESTA MY PATIENCE (G. Boss) and SAINT DESIR (GB) (M. Neilson) after entering the straight, M. Payne, the rider of HAWKS BAY, stated she had travelled very well into the straight just inside the heels of TESTA MY PATIENCE and although initially inclined to get into better going four or five horses wide, for two strides had considered attempting that run, however, considered that movement from both horses had taken that ground and as a consequence then altered course to the outside of TESTA MY PATIENCE. After reviewing the official vision, Stewards accepted M. Payne's explanation.

RACE 7 : THE DISTINCTIVE HOMES GOODWOOD - 1600 metres

STIRLING GROVE lost its off fore plate during the event.

Stewards sought an explanation from L Nolen, the rider of BLACK CAVIAR, into his riding of the mare from the 200 metres. L Nolen explained the Trainer, Mr. P. Moody, had been explicit in his instructions pre-race to win the race as easily as possible but stated he was alert to his obligations under the Rules. In accepting this explanation Stewards reinforced these obligations to the rider.

RACE 7 : THE DISTINCTIVE HOMES GOODWOOD - 1600 metres (Cont'd)

CATAPULTED and GO THE KNUCKLE were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : CENTREBET PROUD MISS STAKES - 1200 metres

The start of this race was rescheduled to 5.07 pm.

GOLDEN PENNY (P. Gatt) was slow to jump.

SHANPANICHI (T. Baker) jumped away awkwardly and shifted out. As a consequence ALL FRIARED UP (C. Lindop), to its outside, shifted out and contacted ARCTIC FLIGHT (G. Boss), which was hampered.

Approaching the 200 metres BONNIE MAC (NZ) (D. Dunn) rolled in onto JUST SYBIL (J. Potter), which was obliged to alter course across the heels of ARCTIC FLIGHT (G. Boss).

D. Oliver, the rider of POWER PRINCESS, explained that in his opinion the inside of the track had deteriorated quickly later in the afternoon and the inside gate had become a disadvantage. He stated that in the vicinity of the 600 metres POWER PRINCESS had dipped in the going and was not comfortable from that point. POWER PRINCESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Race 6 : 2012 Thoroughbred Racing SA Provincial Super Series - 1600 metres

T. Pannell, the rider of OUI SI ATTITUDE, was questioned regarding his use of the whip prior to the 100 metres. T. Pannell pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions and was reprimanded.

Race 8 : Centrebet's Iphone App Handicap - 1200 metres

J. Potter, the rider of STREETCAR REALITY, was questioned regarding his use of the whip prior to the finish. J. Potter pleaded guilty to a charge under ARR.137A(4)(b) in that when using the whip he raised his arm above the shoulder and was reprimanded.
