Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 19 May 2012

RACE 1 : EVRIGHT.COM HANDICAP - 2019 metres

Mr D Balfour, the Trainer of RIVER'S LANE, advised Stewards that having considered the apparent pace in the race, he would instruct Apprentice S Westover to attempt, if possible, to avoid leading in the event but rather obtain a position forward of mid-field with cover and not get into a battle for the lead and permit the gelding, which was having its first start over this distance since being a three-year-old, to finish off the event.

RIVER'S LANE (S Westover) jumped away awkwardly and inconvenienced LANGRIDGE STREET (C Lever).

In the vicinity of the 300 metres BACCHUS EAGLE (J Toeroek), which initially commenced to lay in, shifted out when being corrected and inconvenienced DOUBLY SURE (NZ) (C Lindop), which was obliged to steady on two separate occasions. J Toeroek was reminded of his obligations when his mounts commence to shift ground.

WARATONE (D Tourneur) laid in, in the straight, resulting in D Tourneur having to stop riding and straighten his mount and as a consequence, D Tourneur lost control of his near side rein over the concluding stages.

J Toeroek, the rider of BACCHUS EAGLE, reported the gelding laid in, in the straight.

S Westover, the rider of RIVER'S LANE, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(i) in that he used his whip consecutively prior to the 100 metres and was reprimanded. He also pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$500.

RACE 2 : DISTINCTIVE HOMES HANDICAP - 1000 metres

NIMASAEEL (L Hopwood) reared as the gates opened and as a consequence was slow to begin.

RACE 2 : DISTINCTIVE HOMES HANDICAP - 1000 metres (continued)

IMPULSE BUY (A Patterson) jumped away awkwardly.

On jumping away AKAHADOO (A Herrmann) and ZEDNICK (J Frew) came together and made contact.

Approaching the 800 metres NIMASAEL (L Hopwood) commenced to race keenly and was awkwardly placed on the heels of ZEDNICK (J Frew) for a short distance.

Approaching the 100 metres AKAHADOO (A Herrmann) shifted in under riding taking the running of ANODOUBT (J Toeroek), which had improved into a position between AKAHADOO and SWEET GRACE (M Neilson) resulting in ANODOUBT having to be checked to avoid the heels of AKAHADOO and alter course to the outside of that horse to obtain clear running. A Herrmann pleaded guilty of a charge of Careless Riding under ARR.137(a) in that she allowed her mount to shift ground when insufficiently clear. She was suspended from riding in races for a period to commence at midnight on Sunday, 20 May and to conclude at midnight on Wednesday, 30 May 2012; a period of four (4) meetings.

RACE 3 : CENTREBET HANDICAP - 1600 metres

TABULATED (S Westover) jumped away awkwardly and brushed DRAFTED (C Lindop).

Inside the 1200 metres OUR FREED MAN (J Bowditch) over-raced for a short distance.

In the middle stages of the event BALLYPATRICK (L Stojakovic) raced wide without cover.

KELLERMAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : FRED WORTHLEY MEMORIAL HANDICAP - 1200 metres

MY CHOISIR (J Bowditch) jumped away awkwardly brushing ROXIT (W Egan).

In the vicinity of the 600 metres the saddle on ZEN shifted forward placing jockey A Herrmann at a disadvantage, resulting in her mount becoming awkwardly placed on the heels of MOVING MONEY (C Lindop) for some distance and thereafter, inside the 400 metres, ZEN was unable to obtain clear ground when awkwardly placed between the heels of MOVING MONEY and ROXIT (W Egan) and was obliged to alter course to the outside of MOVING MONEY to obtain clear running.

RACE 5 : PROJECTION GRAPHICS HANDICAP - 1050 metres

SHOT IN JEST (J Bowditch), which was fractious in the gates, jumped away very awkwardly and as a consequence was slow to begin.

CUSTODIAN (S Cahill) and RULING PARTY (C Lindop) contacted at the start and shortly thereafter CUSTODIAN was tightened onto RULING PARTY by VINTAGE PUNCH (M Neilson), which shifted out at the same time as RULING PARTY was taken in by TAKEN THE ROAD (T Baker), which shifted in. As a consequence CUSTODIAN and RULING PARTY were both inconvenienced.

MR GOOD CAT (J. Toeroek) raced keenly in the early stages of the event.

RACE 5 : PROJECTION GRAPHICS HANDICAP - 1050 metres (continued)

In the vicinity of the 200 metres ZAAMMISSION (J Frew) was disappointed for clear running between BIGBADBARRY (J Maund) and TASSIE GOLD (A Herrmann) and altered course to the outside of TASSIE GOLD to obtain clear ground and thereafter, in the vicinity of the 100 metres, was again obliged to alter course to the inside of LADY DYNAMO (S Westover) to obtain clear ground.

RACE 6 : THE PAULS MANIHI CLASSIC - 1100 metres

S Westover, the rider of PERIDUKI, explained the gelding was reluctant when the gates were released and was slow to begin which resulted in him being unable to comply with his instructions to lead in the event. He added that PERIDUKI felt flat during the event and failed to respond to his riding in the manner he expected. PERIDUKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HAPPY ANGEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : VEOLIA HANDICAP - 1200 metres

SACRED SNAADDEE (S Cahill) jumped away very awkwardly unbalancing its rider.

In the vicinity of the 900 metres FIRST MAN (S. Westover) was eased out of the event. S Westover explained the gelding had commenced well but as it felt very awkward in its action behind, he opted to ease FIRST MAN out of the event. As a consequence of FIRST MAN being eased out of the event, in the vicinity of the 800 metres SARCASM (A Patterson), which was following, was inconvenienced and had to alter course. FIRST MAN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both hind legs. Mr S Whittle, representing Mr M Whittle, the Trainer of FIRST MAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial and the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

HORATIUS lost its off fore plate during the event.

M. Neilson, the rider of HORATIUS, reported the gelding laid in and felt awkward in its action in front. HORATIUS was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. T. McEvoy, the Trainer of HORATIUS, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

SARCASM was examined by the Club's Veterinary Surgeon who reported a small wound in the mouth and the gelding to be lame in the near foreleg. Mr. G. Searle, the Trainer of SARCASM, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : EXPRESS COLOUR PRINTING HANDICAP - 1200 metres

SELESSI (J Maund) jumped away awkwardly and shifted out taking SCHOORWIN (D Tourneur) out across the running of BLAME GAME (C Lindop), inconveniencing that gelding.

EXALTED WONDER (L Stojakovic) was slow to begin.

SILVER MOMENT (T Pannell) jumped away awkwardly.

RACE 8 : EXPRESS COLOUR PRINTING HANDICAP - 1200 metres (continued)

Approaching the 800 metres STRUM CHA (J Bowditch) shifted in onto RAINBOW BLACK (M Neilson), which was obliged to race in restricted room for a number of strides and as a consequence CHOMP (S Westover), which was following, had to be steadied. Thereafter RAINBOW BLACK, which shifted out abruptly of its own accord, inconvenienced KUITPO DANCER (T Baker).

In the vicinity of the 500 metres SELESSI (J Maund) rolled in onto SCHOORWIN (D Tourneur), which was taken in onto WYARA MISS (B Claridge), resulting in WYARA MISS having to be steadied, losing its position.

Shortly after entering the straight RAINBOW BLACK (M Neilson), which laid in, was obliged to steady away from the heels of BLAME GAME (C Lindop), which shifted out.

J Bowditch the rider of STRUM CHA reported his mount felt awkward in its action during the event.

RAINBOW BLACK was examined by the Club's Veterinary Surgeon who reported minor mouth abrasions and the mare to be lame in the off hind leg. Mr. J. Gardiner, the Trainer of RAINBOW BLACK, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

SELESSI was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg and lame in both hind legs. Dr. F. Livesey, the Trainer of SELESSI, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
