### RACE 1: CASTEC RURAL / SABOIS 2&3YO MAIDEN PLATE - 1200 metres

WOAKWINE (A. Patterson) jumped away awkwardly and as a result was slow to begin.

SIDIAKOV (S. Harrison) was slow to begin.

Racing to the 250 metres LITTLE MISS AMUR (Jordan Frew) shifted out and away from SHEHARA (C. Lindop) resulting in LUCKY LAZ (H. McKechnie) being taken out wider inconveniencing TRIG (M. Walters).

SOUTHERN ILLUSION was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near fore. Mr. J. Brooks, the Trainer of SOUTHERN ILLUSION, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

#### RACE 2: BUDGET CAR & TRUCK RENTALS / SABOIS MAIDEN PLATE - 1200 metres

Correct weight was delayed to allow P. Marks, the rider of JEUNE KING CARLOS the fourth placegetter, and. L. Kettle the trainer of JEUNE KING CARLOS to look at the official photo finish.

MASLIN MAID (K. Walters) knuckled on jumping and as a result was slow to begin.

PINT MUG (D. Tourneur) was slow to begin.

## RACE 2 : BUDGET CAR & TRUCK RENTALS / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

Racing to the 1100 metres OHWOW (J. Cartwright) shifted in taking MISS PRIME TIME (A. Patterson) in onto FRADEMA (H. McKechnie) which was inconvenienced and taken in onto JUNOOD (C. Puls) which was inconvenienced and taken in onto ZIPPY LAD (D. Thornton) which was momentarily inconvenienced. Shortly after OHWOW (J. Cartwright) continued to shift in resulting in WHEELY BIN (C. Lindop) having to momentarily steady to avoid the heels and shift out inconveniencing FRADEMA (H. McKechnie). J. Cartwright was severely reprimanded for Careless riding under ARR.137a.

Racing to the 300 metres MAGICAL SUN (D. Evans) was momentarily held up on the heels of JEUNE KING CARLOS (P. Marks).

### RACE 3 : O'CONNOR & GRANEY CATTLE REARERS / SABOIS MAIDEN PLATE - 1800 metres

BLINGALING (Jordan Frew) jumped away awkwardly and as a result was slow to begin.

THE WILD THING (J. Cartwright) was very slow to begin.

Racing to the 200 metres APOSTLE (D. Evans) had to momentarily steady when TORRIDON (S. Harrison) rolled in under pressure. S. Harrison was reminded of his obligations when shifting ground.

Racing from the 100 metres to the winning post, APOSTLE (D. Evans) was held up for clear running on the heels of LITTLE VILLAIN (D. Thornton).

TORRIDON (S. Harrison) was inclined to race greenly throughout the event. TORRIDON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 4: SCOTT PETROLEUM RATING 0-72 HANDICAP - 2050 metres

Correct weight for this race was delayed to allow A. Patterson, the rider of the ULTRA SAVINGS which dead heated for third and Trainer, Mr. J. Opperman to view the official photo finish.

#### RACE 5: CARLTON DRAUGHT BLUE LAKE HANDICAP - 1550 metres

BELECONI (A. Patterson) was slow to begin.

LIONHEARTED GIRL (J. Toeroek) and FASMOSS (C. Lindop) brushed on jumping.

D. Thornton, the rider of LIGHT TAN, explained that he believed the gelding never let down in the event and after receiving cover from approximately the 900 metres, was very disappointed with the way the gelding finished the race off. LIGHT TAN was examined by the Club's Veterinary Surgeon who reported the gelding to have a slower than normal recovery rate. He also believes that the gelding may have had a temporary airway obstruction and is of the opinion that the gelding should be scoped prior to accepting for a future trial or race. Mr. M. O'Leary was advised that the results of a scope for LIGHT TAN must be provided prior to accepting for a future trial race.

### RACE 6: MOUNT GAMBIER AIR CONDITIONING RATING 0-59 HANDICAP (Division 1) – 1400 metres

On arrival on course WHERE'SCHRISTOPHER which was fractious in its float en route to the track was examined by the Club's Veterinary Surgeon who reported superficial grazing over the right hip and hind quarters and passed fit to run.

SANDHILL TESS (D. Tourneur) was slow to begin.

LOTS OF DOLLARS (H. McKechnie) jumped away awkwardly and as a result was slow to begin.

NAPASH (K. Walters) raced wide with no cover throughout the event.

Subsequently to the event WHERE'SCHRISTOPHER, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 7: YOUNG'S THE MAN'S SHOP COLTS, GELDINGS & ENTIRES RATING 0-65 HANDICAP - 1200 metres

The start of this race was delayed approximately three (3) minutes as GATALISTIC (A. Patterson) and BECKETT WAY (K. Walters) were fractious in the barriers. GATALISTIC and BECKETT WAY were examined by the Club's Veterinary Surgeon and passed fit to race. Trainers, Mr. D. Kolpin and Mr. G. Smith were advised that a Warning has been placed on the respective geldings in relation to their barrier manners.

SWIPER (NZ) (P. Marks) was slow to begin.

Racing inside the 300 metres BERNIE'S BOY (H. McKechnie) had to steady and lose its position when attempting a run inside BECKETT WAY (K. Walters) which closed due to BECKETT WAY shifting in under pressure. As a result, BERNIE'S BOY was untested for the remainder of the event. H. McKechnie was reminded of her obligations to ride her mounts out to the line in future.

Racing inside the 200 metres SOLITARY MAN (NZ) (M. Walters) was tightened for room between HICONI (J. Toeroek) and EARS HARRY (J. Kah) when HICONI was laying in and away from SWIPER (NZ) (P. Marks).

GATALISTIC was examined by the Club's Veterinary Surgeon who reported grazing over the forehead. First aid was administered.

# RACE 8 : BE-RAY CABINETS / SABOIS FILLIES & MARES RATING 0-65 HANDICAP - 1200 metres

LAST PICASSO (K. Walters) and VERRAZANO (S. Harrison) were slow to begin.

INVINCIBLE DIVA (C. Lindop) and FLIRTY MARTINI (C. Puls) brushed on jumping.

Racing to the 900 metre WHOLETTHECATOUT (P. Marks) was obliged to steady when tightened for room by APPEASING (NZ) (Jordan Frew) which was taken in slightly by FLIRTY MARTINI (C. Puls) which had a tendency to lay in and away from INVINCIBLE DIVA (C. Lindop). Shortly after WHOLETTHECATOUT was obliged to check and lost its position when KVINNAKEL (D. Tourneur) shifted in marginally onto INVINCIBLE DIVA which as a result shifted in slightly onto FLIRTY MARTINI, which continued to lay in onto APPEASING (NZ), further tightening WHOLETTHECATOUT.

# RACE 8: BE-RAY CABINETS / SABOIS FILLIES & MARES RATING 0-65 HANDICAP - 1200 metres (Cont'd)

Racing inside the 200 metres INVINCIBLE DIVA (C. Lindop) had to steady and lose her position when NAUGHTY MOMENTS (D. Thornton) rolled out under pressure. D. Thornton was reminded of his obligations when shifting ground.

ZIRCONI ASPEN was examined by the Club's Veterinary Surgeon who reported an elevated heart rate.

## RACE 9 : CITY COUNCIL OF MOUNT GAMBIER RATING 0-59 HANDICAP (Division 2) - 1400 metres

STYLISH SPENDER (P. Marks) was slow to begin.
