STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Hawker Racecourse
by the Hawker Racing Club on Saturday, 26 May 2012

On arrival on course Stewards became aware of inconsistencies with the track surface and debris on the track. After consulting the riders, Stewards ordered track maintenance be undertaken by the Club in an attempt to complete the race meeting. After further inspection by Stewards, the track was considered safe to race. All race times were rescheduled and Race 1 commenced at 2.05 pm.

RACE 1 : ARKABA / SABOIS 2UP MAIDEN PLATE - 1400 metres

SETATREND, which had not raced since October 2010, was examined by the Club's Veterinary Surgeon and ruled fit to race.

TENEPAL (B. Hoppo) was slow to begin.

Near the 900 metres TENEPAL (B. Hoppo) shifted in slightly onto SHE'S A COMMODITY (E. Boyd), which was momentarily inconvenienced.

From the 800 metres SHE'S A COMMODITY (E. Boyd) weakened and lost touch with the field. SHE'S A COMMODITY was examined by the Club's Veterinary Surgeon who reported the mare had a large amount of dirt in its eyes and nostrils.

Jemma Frew, the rider of MR DODD, reported the gelding had become awkward in its action in the middle stages of the event and lost ground. MR DODD was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr D. Bonetti, the Trainer of MR DODD, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : HAWKER / SABOIS MAIDEN PLATE - 1100 metres

EVE'S DELIGHT (M. Tyndall) jumped away awkwardly, shifted out and tightened ALISIMTO (E. Boyd) onto PERFECTNESS (NZ) (E. Brooks).

PALLAXY (J. Kah) raced very wide throughout the event.

E. Boyd, the rider of ALISIMTO, was reminded of her obligations under ARR.144 in relation to weighing in for fourth place.

RACE 3 : K S RASHEED MEMORIAL RATING 0-64 HANDICAP - 1100 metres

MOUNTAIN CLIMBER (D. Stra) was slow to begin.

SHEEZA PERIL (M. Tyndall) jumped away awkwardly.

RACE 4 : XXXX GOLD WONOKA RATING 0-64 HANDICAP (Division 1) - 1400 metres

STRATOCRUISER (NZ) (K. Dyson) was slow to begin.

In the vicinity of the 500 metres RHODES TO GLORY (E. Boyd) brushed the inside running rail.

RACE 5 : NORTHPOINT TOYOTA HAWKER CUP - 1800 metres

Acting on confirmed telephone advice from Mr. D. Irlam, the Trainer of DESTINY DANZING, that he would not be able to arrive on course by the required time, Stewards withdrew DESTINY DANZING at 8.15 am. Mr. Irlam was reprimanded under LR.19.1 for failing to scratch the gelding by the prescribed time which resulted in the third emergency being denied a start.

On jumping away EPOCHAL (NZ) (E. Brooks) lost its position when tightened between YOUNG TEARAWAY (D. Stra), which shifted out, and KIEVAN RUS (K. Dyson), which shifted in.

In the vicinity of the 800 metres STREET RELATED (B. Hoppo), which was inclined to race keenly, was obliged to steady off the heels of SIERRA SKIES (E. Boyd) for a number of strides.

Near the 400 metres MUKARRAR (P. Roff) brushed the inside running rail.

PELEKUNU VALLEY (NZ), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : XXXX GOLD WONOKA RATING 0-64 HANDICAP (Division 2) - 1400 metres

The start of this event was delayed by three minutes owing to the tongue tie on TONI'S CONNECTION having to be adjusted.

B. Hoppo, the rider of PONTOON FENDER, was reminded of his obligations in relation to making a celebratory gesture prior to the winning post.
