**RACE 1 : KATNOOK ESTATE WINERY / SABOIS MAIDEN PLATE - 1100 metres**

FLEET 'N' TWEET (P. Marks) was slow to begin.

SIDIAKOV (S. Harrison) jumped away very awkwardly.

PEEAHPEE (NZ) was examined by the Club's Veterinary Surgeon who reported an abrasion to the near for anterior coronary band.

**RACE 2 : FESTIVAL HIRE MAIDEN PLATE - 1400 metres**

Shortly after the start MY BIZZO (NZ) (S. Cahill) was hampered when awkwardly placed between the heels of KINGUSSIE (J. Beriman), which rolled out, and LEGAL LINDA (J. Potter).

Correct Weight for this event was delayed to allow D. Tourneur, the rider of the fourth placegetter PINT MUG, and Mr. S. Turner, the gelding's Trainer, to make a submission to Stewards in relation to the gelding being declared the fourth placegetter. Stewards heard evidence from the Official Judges on duty in relation to the result of the race and confirmed that no official photo image was available due to a malfunction of the photo finish equipment. Having considered the Judge's explanation and the submission from D. Tourneur and Mr. S. Turner, Stewards were satisfied with the result as declared by the Judges and declared Correct Weight.

A. Herrmann, the rider of MOST AWESOME, pleaded guilty to a charge under ARR.137A(3) in that she used her whip in an excessive manner and was reprimanded. In determining a penalty, Stewards considered, although A. Herrmann used her whip in a backhand manner, she used it on too many occasions.

### **RACE 3 : FINNS FINE FOODS / SABOIS MAIDEN PLATE - 1700 metres**

KINGJAKE (A. Herrmann) and NOTTINGHAM HOUSE (Jordan Frew) were slow to begin.

LUCKZAT (NZ) (M. Walters) was slow to begin, losing two to three lengths.

Shortly after the start O'JAY (P. Marks) shifted out and contacted FRESCOIST (J. Toeroek), which was taken wider.

J. Beriman, the rider of MAGICAL SUN, explained her instructions were to take up a forward position in running and shortly after the start she encouraged the gelding in order to comply with her instructions but stated MAGICAL SUN appeared flat-footed and failed to respond to her riding and as a consequence she was obliged to settle back of mid-field in the early stages of the event. She added the gelding appeared reluctant in the underfoot conditions at times during the event and approaching the home turn, it had compounded and failed to be competitive. MAGICAL SUN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 4 : DENIS GOULDING EQUINE VETERINARY / SABOIS F&M RATING 0-65 HANDICAP - 1300 metres**

In the vicinity of the 900 metres LAST PICASSO (K. Walters) appeared to clip the heels of BLEXY (NZ) (M. Walters) and fell, dislodging K. Walters. K. Walters was transported to hospital. After initially taking evidence from M. Walters, the inquiry was adjourned to a date to be fixed to allow K. Walters to be present. LAST PICASSO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BLEXY (NZ) lost its off hind plate during the event.

BLEXY (NZ) was examined by the Club's Veterinary Surgeon who reported an abrasion to the off hind fetlock.

Stewards questioned M. Walters, the rider of BLEXY (NZ), regarding her riding of the mare from in the vicinity of the 500 metres. After taking evidence from M. Walters, the matter was adjourned to a date and time to be fixed.

### **RACE 5 : ELDERS PENOLA CLASS 2 HANDICAP - 1100 metres**

The start of this race was delayed approximately three minutes owing to the on course Ambulance awaiting arrival of another Ambulance to transport K. Walters to hospital and track repairs in the vicinity of the 900 metres to be completed.

DISCO TILLATE (Jordan Frew) jumped away awkwardly and shifted out, contacting COLLA VOCE (J. Cartwright), and then shifted back in onto ALWAYS FOCUS (P. Marks) resulting in DISCO TILLATE becoming buffeted between those two horses for a number of strides.

Inside the 200 metres DISCO TILLATE (Jordan Frew) shifted out to obtain clear running and brushed COLLA VOCE (J. Cartwright) on two occasions.

COSTLY ARGUMENT (D. Tourneur) became held up for clear running inside the 100 metres when awkwardly placed on the heels of ALWAYS FOCUS (P. Marks) and was untested to the finish.

**RACE 6 : PENOLA HARDWARE RATING 0-76 HANDICAP - 1300 metres**

On jumping away FLAMING MOE (J. Toeroek) was slow into stride.

At the entrance to the straight BROOKLYN ROADS (NZ) (M. Walters) accidentally dropped her whip. M. Walters was issued a warning for carelessness.

For a short distance in the vicinity of the 200 metres, MA SHANG (NZ) (E. Boyd) raced in restricted room between SWIPER (NZ) (P. Marks), which rolled in under pressure, and LIONHEARTED GIRL (S. Cahill), which maintained its line.

Over the concluding stages LIONHEARTED GIRL (S. Cahill) was tightened between MA SHANG (NZ) (E. Boyd), which shifted in, and HONOUR RON (J. Beriman), which rolled out, and was obliged to steady and lose its position. E. Boyd and J. Beriman were reprimanded and advised in future to exercise greater care when their mounts commence to shift ground.

**RACE 7 : RICHARD RAY INSURANCE BROKERS RATING 0-68 HANDICAP - 1700 metres**

LEATHAL'S LEGACY (S. Harrison) was slow to begin.

DICTATORIAL (D. Tootell) raced wide without cover in the early stages of the event.

BLUE HIGHWAY (NZ) was examined by the Club's Veterinary Surgeon who reported a laceration to the off hind leg. First Aid was administered.

**RACE 8 : COOPERS BREWERY RATING 0-65 HANDICAP - 1400 metres**

GATALISTIC (S. Cahill) became disappointed for clear running inside the 200 metres when racing on the heels of SEULAMONT (A. Patterson) and outside ON THE TRAIL (Jordan Frew) for a number of strides and thereafter, when improving into a tight run to the inside of SEULAMONT, which had commenced to roll in, was tightened onto ON THE TRAIL resulting in ON THE TRAIL being inconvenienced. Thereafter, over the concluding stages, GATALISTIC rolled in and momentarily inconvenienced ON THE TRAIL. A. Patterson and S. Cahill were reprimanded and advised to take greater care when their mounts commence to shift ground in future.

In the vicinity of the 100 metres HOTTENOV (NZ) (S. Harrison) rolled in and brushed ROYALS (D. Tourneur), which was inconvenienced when tightened onto SOLITARY MAN (NZ) (M. Walters).

**RACE 4 : DENIS GOULDING EQUINE VETERINARY / SABOIS F&M RATING 0-65 HANDICAP - 1300 metres**

Mrs. F. Walters, representing Mr. W. Walters, the Trainer of BLEXY (NZ), reported that on return to their stables the mare was found to be lame in the off hind leg. Mrs. Walters was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
