Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Wednesday, 6 June 2012

RACE 1: SCHWEPPES 2YO MAIDEN PLATE - 1300 metres

WOAKWINE (D. Tourneur) was slow to jump.

B. Hoppo, the rider of EXCELL SHOES, was questioned regarding his use of the whip prior to the 100 metres. B. Hoppo pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

COLLIDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : BECOME A SAJC MEMBER FILLIES AND MARES MAIDEN PLATE - 1250 metres

S. Casey, the Trainer of URANIA BELLE, which proved difficult to load, was advised that a repetition of this filly's behaviour may lead to action being taken against it.

URANIA BELLE (J. Maund) jumped away awkwardly.

On jumping away DANZEROUND THE SUN (B. Claridge) and GOING CONCERN (S. Westover) brushed.

MAGICAL RUBY (S. Cahill) knuckled on jumping away.

In the vicinity of the 1000 metres, when being restrained, MAGICAL RUBY (S. Cahill) was inclined to get its head up and made the turn awkwardly.

In the straight MAGICAL RUBY (S. Cahill) was inclined to race greenly and shifted about.

Correct weight for this event was delayed to allow S. Cahill, the rider of MAGICAL RUBY, to view the official vision in the straight.

ELEHNI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: CHRISTMAS TWILIGHT 14TH DECEMBER MAIDEN PLATE - 1950 metres

In the early stages DIAGOLAN (NZ) (Jordan Frew) was obliged to race three wide.

Inside the 600 metres BUX THE TREND (A. Herrmann), in attempting to improve, shifted out onto JEUNE ESPRIT (S. Cahill), which was inconvenienced. A. Herrmann was reprimanded and advised to take greater care when shifting ground in future.

In the vicinity of the 400 metres, when attempting to improve, APOSTLE (J. Bowditch) rolled out and brushed THE WILD THING (C. Lever).

Near the 300 metres APOSTLE (J. Bowditch) rolled out and brushed THE WILD THING (C. Lever).

SHARPAY MAGIC was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. D. Clarken, the Trainer of SHARPAY MAGIC, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 4: PINK DIAMOND DAY 24TH NOVEMBER MAIDEN PLATE - 1250 metres

KANGAROO JACK (Jordan Frew) jumped away awkwardly and brushed with THE PEARLY GATES (P. Gatt).

Shortly after the start THE PEARLY GATES (P. Gatt) rolled in onto KANGAROO JACK (Jordan Frew) which was obliged to ease, losing its position when tightened for room.

For some distance from the 1000 metres, when being restrained, KANGAROO JACK (Jordan Frew) was inclined to race keenly.

Approaching the 200 metres, in attempting to improve, KANGAROO JACK (Jordan Frew) shifted out and brushed THE PEARLY GATES (P. Gatt) on several occasions.

T. Zanker, the rider of PUFF, was questioned regarding her use of the whip in the straight. After considering her explanation T. Zanker was reprimanded under ARR.137A(4)(c) with using the whip when, in the opinion of the Stewards, that gelding was not in contention and was cautioned regarding the use of the whip on horses which were out of contention, were not responding or had otherwise no reasonable prospect of improving or losing its position.

NO HITTER was examined by the Club's Veterinary Surgeon who reported a small laceration to the lateral heel on the off hind hoof.

RACE 5 : MELB CUP LIVE RACING AT MORPHETTVILLE 3YO MAIDEN PLATE - 1000 metres

CASH JOB (L. Hopwood) was slow to jump.

Near the 500 metres SOCIAL ASSASSIN (P. Gatt) shifted out and contacted TOPPITOO (T. Pannell) which was inconvenienced.

J. Bowditch, the rider of ME POP'S A RANGA, reported that gelding was inclined to lay out throughout the event.

RACE 6: SPRING RACING AT MORPHETTVILLE CLASS 2 HANDICAP - 1000 metres

DROSTE was examined by the Club's Veterinary Surgeon and ruled fit to start.

AVALON (P. Gatt) was slow to begin.

RACE 6 : SPRING RACING AT MORPHETTVILLE CLASS 2 HANDICAP - 1000 metres (Cont'd)

On jumping away, SPARKLING BELLA (J. Potter) shifted out onto WINE LOVER (B. Claridge) which was hampered.

On jumping away, ALANZA (A. Patterson) shifted out and brushed SOPHINA (L. Hopwood).

Near the 600 metres REAL FANTASY (D. Tourneur) shifted in and contacted DELTA RHO SAM (M. Pegus) resulting in both runners being unbalanced.

Inside the 300 metres WINE LOVER (B. Claridge), in attempting to improve, shifted out onto ANGEL OF HOPE (C. Lindop) which was inconvenienced. B. Claridge was reprimanded and advised in future to ensure there was adequate room when attempting a run.

L. Stojakovic, the rider of DROSTE, was questioned regarding her use of the whip in the straight. L. Stojakovic pleaded guilty to a charge under ARR.137A(3) in that she used her whip, in the Stewards opinion excessively. She was reprimanded and cautioned that a similar breach in the future will result in a penalty being imposed.

RACE 7: CENTREBET RATING 0-62 HANDICAP - 1400 metres

ARTIE'S ANGEL (B. Claridge) was slow into stride.

Shortly after the start THE BOILERMAKER (S. Westover) shifted in onto BARRIERS (C. Lever) initially taking that gelding in prior to it being steadied off the heels of THE BOILERMAKER, losing its position. As BARRIERS was taken in, DOUBLE CREAM (C. Lindop) was tightened for room and, as a consequence, altered course. An inquiry into this incident was adjourned to permit the Stewards to interview Ms. S. Barr, the Trainer of THE BOILERMAKER, examine the horse with regard to evidence advanced to the inquiry in regards to the condition of THE BOILERMAKER'S teeth and comments allegedly made by the Trainer to the apprentice pre-race.

Near the 1000 metres CLASSIC CAMEO (J. Toeroek), when being restrained off the heels of BARRIERS (C. Lever) shifted out abruptly and contacted ELSEWHERE (A. Herrmann) turning its hindquarters out.

From the 400 metres to inside the 100 metres OTTANA (J. Holder) was unable to obtain clear ground when attempting to improve inside the heels of BARRIERS (C. Lever).

Approaching the 200 metres BRUNO (T. Pannell) shifted out onto THE BOILERMAKER (S. Westover) which was obliged to be steadied.

Approaching the 200 metres HONG KONG MISSY (B. Claridge) initially rolled out onto DOUBLE CREAM (C. Lindop) which, as it improved, rolled back to its line resulting in HONG KONG MISSY being momentarily held up on the heels of ARTIE'S ANGEL (P. Gatt).

BARRIERS lost its off fore plate during the event.

RACE 8: IRISH DAY 1ST SEPTEMBER RATING 0-68 HANDICAP - 1250 metres

Ms. L. Faust, the Trainer of SHAKETHEGROUND, which was reluctant to load, was advised that a repetition of the gelding's behaviour may lead to action being taken against it.

PENZEVENGI (J. Bowditch) was slow to jump.

SHAKETHEGROUND (L. Stojakovic) jumped away awkwardly and knuckled.

RACE 8: IRISH DAY 1ST SEPTEMBER RATING 0-68 HANDICAP - 1250 metres (Cont'd)

Approaching the 1100 metres, for some distance, BIGBADBARRY (L. Hopwood), was inclined to race keenly when in restricted room between FLOWER FORCE (B. Claridge) and NOTHING SHALL PASS (D. Tourneur).

Approaching the 1000 metres RUB DOUBT (Jordan Frew) rolled out onto PARK RANGER (D. Evans) which was inconvenienced.

In the vicinity of the 1000 metres BIGBADBERRY (L. Hopwood), which continued to race keenly, was inconvenienced by FLOWER FORCE (B. Claridge) which rolled out taking BIGBADBARRY onto the hindquarters of NOTHING SHALL PASS (D. Tourneur).

In the vicinity of the 300 metres THE PRINCESS (J. Potter) had difficulty in obtaining clear ground when racing behind FLOWER FORCE (B. Claridge) which commenced to give ground and inside BIGBADBARRY (L. Hopwood).

GENERAL

RACE 4: PINK DIAMOND DAY 24TH NOVEMBER MAIDEN PLATE - 1250 metres

Mrs. M. Oliver, the Trainer of PUFF, was questioned regarding the late arrival on course of that horse. Mrs. Oliver acknowledged that she had overlooked the requirement to be on course for a metropolitan meeting but submitted that a traffic issue en route had unduly delayed her. After considering this explanation Mrs. Oliver was reprimanded and advised in future breaches would result in a penalty being imposed.

RACE 5 : MELB CUP LIVE RACING AT MORPHETTVILLE 3YO MAIDEN PLATE - 1000 metres

Prior to this event Mr. L. Kennewell, the Trainer of ME POP'S A RANGA, approached Stewards and submitted that prior to acceptance time he had removed winkers from the approved gear from ME POP'S A RANGA, and requested the gelding race without the gear. After making brief inquiries the Stewards permitted ME POP'S A RANGA to race without winkers and notified the race callers. Mr. Kennewell was advised that the Stewards would make further inquiries of RISA regarding his submission.

RACE 8: IRISH DAY 1ST SEPTEMBER RATING 0-68 HANDICAP - 1250 metres

Stewards heard a report from the official Starter regarding an exchange which occurred at the start between L. Stojakovic, the rider of SHAKETHEGROUND and Mr. W. Bartlett, the Assistant Starter, alleging conduct which, in his opinion, was counter productive to the attempts to load SHAKETHEGROUND. Miss Stojakovic admitted being agitated when attendants continued to attempt to load her mount when it was obstructed by one of the rear barrier gates. Both Miss Stojakovic and Mr. Bartlett, who admitted certain retaliation, were reprimanded and advised in future to conduct themselves with a greater degree of professionalism.
