**RACE 1 : COOPERS PALE ALE MARES RATING 0-75 HANDICAP - 1500 metres**

TWILIGHT DANCER (B. Claridge) and EPOCHAL (NZ) (D. Tourneur) were slow to begin.

TWILIGHT DANCER (B. Claridge) raced ungenerously for some distance in the early and middle stages of the event.

In the vicinity of the 1100 metres LUCENUP (D. Stra) became awkward on the heels of ELSEWHERE (M. Neilson) as the pace slackened, shifted about and contacted the running rail.

EPOCHAL (NZ) (D. Tourneur) hung out over the concluding stages of the event resulting in D. Tourneur having to stop riding and straighten the mare.

**RACE 2 : COOPERS LAGER / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres**

EXALTED FILLY (L. Hopwood) jumped away awkwardly, shifted out and contacted HEART TO HEART (J. Maund), which was taken out onto KHALAH ROSE (J. Kah) resulting in these two horses coming together.

MAPLE LANE (T. Zanker) was slow to begin.

MY CHANTILLY (D. Tourneur) and SHESHOOTSSHESCORES (J. Holder) brushed on jumping away.

**RACE 2 : COOPERS LAGER / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres (Cont'd)**

Approaching the 800 metres SHADOW JUDGEMENT (A. Patterson) shifted in and tightened HEART TO HEART (J. Maund) onto EXALTED FILLY (L. Hopwood), which was taken out slightly by BIANCA MARIE (Jordan Frew), which rolled out. As a consequence both HEART TO HEART and EXALTED FILLY were inconvenienced. A. Patterson was reminded of his obligations when shifting ground in future.

At the entrance to the straight HEART TO HEART (J. Maund) became held up for clear ground for a short distance between the heels of PEBBLE ROCK (D. Evans) and SHADOW JUDGEMENT (A. Patterson).

BIANCA MARIE (J. Frew) was inclined to lay out in the straight.

TEENAGE QUEEN (S. Cahill) raced in restricted room over the concluding stages as SHESHOOTSSHESCORES (J. Holder) laid in.

S. Cahill, the rider of TEENAGE QUEEN, reported his mount laid in, in the straight.

**RACE 3 : GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE - 1700 metres**

COOGEE COOZIFA sprung its off fore plate in the mounting enclosure and had to be attended to by the Farrier before proceeding to the barriers. On arrival at the barriers COOGEE COOZIFA was examined by the Club's Veterinary Surgeon and ruled fit to race.

L. Hopwood, the rider of STING LIKE A BEE, explained her mount was under pressure from in the vicinity of the 800 metres and failed to respond to her riding. STING LIKE A BEE was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

A. Herrmann, the rider of TOKEN ONE, explained her mount travelled well until the entrance to the straight where it was under pressure and failed to respond to her riding. TOKEN ONE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FRAANIKOVA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : CRITERION TAVERN / SABOIS MAIDEN PLATE - 1200 metres**

ZAKYNTHOS EMPIRE was examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

FULL BORE (T. Pannell) shifted out shortly after the start and contacted FREE FOR ALL (L. Hopwood).

KALO TAXITHI (S. Cahill) jumped away awkwardly and was slow to begin.

In the vicinity of the 1100 metres CRYSTAL GAZER (D. Evans) rolled in and away from EMMOOKI'S DASH (D. Tourneur), which shifted in and inconvenienced FREE FOR ALL (L. Hopwood).

OUR LAGO (J. Maund) raced greenly throughout the event.

ZAKYNTHOS EMPIRE (A. Patterson) raced wide without cover in the early and middle stages of the event.

#### **RACE 4 : CRITERION TAVERN / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)**

T. Pannell, the rider of FULL BORE, which raced wide on the home turn and into the straight, reported the gelding laid out throughout the event. FULL BORE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

L. Hopwood, the rider of FREE FOR ALL, which raced wide on the home turn and into the straight, reported her mount was inclined to run off. FREE FOR ALL was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off side cheek.

L. Stojakovic, the rider of GREAT MEMORIES, which raced wide into the straight, reported that after making an election to improve outside of FREE FOR ALL (L. Hopwood) approaching the 400 metres, she was obliged to race wide when taken out by FREE FOR ALL, which failed to negotiate the turn. She added that she had no option and was committed to the run in the circumstances.

A Patterson, the rider of ZAKYNTHOS EMPIRE, reported his mount felt awkward in its action on pulling up. ZAKYNTHOS EMPIRE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 5 : TARRAWATTA / CLASS 2 HANDICAP - 1700 metres**

DUBAI VENGEANCE (J. Potter) raced wide throughout the event.

MONSTARHIT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 6 : COOPERS DR TIMS RATING 0-62 HANDICAP - 2100 metres**

Near the 2000 metres CROCODILE TEARS (D. Tourneur) and SPIRIT LINE (A. Patterson) shifted in and inconvenienced ZABDUED (NZ) (A. Herrmann), which had to be steadied to avoid the heels of SPIRIT LINE. D. Tourneur and A. Patterson were reminded of their obligations when shifting ground in future.

#### **RACE 7 : WATERSEARCH / SABOIS 3YO RATING 0-68 HANDICAP - 1500 metres**

The start of this race was delayed approximately two minutes owing to ducks situated on the track near the 900 metres having to be cleared off the track.

GRANULATOR (C. Lindop) raced wide without cover in the early stages of the event.

MONEY BAGS (A. Patterson) became held up for clear running behind DONNA CECILIA (J. Kah) for a short distance approaching the 500 metres and thereafter, approaching the 400 metres, MONEY BAGS was disappointed when racing between DONNA CECILIA, which rolled in, and SHAABAM (T. Pannell), which improved into a run to the inside of MONEY BAGS.

At the entrance to the straight SHAABAM (T. Pannell) shifted out to improve and brushed with DONNA CECILIA (J. Kah), which was taken out onto BOSSED (B. Claridge), which was taken wider.

**RACE 8 : KINGSFORD HOTEL RATING 0-62 HANDICAP - 1100 metres**

S. Westover, the rider of ARCTIC CASH, reported the mare made a breathing noise near the 200 metres and commenced to weaken. ARCTIC CASH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WHERE'S TIM (J. Potter) jumped away awkwardly, shifted out and brushed with ENERGIZED (IRE) (J. Kah).

In the vicinity of the 900 metres STELLA JEUNE (C. Lindop), which became awkwardly placed on the heels of KUITPO DANCER (J. Maund), was obliged to steady and alter course to the inside of that mare.

Shortly after the entrance to the straight WANAKA GOLD (J. Holder) became held up for clear running on the heels of CANNY PREVAIL (M. Tyndall) and was only able to obtain clear ground near the 100 metres.

In the vicinity of the 150 metres WHERE'S TIM (J. Potter), which laid out, shifted out and tightened ARCTIC CASH (S. Westover), which was weakening, inconveniencing that mare resulting in ARCTIC CASH having to be steadied. J. Potter was reminded of his obligations when his horses commence to shift ground.

Approaching the 100 metres CANNY PREVAIL (M. Tyndall) rolled out under pressure and inconvenienced KOODA WONDER (B. Claridge), which had to be steadied. M. Tyndall was reminded of her obligations.

WANAKA GOLD lost its near fore plate during this event.
