**RACE 1 : TRENCHLESS PIPELAYING CONTRACTORS HANDICAP - 1000 metres**

INFINITE FORTUNE (J. Bowditch) jumped away awkwardly.

M. Pegus, the rider of INDUBIOUS, explained that it was his intention to take up a more forward position in running but due to the pace in the event and his mount's reluctance to respond to his riding, he was obliged to settle further back in the field. He added that the colt was under pressure shortly after entering the straight and was inclined to lay in near the 200 metres.

LITTLE CRITTER was examined by the Club's Veterinary Surgeon who reported a minor laceration to the off hind cannon. First aid was administered.

BRIMARVI DUE FACE was examined by the Club's Veterinary Surgeon who reported moderate cramping in both shoulders.

**RACE 2 : RICHARDS LEGAL BARRISTERS AND SOLICITORS HANDICAP - 1050 metres**

The start of this race was delayed approximately three minutes owing to the tongue tie on PUNCTUATE having to be replaced. PUNCTUATE was examined by the Club's Veterinary Surgeon and ruled fit to start.

J. Bowditch, the rider of BET THE FARM, reported that from the vicinity of the 500 metres the gelding commenced to labour and raced in a very awkward fashion and was on one rein over the concluding stages of the event.

AVALON (J. Holder) was inconvenienced at the start and lost its position when tightened for room between PUNCTUATE (Jordan Frew) who shifted out and away from A WEE DRAM (S. Westover) who jumped away awkwardly, and COLLA VOCE (S. Harrison) which shifted in and away from KOODA WONDER (B. Claridge).

**RACE 2 : RICHARDS LEGAL BARRISTERS AND SOLICITORS HANDICAP -**  
**1050 metres (Cont'd)**

SHOT IN JEST (M. Neilson) jumped away awkwardly and was slow to begin.

In the vicinity of the 800 metres SHOT IN JEST (M. Neilson) was inclined to race keenly for a short distance.

Following the running of this event, BET THE FARM collapsed on return to its raceday stall. BET THE FARM was attended to by the Club's Veterinary Surgeon who declared the gelding to be deceased and that in his opinion the horse had ruptured a major blood vessel internally. As a result of experiencing some difficulty in removing BET THE FARM from the raceday stall area, the start times for the following races were amended as follows:

**RACE 3 : OXFORD INSURANCE BROKERS HANDICAP - 1050 metres**

S. Kavanagh, the Trainer of SUBARC, was questioned regarding the Thoroughbred Identification Card not being available for that gelding. As Stewards were able to establish the identity of SUBARC from records held by them, the gelding was permitted to start. Having considered the explanation provided, S. Kavanagh was fined \$50 under ARR.59A.

KOODA DAWN (B. Claridge) jumped away awkwardly and was slow to begin.

In the vicinity of the 600 metres OUR SNIPPY (J. Holder) shifted in and crossed the running of OGUNDE (S. Harrison) which was obliged to shift to the outside of that horse's heels and in doing so SECRET STATUS (C. Lindop) became awkwardly placed on the heels of OGUNDE for a number of strides and lost its position. J. Holder was reminded of his obligations when shifting ground.

Shortly after entering the straight SECRET STATUS (C. Lindop), which was disappointed for clear running, shifted to the outside of IMPERIAL FURY (L. Stojakovic) and attempted a tight run between that horse and EL PRADO GOLD (S. Westover) which rolled in and thereafter became held up on the heels of IMPERIAL FURY (L. Stojakovic) and OGUNDE (S. Harrison), which rolled out, until inside the 200 metres.

SUBARC, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : VIP HOME SERVICES HANDICAP - 2600 metres**

WILFUL LAD and RISK IT ALL, which arrived late on course, were examined by the Club's Veterinary Surgeon and passed fit to race.

FASTIZIO (D. Tourneur) jumped away very awkwardly and unbalanced its rider.

RISK IT ALL (J. Fry) jumped away awkwardly, shifted out, and contacted DOUBLY SURE (NZ) which was inconvenienced.

DOC HENNESSY (J. Potter) was inclined to lay out in the straight.

Correct Weight for this event was delayed to permit J. Fry, the rider of the fourth placegetter, RISK IT ALL, to view the official photo finish.

#### **RACE 4 : VIP HOME SERVICES HANDICAP - 2600 metres (Cont'd)**

D. Stackhouse, the rider of STAR SCREAM, explained that the gelding was under pressure from the entrance to the straight and in his opinion, finished the race off poorly.

HURRICANE THUNDER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mrs. C. Rose, the Trainer of HURRICANE THUNDER, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

#### **RACE 5 : NOCELLE FOODS HANDICAP - 1800 metres**

The start of this race was delayed approximately two minutes due to GOLD FRENZY proving fractious behind the barriers. Mr. T. Snelling, the Trainer of GOLD FRENZY, was advised that a warning had been placed on this gelding in relation to its barrier manners.

Inside the 1400 metres FULL OF CACHE (M. Neilson) became awkwardly placed on the heels of HIGH VALUE (J. Maund) for a number of strides.

VELOCIDADE (J. Toeroek) raced wide without cover in the middle stages of the event.

C. Lindop, the rider of JULIET'S PRINCESS, was questioned regarding her riding instructions. She explained she was instructed to race from a position back in the field with cover but due to its favourable barrier draw, the manner in which the filly began, the early pace and the positioning of the field in the early stages of the event, she found herself forward and was reluctant to allow the runners to her outside to cross and race in the box seat as she was of the view this would not best suit the horse. Thereafter near the 1000 metres when horses improved to her outside, she was of the opinion that the filly was inclined to race a touch keenly and for this reason she allowed her mount to stride clear as she formed the view that the horse would be better suited to race in a relaxed manner without horses challenging to its immediate outside. She also added the filly was racing well within itself at that point and was breathing normally. She concluded, and Stewards concurred, that in hindsight after reviewing the footage, she may have been better served in not allowing her mount to stride clear to the extent it did between the 1000 metres and 800 metres. JULIET'S PRINCESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FULL OF CACHE was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. P. Stokes, the Trainer of FULL OF CACHE, was advised a Veterinary Certificate of Fitness would be required prior to the accepting for a future trial or race.

#### **RACE 6 : ANTHONY SCOPELITIS MEMORIAL HANDICAP - 1200 metres**

Approaching the 800 metres LIKABLE WILL (M. Walters) became awkwardly placed on the heels of AVIONICS (D. Tourneur) when the place slackened and was obliged to alter course to the outside of that horse to obtain clear running. D. Tourneur's attention was drawn to the rules relating to slowing the pace.

S. Cahill, the rider of LEXCEN, reported that his mount felt awkward in its action behind and as a consequence he eased his mount out of the event approaching the 100 metres.

LEXCEN and PERIDUKI were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : IAN FILSELL MEMORIAL HANDICAP - 1600 metres**

Prior to the start of this race, at the Trainer's request, BALLYPATRICK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

The start of this race was delayed approximately two minutes owing to the delays experienced earlier in the day.

TABULATED (J. Fry) jumped away awkwardly and shifted in taking DRAFTER (J. Holder) in onto L'ESPRIT (D. Stackhouse) which in turn took BALLYPATRICK (L. Stojakovic) in onto SILVER MOMENT (C. Lindop).

BOLD DAZZLER (M. Neilson) raced wide without cover in the early stages of the event.

M. Pegus, the rider of TARA MAN, reported that the gelding laid in throughout the event. TARA MAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

S. Cahill, the rider of SAVANNAH'S CHOICE, explained that the mare responded reasonably well to his riding from the 600 metres to the 400 metres but thereafter was under pressure and failed to respond to his riding and commence to give ground. SAVANNAH'S CHOICE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

HONOURABLE KIND lost its near hind plate during the event.

**RACE 8 : BURNS CEILINGS AND BUILDING SUPPLIES HANDICAP - 1200 metres**

S. Kavanagh, the Trainer of IRON LACE, was questioned regarding the Thoroughbred Identification Card not being available for that mare. As Stewards were able to establish the identity of IRON LACE from records held by them, the mare was permitted to start. Having considered the explanation provided, S. Kavanagh was fined \$50 under ARR.59A.

STATUE OF GLORY (J. Potter) knuckled at the start.

ZAAMMISSION (J. Holder) was slow to begin.

SILVER RAVEN (S. Westover) jumped away awkwardly, shifted out and tightened ASTERIX (D. Stackhouse) onto THE RUSSELER (L. Stojakovic).

SIX CROWNIES (J. Bowditch) shifted out on jumping away and contacted IMPERIAL LINES (J. Toeroek).

D. Stackhouse, the rider of ASTERIX, explained that his instructions were to race from a position back in the field and to improve to the outside of the field and not place the gelding between runners as the horse is reluctant to gallop when raced in this manner. He stated that in complying with these instructions he was forced to race very wide into the straight when taken wider on the home turn. He stated that the horse responded well to his riding but may have peaked in its run near the 100 meters.

ASTERIX was examined by the Club's Veterinary Surgeon who reported who reported no visible abnormalities.
