RACE 1 : ADELAIDE IMAGE PRINTING / SABOIS DISTANCE MAIDEN PLATE -
2100 metres

ELEGIDO was examined by the Club's Veterinary Surgeon on arrival on course and was found to be lame in the off foreleg. Acting on that advice Stewards withdrew ELEGIDO at 10.18am.

SWING ALONG (B. Claridge) jumped away awkwardly and as a result was slow to begin.

Racing inside the 1800 metres MAGUS (NZ) (M. Neilson), when being restrained, rolled in and brushed the rail resulting in the mare being momentarily unbalanced.

Racing from the 800 metres and for the remainder of the event, FRAANIKOVA (J. Kah) was inclined to lay out.

Subsequent to the event, Mr. J. Macmillan, the Trainer of FRAANIKOVA, reported that the mare had returned to scale with its tongue over the bit. FRAANIKOVA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : RENTOKIL / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1100 metres

D'ARTAGNAN, which was fractious in the barriers after being loaded and became cast, was examined by the Club's Veterinary Surgeon who ruled the gelding unfit to race. Acting on that advice, Stewards withdrew D'ARTAGNAN at 11.50 pm. Mr. T. McEvoy, the Trainer of D'ARTAGNAN was advised the gelding would be required to prove tractable in the barriers in an Official Barrier Trial prior to accepting for a future race.

RACE 2 : RENTOKIL / SABOIS TWO-YEAR-OLD MAIDEN PLATE -
1100 metres (Cont'd)

JADIPECH was examined by the Club's Veterinary Surgeon and passed fit to race.

JUST A SPARK (Jordan Frew) and SUNSIGN (D. Tootell) were slow to begin.

SPOILSPOT (A. Patterson) and CASTANO GIRL (J. Bowditch) brushed on jumping.

Racing to the 800 metres HEART 'N' SPIRIT (A. Herrmann) and JADIPECH (L. Hopwood) had to steady and lose their position when tightened by CASTANO GIRL (J. Bowditch) which raced ungenerously and shifted in and away from JACKS JOURNEY (J. Kah).

LIGHT SUPREME was examined by the Club's Veterinary Surgeon and was found to be lame in the near foreleg. Mr. S. Gower, the Trainer of LIGHT SUPREME, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 3 : RENTOKIL / SABOIS MAIDEN PLATE (Division 1) - 1200 metres

GOLD TILLIE was examined by the Club's Veterinary Surgeon on arrival on course and was found to be lame in the near foreleg. Acting on this advice, Stewards withdrew GOLD TILLIE at 11.25am.

Shortly after the start, NABAWIN (J. Bowditch) shifted out inconveniencing HEAVENSAKE (T. Baker).

Rounding the home turn and in the home straight, KOODA CHANCE (K. Bishop) was inclined to lay out and as a result, after entering the straight, MEADOWS STORM (C. Lindop) was taken wider on the track.

Approaching the 200 metres MEADOWS STORM (C. Lindop) had to take hold and alter course to the inside of KOODA CHANCE (K. Bishop) which continued to lay out resulting in that gelding finishing its race off on the outside of the track. KOODA CHANCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. . Mr. J. Dunn, the Trainer of KOODA CHANCE, was advised a warning has been placed on this gelding

RACE 4 : COOPERS PALE ALE / SABOIS MAIDEN PLATE (Division 2) - 1200 metres

CASH JOB (D. Stra) jumped away awkwardly and as a result was slow to begin.

MOONBOOTS (L. Hopwood) and LADY SONRO (J. Kah) brushed on jumping.

Racing to the 300 metres FREE ENTRY (M. Tyndall), when racing greenly, rolled in and had to momentarily steady off the heels of OUR LAGO (J. Maund).

Approaching the 100 metres M. Tyndall, the rider of FREE ENTRY, accidentally dropped her whip. M. Tyndall was reprimanded and advised that future carelessness may result in a penalty being imposed.

RACE 5 : PALLETCO SA MAIDEN PLATE - 1700 metres

Shortly after the start PRETTY BLONDE (J. Potter) shifted out and contacted WHAT LOGIC (S. Cahill) causing WHAT LOGIC to dip and lose its position, and its rider to become unbalanced.

RACE 5 : PALLETCO SA MAIDEN PLATE - 1700 metres (Cont'd)

Racing in the early and middle stages of the event GIANT VICTORY (D. Evans) was inclined to race ungenerously and near the 1200 metres was obliged to be restrained from the heels of WHY NOT YOU (J. Bowditch).

Racing to the 500 metres PRETTY BLONDE (J. Potter) had to check and lose its position when being restrained off the heels of the tiring TEENAGE QUEEN (J. Toeroek).

P. Gatt, the rider of BLEVIC LAD, which performed poorly, explained that the gelding, after being put in a three wide position in the vicinity of the 1400 metres, had to do more work than was anticipated and in his opinion, after making its run from the 700 metres, he believed that the gelding was at the top of its run from the 500 metres and thereafter failed to respond to his riding. BLEVIC LAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct weight was delayed to allow A. Patterson, the rider of the fourth placegetter, TOBY'S STATEMENT, to view the official patrol films in the home straight. After doing so correct weight was declared.

RACE 6 : AKERS OF LAWN RATING 0-68 HANDICAP - 1700 metres

TWILIGHT DANCER (D. Tourneur) and SLACKSMITH (NZ) (A. Herrmann) were slow to begin.

Racing to the 400 metres TWILIGHT DANCER (D. Tourneur) and LANDAMMAN (Jordan Frew) brushed.

RACE 7 : HAPPY BIRTHDAY GREG OMAN RATING 0-68 HANDICAP - 1100 metres

AVALON (J. Holder) was slow to begin.

Racing to the 800 metres BELSYND (J. Bowditch) had to steady away from the heels of THE BAY ROD (J. Maund) when taken in slightly by DARAKAN (M. Neilson), which momentarily laid in.

Racing from the 600 metres to the 400 metres BELSYND (J. Bowditch) was held up for clear running on the heels of DARAKAN (M. Neilson).

Racing to the 400 metres SAINT SHA ROSE (B. Claridge) shifted in resulting in THE BAY ROD (J. Maund) having to momentarily steady. B. Claridge was reminded of his obligations when shifting ground.

Racing from the 50 metres to the finish line FRENCH CHARGE (P. Gatt) was held up for running when racing tight between HE'S A HOUNDOG (K. Bishop) and BELSYND (J. Bowditch).

ODETTE was examined by the Club's Veterinary Surgeon who reported the mare was lame in the near foreleg. Ms. L. Conlon, the Trainer of ODETTE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Mr. B. Brook, the Trainer of HE'S A HOUNDOG, reported to Stewards that blood was detected in this gelding's right nostril. Acting on that advice Mr. Brook was advised that HE'S A HOUNDOG would be required to gallop 1000 metres to the Stewards' satisfaction prior to presenting for a future trial or race in accordance with ARR.53A(7).

RACE 8 : TYPHON AT GLENRAE / SABOIS FILLIES & MARES RATING 0-68 HANDICAP – 1500 metres

SILVER MOMENT (M. Schrapel) reared on jumping and as a result was slow to begin.

DUBAI ME ROSES (A. Patterson) and ANGEL EYES (K. Bishop) were slow to begin.

Approaching the 400 metres JUST PUSH ON (P. Gatt) had to check off the heels of WHERE'SCHRISTOPHER (W. Kerford) which was tiring quickly. In being checked, JUST PUSH ON shifted out abruptly onto FERROQUEST (E. Boyd) which had to be checked when taken out onto ANGEL EYES (K. Bishop) which in turn had to be checked when tightened onto CLASSIC CAMEO (M. Neilson) which checked after being taken in by BAR ROOM BELLE (M. Tyndall) which shifted ground. As a consequence, MORELIA (NZ) (J. Potter), which was racing on the heels of ANGEL EYES had to be steadied and alter course abruptly out, resulting in that mare being obliged to check to avoid the heels of DUBAI ME ROSES (A. Patterson). M. Tyndall was reminded of her obligations when shifting ground.

RACE 9 : AWH COLTS, GELDINGS & ENTIRES RATING 0-62 HANDICAP – 1500 metres

BRINKLEY BULLET (J. Bowditch) was slow to begin.

Racing to the 400 metres SCARLET CROSS (S. Westover) had to momentarily steady when MOUNT MEE UP (A. Patterson) shifted out to improve its position. A. Patterson was reminded of his obligations when shifting ground.
