**Report on Race Meeting held at the Port Augusta Racecourse**  
**by the Port Augusta Racing Club on Thursday, 26 July 2012**

**RACE 1 : REMEMBER WHYALLA CUP DAY SEPTEMBER 9 / SABOIS MAIDEN PLATE –**  
**1400 metre**

RUN FOR CASH (D. Evans) shifted out on jumping away tightening DAZED (P. Roff) onto IMAGINARIUM (J. Kah).

CHAMPLEVE (W. Kerford) jumped away awkwardly.

From in the vicinity of the 300 metres KANGAROO JACK (L. Hopwood) commenced to lay out.

KANGAROO JACK (L. Hopwood) continued to lay out over the final 50 metres taking STING LIKE A BEE (T. Pannell) out across the heels of DAZED (P. Roff), resulting in STING LIKE A BEE having to be eased. L. Hopwood was reprimanded and advised to take greater care in future when shifting ground.

J. Kah, the rider of IMAGINARIUM, was questioned regarding her use of the whip prior to the 100 metres. She pleaded guilty to charges under ARR.137A(5)(a)(i) & (ii) in that she used her whip in a forehand manner on consecutive occasions and on more than five occasions prior to the 100 metres and was fined \$250 for each breach.

KANGAROO JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STING LIKE A BEE was examined by the Club's Veterinary Surgeon who reported the gelding to be suffering from neck soreness. First Aid was administered. Mr. A. Beswick, the Trainer of STING LIKE A BEE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**RACE 2 : PORT AUGUSTA CITY COUNCIL RATING 60 & OVER HANDICAP – 1600 metres**

In the vicinity of the 700 metres CLUB HA HA (A. Patterson) was obliged to ease momentarily as SAGWALA (W. Kerford) rolled in.

Inside the 400 metres SAGWALA (W. Kerford) was obliged to ease momentarily as CLUB HA HA (A. Patterson) rolled in.

J. Potter, the rider of WORLD RULER (NZ), was questioned regarding a celebratory gesture prior to the finish. J. Potter pleaded guilty to a charge under ARR.137(c) in that he made a celebratory gesture prior to the finish and was fined \$250.

**RACE 2 : PORT AUGUSTA CITY COUNCIL RATING 60 & OVER HANDICAP – 1600 metres**  
**(Cont'd)**

WORLD RULER (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding had bowed its off fore tendon. Mr. M. White, the Trainer of WORLD RULER (NZ), was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**RACE 3 : BAGMAN DISTRIBUTION SERVICES / SABOIS MAIDEN PLATE – 1100 metres**

On arrival at the barriers BIT O' ME was examined by the Club's Veterinary Surgeon and ruled fit to race.

Ms. S. Salvemini, the Trainer of SAL'S SHINKO, was advised a warning had been placed on the gelding as it proved difficult to load.

DON'T LOOK DOWN (J. Toeroek) knuckled on jumping away.

Approaching the 800 metres DON'T LOOK DOWN (J. Toeroek) rolled out onto ACES WE HOLD (Jordan Frew) which was taken out contacting SAL'S SHINKO (M. Tyndall), unbalancing that gelding for a short distance.

BIANCA MARIE lost its near fore plate during the event.

**RACE 4 : PHILLIP KITTEL MEMORIAL RATING 0-59 HANDICAP - 1600 metres**

On jumping away TONI'S CONNECTION (M. Tyndall) shifted out onto AS A RULE (D. Evans) taking that gelding out onto OUT DO ME (J. Kah), which was forced to race in restricted room for a short distance when being tightened onto ARAKAZEL (J. Toeroek).

M. Tyndall, the rider of TONI'S CONNECTION, reported the gelding was inclined to lay out rounding the home turn.

**RACE 5 : MY CARWASH RATING 0-68 HANDICAP - 1200 metres**

In the vicinity of the 800 metres MONFILS (B. Claridge) was obliged to ease momentarily when BLACK BARRA (P. Roff) rolled in.

MONFILS (B. Claridge) was held up for clear running on the heels of LOVE A SEQUALO (A. Herrmann) and to the inside of BLACK BURRA (P. Roff) from inside the 400 metres until entering the straight.

J. Toeroek, the rider of ROLL OF THE DICE, reported to Stewards he had been instructed to lead if possible, however, due to the gelding jumping mid-field and the formation of the field, he was unable to fully comply with these instructions and was obliged to settle forward, three wide without cover. He added that in the vicinity of the 600 metres the mare was under pressure and failed to respond to his riding and finished the race off in a disappointing fashion, and in his opinion did not handle the track. ROLL OF THE DICE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ENCOSTA DELIGHT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : PASTORAL HOTEL / MOTEL RATING 0-64 HANDICAP - 1850 metres**

J. Toeroek, the rider of the third placegetter MOUNTAIN CLIMBER, was questioned regarding his failure to weigh in after the event. J. Toeroek pleaded guilty to a charge under ARR.144 in that he failed to weigh in as required by the Rules and was fined \$200.

**RACE 7 : XXXX GOLD RATING 0-59 HANDICAP - 1100 metres**

Mr. D. Courtney, the Trainer of LYNSHEE, was advised a warning had been placed on the gelding in relation to its reluctance to proceed to the barriers.

The start of this race was delayed seven minutes owing to an issue with the vehicle used to transport the barrier staff.

On jumping away DO SOMETHING (B. Claridge) was inconvenienced momentarily when tightened between DRIFTING SPIRIT (M. Tyndall), which shifted out, and KELPORT (A. Herrmann), which rolled in.

B. Claridge, the rider of DO SOMETHING, reported the gelding never travelled throughout the event. DO SOMETHING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LYNSHEE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. D. Courtney, the Trainer of LYNSHEE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**RACE 8 : JM DELI RATING 0-61 HANDICAP - 1400 metres**

On arrival the barriers GALADAN was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Acting on this advice, Stewards withdrew GALADAN at 4.13 pm. Mr. D. Halliday the Trainer of GALADAN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

GENARKA STAR (C. Lindop) dipped on jumping away.

AL CHICAGO (Jordan Frew) jumped away awkwardly.

GRACEFUL EDGE (L. Hopwood) was slow to begin.

From in the vicinity of the 400 metres MALEBO MAGIC (W. Kerford) was unable to obtain clear ground until inside the 150 metres when racing on the heels of DASHMAN (J. Kah) and to the inside of AL CHICAGO (Jordan Frew).

In the vicinity of the 300 metres PERFECT BEAU (J. Toeroek) was unable to obtain clear ground until entering the straight when racing on the heels of GENARKA STAR (C. Lindop) and to the inside of MALEBO MAGIC (W. Kerford).
