Report on Race Meeting held at Balaklava Racecourse by the Balaklava Racing Club on Wednesday, 5 September 2012

RACE 1: ATLAS EVENT & PARTY HIRE / SABOIS MAIDEN PLATE - 1600 metres

Mr. K. Sweeney, the Trainer of WHERE'S THAT, which lead against instructions at its previous start, advised he would emphasise to rider, S. Westover, if possible, to ride the gelding behind mid field with cover.

Near the 1100 metres FROESE (J. Toeroek), after receiving minor pressure, shifted out onto CURRAHEE (A. Patterson) which was inconvenienced. In consequence, CURRAHEE shifted out onto WHERE'S THAT (S. Westover) which was also inconvenienced.

Approaching the 100 metres WHERE'S THAT (S. Westover), which was inclined to lay in, rolled in and brushed SET TO EXCITE (M. Neilson).

J. Toeroek, the rider of FROESE, reported that the gelding appeared sore after passing the finish. FROESE was examined by the Club's Veterinary Surgeon who reported the gelding had sustained a superficial strain injury to the near fore flexor tendon and was lame in the near foreleg. Mr. S. Trenowden, the Trainer of FROESE, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

RACE 2: BARDRILL BARTON / SABOIS 3YO MAIDEN PLATE - 1050 metres

GENEROUS BELLE was withdrawn by Stewards at 12.32 pm when after several attempts, it would not allow the rider to take his seat. Mr. R. Balfour, on behalf of Mr. D. Balfour, the Trainer of GENEROUS BELLE, was advised that a repetition of the filly's behaviour may lead to action being taken against it.

Mr. B. Lear, the Trainer of PROPSHAFT, which proved difficult to load, was advised that a repetition on the gelding's behavior may lead to action being taken against it.

SCHADUW (J. Kah) and THE HEADLINER (M. Neilson) were slow to jump.

PROPSHAFT (L. Hopwood) jumped away awkwardly.

FORCE OF THREE (J. Holder) jumped away awkwardly losing its hind legs.

RACE 2: BARDRILL BARTON / SABOIS 3YO MAIDEN PLATE - 1050 metres (Cont'd)

On jumping away HANK'S NEPHEW (S. Price) shifted out across the running of THE HEADLINER (M. Neilson).

Near the 900 metres SATURDAY'S CHILD (B. Claridge) was obliged to steady away from the heels of STONEHAVEN (J. Bowditch) which shifted in. J. Bowditch was advised in future to give riders to his inside the room to which they are entitled.

In the vicinity of the 900 metres BRAVE JOURNEY (J. Maund) raced greenly and shifted in abruptly, contacting SECRETMENSBUSINESS (T. Pannell), taking that filly in onto HANK'S NEPHEW (S. Price), which was inconvenienced. BRAVE JOURNEY and SECRETMENSBUSINESS continued to race greenly for some distance thereafter.

From the entrance to the straight until approaching the 200 metres STARFIRE LADY (P. Gatt) was unable to obtain clear ground.

FORCE OF THREE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: CAROMA / SABOIS MAIDEN PLATE - 1200 metres

On jumping away RAGING SWELL (J. Bowditch) was inconvenienced when tightened for room by WORDS OF WAR (C. Lindop), which shifted in, and TWENTY FIVE CARAT (D. Tootell), which rolled out.

Approaching the 1100 metres KARABAY (L. Hopwood) was obliged to ease when inconvenienced by FINE FETTLE (D. Tourneur), which rolled out.

In the vicinity of the 900 metres COTTON ROAD (C. Lever) raced keenly when being restrained.

In the straight RAGING SWELL (J. Bowditch) was inclined to lay in under pressure.

Approaching the 200 metres FINE FETTLE (D. Tourneur) was inconvenienced by GONE WITHOUT (T. Pannell), which rolled in.

RACE 4 : ADELAIDE GALVANISING / SABOIS + RATING 0-68 HANDICAP - 2200 metres

On jumping away ELEGIDO (L. Stojakovic) was inconvenienced when tightened for room between SIR PRESIDENTE (NZ) (J. Toeroek), which shifted in, and WOTZITWORTH (P. Keane), which shifted out.

GOLDEN SCHNAPS (C. Lindop) raced three wide without cover throughout the event.

Near the 300 metres, when attempting to improve outside the heels of BELL RINGER (Jordan Frew), STURGIS (NZ) (J. Kah) was obliged to alter course away from the heels of BELL RINGER, which shifted out. Jordan Frew was severely reprimanded and advised in future to shift ground only when entitled to do so. J. Kah was cautioned that in similar circumstances in future, she would be required to react to horses shifting ground sooner.

SIR PRESIDENTE (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding had sustained an injury to the inside of its off fore heel. First aid was administered.

RACE 4: ADELAIDE GALVANISING / SABOIS + RATING 0-68 HANDICAP - 2200 metres (Cont'd)

L. Stojakovic, the rider of ELEGIDO, explained that she had intended to ride the mare, in the early stages, in a similar manner to its previous start when successful however, after being tightened out of the gates, ELEGIDO had raced keenly and as a consequence she was unable to restrain to obtain cover.

RACE 5 : TATTSBET RATING 0-68 HANDICAP - 1600 metres

No report.

RACE 6: ANGAS SECURITIES GOLD STANDARD RATING 0-62 HANDICAP - 1400 metres

DRIFTING SPIRIT (M. Tyndall) reared as the gates opened.

Inside the 900 metres, for some distance, QUICK THOUGHTS (J. Bowditch) was forced to race in restricted room inside the heels of BESA BOLA (D. Tourneur). D. Tourneur was reprimanded and advised in similar circumstances in future, he would be expected to either relieve the pressure or clear the horse to his inside.

In the straight MISS ARTICULATE (J. Kah) was inclined to lay in under pressure.

RACE 7: COOPER'S 150 YEAR SPRINT - 1050 metres

The start of this race was delayed owing to HAPPY ANGEL being presented without the approved gear. Mr. S. Kavanagh, the Trainer of HAPPY ANGEL, was questioned regarding the reason he had presented the mare without its approved gear. After considering Mr. Kavanagh's explanation, he was fined \$200 under ARR.140B(3) for failing to gain Stewards' permission to change gear prior to acceptance time.

L. Stojakovic, the rider of JUST SYBIL, was questioned regarding her use of the whip in the straight. L. Stojakovic pleaded guilty to a charge under ARR.137A(3) in that her use of the whip in the straight was excessive and was fined \$400.

P.Gatt, the rider of HAPPY ANGEL, explained that although the mare usually exhibited a shortened action, in his opinion its action was worse than normal. He stated that the mare had never travelled and was disappointing. The only explanation he could offer was that the ground may be firmer than HAPPY ANGEL might appreciate. HAPPY ANGEL was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both hind legs. Mr. S. Kavanagh, the Trainer of HAPPY ANGEL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

HILLFIRE was examined by the Club's Veterinary Surgeon who reported the gelding exhibited symptoms of tying up.

LILGIGGLEO suffered a laceration to the mid cannon on the off hind leg during the event.

RACE 8: THE ADVERTISER NEWSPAPER BALAKLAVA CUP - 1600 metres

BERTUCCI (P. Gatt) jumped away awkwardly.

RACE 8: THE ADVERTISER NEWSPAPER BALAKLAVA CUP - 1600 metres (Cont'd)

Near the 900 metres COMIC COMPOSER (NZ) (C. Lindop) was obliged to steady off the heels of HANDSOME AS (J. Maund), which shifted in. In being steadied, COMIC COMPOSER (NZ) got its head up for some distance.

Inside the 900 metres COMPIC COMPOSER (NZ) (C. Lindop) became awkward for several strides when attempting to restrain off the heels of LIGHT TAN (A. Patterson), which shifted in.

M. Neilson, the rider of PRINCE OF CAPERS, explained that the gelding had travelled well until entering the straight however, when asked to extend, had not let down in its usual manner. He stated that the only excuse he could provide was that the ground may have been firmer than the gelding appreciated.

RACE 9: JACOBS CREEK RATING 0-62 HANDICAP - 1200 metres

HOTDEAL was examined by the Club's Veterinary Surgeon and ruled fit to start.

Shortly after the start LORD ASHFORD (J. Kah) was inconvenienced when tightened between WINE LOVER (P. Gatt), which shifted out, and HOTDEAL (P. Keane), which shifted in.

Near the 200 metres, when taken out by HERE DE SPEAKER (M. Pegus), FIVE IRON (T. Pannell) was inconvenienced when tightened onto the hindquarters of GREY MUSTANG (M. Schrapel).

KINGS AND JACKS lost its near fore plate during the event and as a consequence suffered minor lacerations during the race.
