**RACE 1 : JETWAVE EP RATING 0-68 HANDICAP - 1350 metres**

ENCOSTA DELIGHT (J. Potter) jumped away awkwardly and shifted in, inconveniencing DISCOUNTED (J. Kah).

EL TORO (A. Patterson) jumped away awkwardly.

In the early and middle stages EL TORO (A. Patterson) was inclined to race ungenerously.

From inside the 400 metres until in the vicinity of the 200 metres MASTER PICKLES (B. Claridge) had difficulty obtaining clear ground when racing inside EL TORO (A. Patterson) and outside of ENCOSTA DELIGHT (J. Potter).

From the 200 metres VISA BOY (E. Boyd) was eased out of the event. VISA BOY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. T. Trenowden, the Trainer of VISA BOY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

GRACEFUL EDGE was examined by the Club's Veterinary Surgeon who reported an irregular heart beat. Mr. P. Holtham, the Trainer of GRACEFUL EDGE, was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial and the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon together with a Veterinary Certificate of Fitness prior to presenting for a future trial.

**RACE 2 : CARLTON DRAUGHT / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1000 metres**

MR KARGER (T. Baker) jumped away awkwardly and shifted out, brushing DESTINY VENGEANCE (B. Claridge).

REDLEAF ROSE (K. Bishop) was slow to begin.

CORONA GIRL (P. Roff) was inclined to race ungenerously in the early and middle stages.

Racing to the 300 metres CORONA GIRL (P. Roff), which continued to race ungenerously, had to momentarily steady off the heels of WRITE NO MORE (S. Price).

**RACE 2 : CARLTON DRAUGHT / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1000 metres**  
**(Cont'd)**

Racing to the 100 metres JUST PURE FUN (J. Kah) was inclined to hang in under pressure resulting in that filly shifting in abruptly and having to be steadied away from the heels of SHE'S SO SHADY (A. Patterson).

Mr. S. Drewitt, the Trainer of MR KARGER, and Mr. C. Baker, the Trainer of WRITE NO MORE, were advised a warning has been placed on their horses owing to their pre-race barrier manners.

**RACE 3 : SHAYNE KING MEMORIAL / COLTS, GELDINGS & ENTIRES RATING 0-61**  
**HANDICAP - 1000 metres**

LORD OF THE CASTLE (S. Westover) jumped away awkwardly and shifted out, inconveniencing LYNSHEE (L. Hopwood), which as a result shifted out, bumping OUR DESTINATION (B. Claridge).

L. Hopwood, the rider of LYNSHEE, pleaded guilty to a charge under ARR.137A(3) for striking her mount on one occasion on the hindquarters before mounting in the mounting yard. L. Hopwood was fined \$200.

Mr. D. Courtney, the Trainer of LYNSHEE, was advised a warning has been placed on the gelding in relation to its pre-race manners.

SON OF A GUN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : YALUMBA / SABOIS MAIDEN PLATE - 1000 metres**

SING THAT SONG (S. Cahill) jumped away awkwardly and shifted out, brushing TELLURIUM (A. Patterson), which as a result shifted out, bumping KALINGA LOCK (B. Claridge).

Shortly after the start DANZEROUND THE SUN (K. Bishop) and TRUTHS (T. Baker) brushed, resulting in TRUTHS attempting to buck. As a result T. Baker lost the use of his irons until racing to the 600 metres. Mr. J Hyam, the Trainer of TRUTHS was advised a warning has been placed on the mare in relation to its racing manners.

In the vicinity of the 900 metres SING THAT SONG (S. Cahill) had to momentarily steady when KALINGA LOCK (B. Claridge) shifted in. B. Claridge was reprimanded under ARR.137(a) for careless riding.

NATURAL HERO (E. Brooks) was inclined to lay in under pressure in the straight.

**RACE 5 : PURELL / SABOIS F&M RATING 0-68 HANDICAP - 1000 metres**

The start of this race was delayed owing to NOTFORGIVEN, which lost its off side fore plate during its preliminary, requiring Farrier attention.

Racing to the 200 metres ROLL OF THE DICE (J. Kah) had to steady and lose its position when BELLELON (E. Brooks) shifted in. E. Brooks was severely reprimanded under ARR.137(a) for careless riding.

KOODA WONDER (K. Bishop) was inclined to lay in under pressure in the straight.

**RACE 5 : PURELL / SABOIS F&M RATING 0-68 HANDICAP - 1000 metres (Cont'd)**

ROLL OF THE DICE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. J. Stephens, the Trainer of ROLL OF THE DICE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

BELLEVELO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. S. Drewitt, the Trainer of JAIPUR GEM, was fined \$50 under ARR.140B(3) as the mare was presented in incorrect gear.

Mr. J. Stephens, the Trainer of ROLL OF THE DICE, was fined \$50 under ARR.140B(3) as the mare was presented in incorrect gear.

**RACE 6 : EP ASBESTOS RATING 60+ HANDICAP - 1000 metres**

REGANSBURG (D. Tourneur) was slow to begin.

Racing to the 700 metres the saddle on PASS THE ACE shifted and as a consequence Jockey P. Roff had difficulty managing the mare for some distance, which laid in noticeably, resulting in MUMSLAD (L. Hopwood) having to steady and lose its position. Shortly thereafter PASS THE ACE continued to lay in, resulting in PIONEER PRINCE (S. Westover) having to steady and lose its position.

ETHBAAL, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to have a shortened stride in both forelegs. Mr. B. Dunn, the Trainer of ETHBAAL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

PASS THE ACE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : BALDWIN'S PLUMBING & GAS RATING 0-59 HANDICAP - 1250 metres**

PRIMAL INSTINCT, which was fractious and became cast in its barrier stall, was examined by the Club's Veterinary Surgeon and ruled fit to race. Mrs. A. Forster, the Trainer of PRIMAL INSTINCT, was advised a warning has been placed on this gelding in relation to its pre-race barrier manners.

MILITARY DAN (E. Boyd) jumped away awkwardly and shifted out at the same time as SAUCY WAVE (L. Hopwood) jumped away awkwardly and shifted in, and as a result NIC'S BUDDY (B. Claridge) and DAY DIVA (E. Brooks) were inconvenienced.

TARONGA (S. Cahill) jumped away awkwardly and shifted out, brushing DAZED (T. Baker).

From inside the 200 metres until the vicinity of the 100 metres DAY DIVA (E. Brooks) had difficulty obtaining clear ground when racing inside SAUCY WAVE (L. Hopwood) and outside of PRIMAL INSTINCT (P. Roff).
