Report on Race Meeting held at Gawler Racecourse

RACE 1 : THE CAVE IN 2013 MAIDEN PLATE - 1700 metres

LEMERIO, which contacted the fencing in the raceway en route to the barriers, was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to race.

LEMERIO (L. Stojakovic) was slow to begin.

BAKLAVA BOY (NZ) (C. Lindop) raced keenly for a short distance inside the 1400 metres.

DANCES WITH SPURS (D. Tourneur) was held up for clear running at the entrance to the straight when racing behind SMOKE BURNER (T. Baker) until in the vicinity of the 300 metres where it was obliged to alter course to the outside of SMOKE BURNER to obtain clear running.

SET TO EXCITE (M. Neilson) was held up for clear running at the entrance to the straight between the heels of KOODA CHANCE (A. Patterson) and HIOCTDANE (P. Gatt) until inside the 200 metres where it was obliged to alter course to the outside of HIOCTDANE to obtain clear running.

LEMERIO, which performed poorly, was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near hind leg. Mr. B. Bogarts, the Trainer of LEMERIO, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : THE LONG LUNCH IN 2013 / SABOIS DISTANCE MAIDEN PLATE - 2100 metres

WHY YOU LITTLE was examined by the Club's Veterinary Surgeon on arrival on course and found to have a swollen near fore tendon. Acting on this advice, Stewards withdrew WHY YOU LITTLE at 12.22 pm.

DEE JAYS DASH (A. Patterson) and BLENHEIM BELLE (B. Claridge) raced in restricted room shortly after the start between SLASH (S. Price) and PODIUM FINISH (J. Maund) and were unable to maintain their positions.

RACE 2 : THE LONG LUNCH IN 2013 / SABOIS DISTANCE MAIDEN PLATE -
2100 metres (Cont'd)

MEADOWS BOO and PODIUM FINISH were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : JACOBS CREEK RATING 0-68 HANDICAP - 2100 metres

DOC HENNESSY (T. Pannell) began awkwardly.

WELL SPENT (NZ) (C. Lindop) jumped the crossing near the 1800 metres.

T. Pannell, the rider of DOC HENNESSY, explained that his instructions were to allow the gelding to settle where it was comfortable and whilst he had intentions of racing in a more forward position, he was unable to do so as a result of the horse not beginning on terms and the early pace which he considered to be well above average. He stated that as a consequence, the horse was left flat footed in the early part of the race.

T. Pannell, the rider of DOC HENNESSY, was questioned regarding his use of the whip prior to the 100 metres. T. Pannell pleaded guilty to a charge under ARR.137A5(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres, and was reprimanded.

RACE 4 : WWW.GAWLERJOCKEYCLUB.COM.AU / SABOIS MAIDEN PLATE -
1100 metres

RUBY BE THERE (J. Maund) and ROLLING STONES (J. Kah) both shifted ground at the start, came together and made contact.

Shortly after the entrance to the straight PRESTIGE GLEN (Jordan Frew) improved onto the heels of ROLLING STONES (J. Kah) and when shifting in to obtain clear running, shifted in abruptly of its own accord and inconvenienced RUBY BE THERE (J. Maund).

MAKE THE TIME, which raced greenly and laid out on the home turn and raced very wide into the straight, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Jordan Frew accidentally dropped his whip over the concluding stages and was reprimanded under ARR.137(a) for carelessness.

RACE 5 : COOPERS MARES 0-68 HANDICAP - 1100 metres

SUKI (J. Holder) reared and was slow to begin.

Approaching the 800 metres MAGIC TIGRESS (J. Kah) and SILKEN THREAD (J. Maund) commenced to over race. Shortly thereafter SILKEN THREAD, when awkward on the heels of OUR LARA (B. Claridge), shifted in and contacted with MAGIC TIGRESS which maintained its position resulting in these two horses brushing for a short distance before MAGIC TIGRESS shifted out slightly, resulting in SILKEN THREAD losing his position when tightened onto OUR LARA.

OUR BELVOIR, which was kicked by another runner in the race way on return to scale, was examined by the Club's Veterinary Surgeon who reported a small haematoma on the chest. First aid was administered.

RACE 6 : WAYMAG HANDICAP - 1200 metres

Correct weight was delayed to allow Stewards to view the vision in the straight.

Approaching the 100 metres TESTATE (J. Potter), which had improved into a run between JUSTIFY THAT (D. Stra), which initially maintained its line, and ST FRASER (K. Bishop) which was inclined to lay in, became disappointed for clear running as ST FRASER rolled in marginally and JUSTIFY THAT rolled out slightly resulting in TESTATE (J. Potter) having to alter course to the inside of JUSTIFY THAT to obtain clear running.

RACE 7 : PD EXCAVATIONS GAWLER CUP - 1500 metres

BELECONI (L. Hopwood) knuckled severely at the start, unbalancing its rider.

In the vicinity of the 1000 metres SLIM HENRY (S. Westover) shifted out and tightened ABOUT ME (J. Kah) onto OUR FREED MAN (J. Maund) which maintained a tight line to the outside of ABOUT ME resulting in ABOUT ME being inconvenienced for a short distance. S. Westover was reprimanded and advised in future to take greater care when shifting ground.

Approaching the 100 metres MAGIC ME (NZ) (J. Holder) was obliged to shift to the inside of ANYWAYS (J. Potter) to obtain clear running.

RACE 8 : COOPERS FOUR-YEARS-OLD & OVER RATING 0-62 HANDICAP - 1200 meters

DRIFTING SPIRIT (J. Maund) was slow to begin.

BULLYDOZER (L. Hopwood) and DANISH SPY (J. Matthews) contacted shortly after the start when both horses shifted ground.

HEZAFRAAR (C. Lindop) and KISSED AGAIN (J. Toeroek) contacted at the start when both began awkwardly.

Shortly after the entrance to the straight CAPE CLEAR (J. Potter) improved into a run between JUST TESS (B. Claridge) to its outside and HEZAFRAAR (C. Lindop) to its inside and as a result J. Potter was accidentally struck by the whip of C. Lindop. Shortly thereafter HEZAFRAAR shifted in abruptly away from CAPE CLEAR as it commenced to weaken.

GENERAL

RACE 1 : THE CAVE IN 2013 MAIDEN PLATE - 1700 metres

Mr. B. Bogarts, the Trainer of LEMERIO, reported that on return to stable the filly exhibited soreness in its near side shoulder and was still lame in the near hind leg. He advised the filly would now be spelled.
