Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 29 September 2012

RACE 1: SCHWEPPES HANDICAP - 2250 metres

SIR TRENTIN required the attention of the Farrier to have its near fore shoe replaced in the parade ring. SIR TRENTIN was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to race.

MAGUS (NZ) (M. Neilson) laid out severely from inside the 600 metres resulting in M. Neilson being unable to ride his mount out fully for the remainder of the event.

M. Neilson, the rider of MAGUS (NZ), reported his mount hung out during the event placing him at a disadvantage. MAGUS (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of MAGUS (NZ), was questioned regarding his use of the whip prior to the 100 metres. M. Neilson pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

MY BENTLEY (NZ), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BELL RINGER lost its off fore plate during the running of this event.

RACE 2: ICE BREAK HANDICAP - 1250 metres

ASSERTIVE EAGLE (M. Neilson), SILVER FALLS (C. Lindop) and CALIFORNIA MOON (USA) (D. Moor) over raced in the early stages of the event.

CALIFORNIA MOON (USA) (D. Moor) had difficulty obtaining clear running at various stages in the straight.

ASSERTIVE EAGLE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr. T. McEvoy, the Trainer of ASSERTIVE EAGLE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 3: SLOANS SANDS HANDICAP - 1000 metres

CAPTAIN SHARP (NZ) (P. Gatt) was slow to begin.

Shortly after the start SAREEB (A. Herrmann) was inconvenienced when awkwardly placed to the outside of the heels of BUSH AVIATOR (J. Winks), which rolled out slightly, after being taken in briefly by TIGARA'S GEM (B. Claridge).

BUSH AVIATOR (J. Winks) laid in, in the straight. BUSH AVIATOR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: PAULS MILK HANDICAP - 1400 metres

TUREEN (B. Claridge) jumped away awkwardly and was slow to begin.

ANDRONICA (J. Matthews) was slow to begin.

SHIMANO MISS (NZ) (K. Bishop) over raced in the early and middle stages of the event.

RACE 5: ADELAIDE GALVANISING HANDICAP - 1550 metres

The start of this race was delayed approximately two minutes owing to LONCAY proving difficult to load.

MEADOWS MIST (L. Hopwood) was held up for clear running from the vicinity of the 400 metres until inside the 200 metres.

In the vicinity of the 700 metres CAITLIN'S SPIRIT (NZ) (D. Moor) rolled in inconveniencing BELLCHUCA (J. Potter) which brushed the running rail.

In the vicinity of the 1100 metres BELLCHUCA (J. Potter) shifted in tightening CAITLIN'S SPIRIT (NZ) (D. Moor) for a number of strides resulting in CAITLIN'S SPIRIT having to be steadied to avoid the heels of BELLCHUCA. J. Potter was found guilty of a charge of Careless Riding under ARR.137(a) in that he permitted his mount to shift in when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 3 October 2012 and to conclude at midnight on Saturday, 13 October 2012; a period of four (4) meetings. J. Potter was advised of his right of Appeal.

RACE 6: ADELAIDE CASINO HANDICAP - 1400 metres

LE ROI (GER) (M. Neilson) was slow to begin.

P. Gatt, the rider of ANDAMOOKA GEM, was questioned regarding his use of the whip prior to the 100 metres. P. Gatt pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

GENEROUS BEAU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: CFMEU HANDICAP - 1000 metres

The start of this event was initially delayed approximately two minutes owing to an interstate delay (Belmont Race 4).

RACE 7: CFMEU HANDICAP - 1000 metres (Cont'd)

The start of this race was further delayed approximately one minute owing to TILOS kicking out after being loaded in its barrier stall and having to be examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg and declared the gelding unfit to race. Acting on this advice Stewards withdrew TILOS at 4.23 pm. Mr. D. Jolly, the Trainer of TILOS, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Correct weight for this race was delayed to allow the Connections of LONE STAR to view the official photo finish for first and also to allow Mr. J. Macmillan, the Trainer of ZAKUMI and that gelding's rider, J. Kah, to view the vision in the straight.

NOBLE SUCCESS (J. Potter) was slow to begin losing three to four lengths at the start.

LONE STAR (D. Moor) jumped away awkwardly, shifted in and hampered ULI URS UTZ (J. Holder) which was then slow into stride.

Approaching the 700 metres GRAND TAJ (S. Price) shifted in and inconvenienced STRIDING SUCCESS (Jordan Frew) which had to be momentarily steadied. S. Price was reprimanded for shifting ground when insufficiently clear.

RACE 8 : DOMINANT HANDICAP - 1400 metres

WARATOR (Jordan Frew) jumped away awkwardly, shifted in and contacted CIRCLE OF TRUST (M. Neilson).

FULL BORE (J. Kah) jumped away awkwardly.

FULL BORE (J. Kah) became held up for clear running shortly after the entrance to the straight when inside JEUNEALISTIC (S. Westover) and on the heels of WARATOR (Jordan Frew) and was obliged to alter course to the outside of the field in the vicinity of the 200 metres to obtain clear running.

P. Gatt, the rider of GREY MUSTANG, was questioned in relation to his use of the whip and reprimanded for using his whip in a manner which raised his arm above shoulder height over the concluding stages.
