RACE 1 : WISE FORD & FARM EQUIPMENT DISTANCE MAIDEN PLATE - 1900 metres

The start of this race was delayed four minutes when CHOUXSHINE (NZ), which was fractious in the barriers, was examined by the Club's Veterinary Surgeon. Acting on veterinary advice CHOUXSHINE (NZ) was withdrawn by Stewards at 1.22 pm. Mr. S. Morrish, the Trainer of CHOUXSHINE (NZ), was advised the gelding would be required to perform to the Stewards' satisfaction in the barriers in an Official Barrier Trial prior to accepting for a future race.

SUPA COOL DUDE (H. McKechnie) jumped away awkwardly.

BLENHEIM BELLE (B. Claridge) was inclined to race ungenerously in the early and middle stages.

Racing to the 600 metres PORTFOLIO (D. Tourneur) was tightened and had to steady when taken in by INSATIABLE (C. Lindop), which shifted in and away from BLENHEIM BELLE (B. Claridge), which was inclined to lay in.

Racing to the 500 metres BLENHEIM BELLE (B. Claridge) rolled in, brushing INSATIABLE (C. Lindop).

PORTFOLIO (D. Tourneur) and BLENHEIM BELLE (B. Claridge) were inclined to lay in under pressure in the straight.

B. Claridge, the rider of BLENHEIM BELLE, accidentally dropped his whip at the 50 metre mark. B. Claridge was fined \$50 under ARR.137(a) for carelessness.

PORTFOLIO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BLENHEIM BELLE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. R. Daniel, the Trainer of BLENHEIM BELLE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : XXXX GOLD / SABOIS MAIDEN PLATE - 1100 metres

LADY SONRO (J. Maund) and OH SO APPEALING (T. Baker) were slow to begin.

ALISON JEAN (D. Tourneur) and SNEGUROCHKA (P. Marks) brushed on jumping and as a result SNEGUROCHKA was slow into stride.

Racing to the 900 metres ALISON JEAN (D. Tourneur) was inclined to race greenly resulting in ROLLING STONES (J. Kah) being momentarily inconvenienced.

RACE 3 : BORDERTOWN HARDWARE / SABOIS MAIDEN PLATE - 1300 metres

RANDOM VALUE (J. Holder) was slow to begin.

MAKE THE TIME (J. Maund) jumped away awkwardly and shifted out and MISS PARNASSUS (J. Bowditch) jumped away awkwardly and shifted in, inconveniencing MUSEE D'MODEL (D. Tourneur) and OCEAN WARRIOR (A. Herrmann).

GOLDEN MONARCH (C. Lindop) was inclined to race ungenerously throughout.

GOLDEN MONARCH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : WOOLSHED INN RATING 60 & OVER HANDICAP - 1200 meters

The start of this race was delayed approximately four minutes when SHAKETHEGROUND proved difficult to load. Ms. L. Faust, the Trainer of SHAKETHEGROUND, was advised that the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

SHAKETHEGROUND (T. Zanker) jumped away awkwardly.

DJATALA (H. McKechnie) jumped away awkwardly, shifted in and brushed FINNISS STORM (J. Kah).

FINNISS STORM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : S C IRLAM SHEARING CONTRACTORS RATING 0-65 HANDICAP - 1900 metres

GOD HELP US (H. McKechnie) jumped away awkwardly and shifted out bumping NO DOUBTFIRE (D. Tourneur).

ALWAYS IN DA'NILE (T. Zanker) was inclined to race ungenerously in the early and middle stages of the event.

D. Larsson, the rider of NIPPY PHILLY, was questioned regarding his use of the whip prior to the 100 metres. D. Larsson pleaded guilty to charges under ARR.137A(5)(a)(i) & (ii) in that he used his whip in a forehand manner on more than five occasions and in a consecutive manner prior to the 100 metres and was fined \$200.

CREATIVEPERCEPTION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : BARRETT DISTRIBUTORS RATING 0-59 HANDICAP - 1100 metres

SPRAY TAN (D. Tootell) was slow to begin.

HIGHLY EXPLOSIVE (J. Maund), REGAL MONTY (B. Claridge) and FLIRTY MARTINI (C. Puls) made the turn at the 900 metres awkwardly.

Racing to the 200 metres SPRAY TAN (D. Tootell) shifted out to improve and momentarily inconvenienced TORTURED (C. Lindop).

REGAL MONTY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : TATIARA TRUCK & TRAILERS RATING 0-61 HANDICAP - 1300 metres

The start of this race was delayed approximately four minutes when TWO TIMING (NZ) needed a tongue tie to be refitted.

BERNIE'S BOY (H. McKechnie) and STAR ACT (D. Tootell) brushed on jumping away.

ENCOSTA DELIGHT (T. O'Donnell) was inclined to race keenly in the early and middle stages of the event.

From the 800 metres to entering the home straight MAGIC TIGRESS (J. Kah) hang out severely. MAGIC TIGRESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. MacMillan, the Trainer of MAGIC TIGRESS, was advised that the mare would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

From the 300 metres STAR ACT (D. Tootell) shifted out to improve to the outside of SEULAMONT (D. Tourneur), resulting in STAR ACT contacting WAIT FORETTE (J. Frew), which was rolling in under pressure and as a result STAR ACT had to shift back to the inside of SEULAMONT to gain clear running.

ENCOSTA DELIGHT was examined by the Club's Veterinary Surgeon who reported a minor laceration to the offside knee.
